We are going to try out a new system this week <sup>we</sup> will give it several weeks trial. We procured some gummed paper and proceeded to run the member's names and addresses off on it. Since the last Bulletins were run off last week, CFCT has promised to give us a broadcast on the morning of December 17, from 3:00 to 4:00 A.M., E.S.T. CHAB advises us that they have been ordered off of the air by the Canadian Radio Commission, however, they say that they feel that it may only be a temporary condition and that if they are back on the air in time, they too will give us a program on Sunday morning, Dec. 17 from 3:00 to 4:00 A.M., E.S.T. therefore we would suggest that you watch closely for this station.

We have some very interesting information from good ol' Ray Lewis, which we feel will be of interest to you. He advises that a new station, CX28, Montevideo, Uruguay is operating on 1095 kycs and he says that they have been heard quite often in the evenings from 8 to 11 PM., EST. He also says that LR2 are giving WOAI considerable interference and asks the members to be on the watch for them. Also that LS4 are being heard behind WMAQ. Also that London Regional is being heard quite frequently in the Eastern part of the United States from 6 to 7 PM., EST. Also Rabat Morocco on 721 behind WGN. So, you see fellows, it is not even necessary to remain up into the wee small hours of the mornings to pick up some real catches. A letter from Mr. Henry P. Allen, Vice-President of the ARC advises us that LR4 has been heard quite often in Philly. Also that Cardiff, Wales was heard by him at 7 PM the other evening. Quoting from the second paragraph, he says "I really did not think these stations would come in so well until Fred Owens started to pick up London, Cardiff and Anthone around 6:30 p.m. Now he has us all at the dials around that time every night! In their tipsheets, we note that they advise their members that Poste Parisien comes on the air around 2:15 A.M., E.S.T. so, we would advise that you tune for them around that time. With the nights lengthening we should soon be able to hear quite a few of the Europeans when they come on the air in the mornings. We certainly wish our members lots of luck in hearing these stations.

Incidentally we note that we forgot to mention that Mr. Barlow will serve our club on the Courtesy Programs Committee. We certainly wish you lots of luck Mr. Barlow. Did any of our members hear CP4? There was a station operating on 915 kycs that morning that we here in headquarters thought might have been them but we are not at all certain. We understand that at the last minute they changed the time of this broadcast to 12:30 to 1:30 instead of the original time but they failed to register here in club headquarters at either of these times.

Art Collins sends us a card which he received from CMJK, Camaguey, Cuba in which Senor Tano Gomez informs us that they will broadcast a DX program for the members of our club on Sunday morning, December 17 from 4:00 to 5:00 A.M., E.S.T. WSOC Charlotte, N. C. granted license covering move of station from Gastonia to Charlotte, N. C. and making changes in equipment. WOR Newark, N. J. granted modification of license extending commencement date to Jan. 16/34 and completion date to June. 16/34. WSB Atlanta, Ga. granted license for authority to use former main transmitter at its present location as an auxiliary.
