DX NEWS

OCTOBER 3, 1934.

Well here it is high time that we were getting started on this Bulletin. We have a lot of news which we hope will be of interest to all of our members this week.

First of all we wish to advise all of you that have been listening to the WORK DX Club broadcasts on Friday afternoons at 2:45 P.M. E.S.T. that this week's broadcast will take place Friday morning at 9:45 A.M. instead, owing to the fact that the York Broadcasting Co. have made arrangements to broadcast from the York County Fair each afternoon this week. However we expect to be back on the regular 2:45 P.M. schedule next week. We certainly would appreciate more response from the members of our club on this broadcast, for we have found it to be a very excellent outlet for our last minute tips and we want you to show the station your appreciation of this fine courtesy they have shown us by sending in your reports.

At this time we wish to welcome John E. A. Sanderson, 8 Grove St., Musselburgh, Dunedin, New Zealand as a new member in our club. We certainly do hope that you will enjoy your membership in our club and incidentally to you goes the honor of being our first New Zealand member.

C. G. Huber, Chairman of our Programs Committee, advises that E. H. Bullard, Chairman of CDXR's Program Committee, has received the following letter from NNRC Chairman Hahn in reply to Mr. Bullard's letter to Mr. Hahn inviting NNRC to join the IDA-CDXR-NRC plan of co-operation to prevent clashing of DX programs:

We wish at this time to acknowledge a slight misunderstanding with station WJBC Bloomington, Ill. We stated in last week's Bulletin that their test program on October 6th was to be dedicated to the members of our club; this morning we learned that this program has been promised to I.D.A. for several months, however their November test will be de-

icated to the members of our club instead. We regret this slight mix-up and trust that this will straighten everything out satisfactorily.

John J. Barlow sends us a summary of his successful CPC work thus far. He says that he has been fortunate enough to line up KMAC for two programs. The first of which will take place Sunday morning, October 21. John only asked for the hour from 3:00 to 4:00 A.M., E.S.T. but Mr. R. R. Hayes, the chief operator who will be at the "mike" said that if we did not have any other programs scheduled for those mornings on their frequency that he would be on as follows with all the time dedicated to the members of our club; from 3:00 to 8:00 A.M., EST. John tells us that inasmuch as he did not have any other program arranged for that morning or for Saturday morning, December 22 which happens to be the date of these broadcasts he is confident that KMAC San Antonio, Tex. will be on for the full length of time they have mentioned. Incidentally the broadcast for Dec. 22 is from 1:30 to 5:00 A.M., E.S.T. This station operates on 1370 kycs. We would suggest you address your personal reports on this series of DXes direct to Mr. Hayes in care of the station. They want comparative reports as to tone, quality and volume. John also advises us that he has heard from WMBR Jacksonville, Florida in which they have informed him that they are running a DX program for ODXR on Nov. 25 and that they will dedicate one selection during this program to our club in appreciation for the publicity we give the program. They say if they get enough reports from NRC members that they will give us a DX program on a later date. Still more news from John, he tells us that he received a letter from WRAK, 1370 kycs. Williamsport, Penna. saying that they will be very glad to go on the air for the N.R.C. on Sunday morning, October 28 from 4:00 to 5:00 A.M., E.S.T. He says that they are working on a great program for our members and would greatly appreciate your response. Congratulations on all of this fine work, John.

We learn from WTOG, 1260 kycs that they plan to run another anniversary program this month. The broadcast is to start at 7 A.M. on the morning of October 15 and continue up until midnight, October 16. This means that the program will run all morning on October 16. Mr. Meakin, who has charge of their frequency will undoubtedly attempt to have them dedicate a portion of this broadcast to the members of our club. WTOG is located in Savannah, Ga.

From the United States Radio Club we learn that there is a possibility that the frequency checks may end this season as the FCC has ordered several trucks fully equipped with apparatus for monitoring in order to check frequencies during the regular broadcast hours. May we add that if this is the case you had all better work especially hard on the frequency checks to pull in those stations which are still needed in your logs, for it certainly does look as though the checks may be discontinued when the trucks mentioned above are delivered.
