Well here we are again on the threshold of another week and it is time for us to get to work on this week's Bulletin again. This past week has found DX reception very much improved and we hope that all of you found the same condition existing in your locality.

Friday morning, February 8 will find WGBI 880 kycs. on the air, between the hours of 2:00 and 5:00 A.M., E.S.T. They have promised to dedicate a portion of this broadcast to the members of our club, we therefore suggest that you be on hand to try for this program. They are as you know located in Scranton, Penna.

We are given to understand that KGIW 1420 kycs. Alamosa, Colorado are running a DX program every Wednesday, Thursday, Friday, Saturday and Sunday morning and that these broadcasts are being dedicated to the NRC, the CDXR and several other clubs each morning. These programs take place from 2:00 to 3:00 A.M., E.S.T.

On Saturday morning, February 9, the members of our club are to again be favored with another of the fine DX programs that have been put on for our club over station CMW, 930 kycs. Havana, Cuba, between the hours of 1:00 to 2:00 A.M., E.S.T. No doubt either our good friend Alec Kinghorn or our other good Cuban friend Vincent Clarke will be at the mike during this broadcast. While we are on the subject of these two fine gentlemen, we want to take this opportunity of thanking them for the mighty fine work that they have done for all of the DXers this year in the form of all the excellent Cuban specials that have been on the air and also for the large amount of work that they have on their hands in verifying all of the reports that come in on these DXes. The DX fans certainly do owe these two gentlemen a large debt for their fine co-operation and the National Radio Club takes this opportunity of expressing their gratitude to these gentlemen.

Sunday morning, February 10 has been set aside by the Canadian DX Relay for their Western-Canadian DX Party and from the fine list of stations that have already designated their intentions of taking part in this series of programs, we know that it will be worth your while to stay up nearly all night this coming Saturday night. Page four of this week's Bulletin carries the complete list of these Far-West and Middle-West Canadian Stations that will be broadcasting on February 10 for the CDXR. This series of programs really presents an excellent opportunity to hear several excellent Canadian catches which are rarely on the air.

We want to take this opportunity of thanking all of those stations that either ran special programs for our club or else dedicated their frequency checks to our club during the past week. We certainly appreciate this splendid co-operation from these stations.

We want to thank Floyd Smith, our Greenville, Ill. CPCor for having made arrangements with WAWZ 1350 kycs. Zarephath, N. J. to have them dedicate a program to the members of our club on Sunday morning, February 17 from 4:00 to 5:00 A.M., E.S.T. We urge you all to listen in and send this station your reports on their broadcast for the members of our club

This past Sunday morning, we had the privilege of hearing for the

first time the new 10 KW transmitter of station LYA 650 kycs. Auckland, New Zealand. We were agreeably surprised to hear how well this station comes through for this time of the season, within a few weeks by which time Australian reception begins to pick up, we feel that this station will be heard quite easily over these entire United States without much difficulty. They can be heard around 4:45 A.M., E.S.T. and we urge all of you that have not heard this station as yet to try for them every morning for the next month or so, that you have the chance to, for we feel that your efforts will be favorably rewarded. This will give many of the DX fans in this country that have not as yet been able to tune in any stations from down under to hear one, for we are really expecting great things from this station.

J. Warren Routzahn, Secretary of the NRC tells us that his verif from XETH 1210 kycs. Pueblo, Mexico contains the good news that this station will again present another DX program on Tuesday morning, February 19 from 2:00 to 3:00 A.M., E.S.T. and from the way his verif reads we are also enclined to believe that a portion of this broadcast will be dedicated to the members of our club. During their program for our club last month they seemed to be operating on a frequency of 1205 than 1210 kycs. Therefore do not give up if you do not hear them on 1210 kycs as listed in our Calendar, for they may be on one side or the other of it. Watch closely for them, for they really came in quite fine last week and we feel that they will do likewise this time.

We feel a bit disappointed over the interest that has been shown thus far in the contest which Bob Rawstron is conducting for the members of our club. This is a mighty fine contest and we feel that all of you ought to take part in it. Remember all you have to do to enter it is to send the report of the number of Thank You Cards that you have sent out to stations putting on DX programs for our club since December 15 and also the number of verifications that you have received on programs that have been dedicated to our club since the same date. Thank You Cards constitute one point and verifs received count three points. Send in your results to Keith L. Freas, 115 Webash Ave., Kenmore, N. Y. Let's show some interest in this contest, the prizes as you know are an antenna kit, a viso-glow lightning arrestor and two night lamps. We feel sure that any of you would be doing a wise thing to enter this contest for if it is shown that there is enough interest in the club for contests we feel reasonably sure that there will be more contests to follow, whereas if there isn't more interest shown there may possibly never be any more contests of this kind, so let's show everyone what we can do and all of the members take part in this contest.

John C. Kalmbach, Jr. one of our Buffalo, New York members sends us word that he has recently been advised by station WKAQ San Juan, P.R. that they will put on a special DX program on Sunday morning, February 24 from 2:00 to 5:00 A.M., E.S.T. Thanks for sending us this information.

From the Universal DX Club of Hackensack, N. J. we learn that WTEL, 1310 kycs. Philadelphia, Penna. will present a DX program on Tuesday morning, January 19 from 3:30 to 7:00 A.M., E.S.T. We know that this will be good news for many of our Western members that have never had an opportunity of hearing WTEL.

Joe Becker, Sr. our Vice-President sends us word that he has just received word from station KWG 1200 kycs. Stockton, Calif. that they will dedicate their March frequency check which takes place on Tuesday morning, March 5 from 4:00 to 4:20 A.M., E.S.T. to the members of our club. We want to thank Joe very much for having arranged for this dedication to the members of our club. Let's all report on it.

We are in receipt of a very fine letter from Lester Zellmer of station WTRC who did such an excellent job of dedicating a DX program to the members of our club about two weeks ago. He says that so far they have received more reports on their program for our club than on any other DX program this season. We are indeed very happy to know that you all responded so well to this fine program. Mr. Zellmer asks that we put the following note in our Bulletin this week and we are more than happy to do so: "So far this winter WTRC has been heard in 38 states of the Union, in all provinces of Canada, in Waihi, N. Z. (Nov) and Invercargill, N. Z. (Dec) and we would like to hear from listeners in the 10 remaining states: Arizona, Delaware, Idaho, Louisiana, Montana, New Mexico, South Carolina, Utah, Washington and Wyoming". If any of our members know any DXers in these states please write them and ask them to send in their reports on any future DX programs that WTRC may run this season.

Station KFRC San Francisco, Calif. have notified John J. Barlow that there was some sort of a slip-up in the DX program which was to have been presented for the members of our club a week ago and that instead of going on the air on Sunday morning, this program took the air on Monday morning instead. Y. testing the other morning but was unable to get much on them as she just happened to tune in on them as they were getting ready to sign off. We therefore suggest that you all watch 1310 kycs for future tests from this station.

Mrs. A. C. Johnson, our South Dakota member sends us word that there was an article appeared in one of their local newspapers to the effect that applications of WBBM and KFAB for double power met a disappointment at a hearing before the FCC when representatives from other stations on adjacent frequencies claimed that they would get too much interference from these stations if their power was increased as they had asked.
