- 955 BURM. XZK, Rangoon. Yes, you're right about WRH starting Burmese transmission at 0600. I apparently made a mistake in my report; my notes say first reception 0236 PST, best at 0618-0659 EST. I gave up at 0412 PST, 0712 EST. Too sleepy when converting to EST. Correct reception overall 0536 to 0712. Add 11½ hours to convert to Burmese time makes it 1706 to 1842 there. Playback of tapes, plus some erased for other recording, finds nothing usable. (Freeman, Calif.) I'll gladly check the language on tape, if sent. Re Schwartz' suggestion on checking SW parallel (6035), inexperienced SWL's should beware: dominant on 6035 is a Soviet station, listed as Tashkent, but thought to be Komsomolsk. May lead to confusion (especially if Tashkent, and in Asian language.) (Wood, Ind.)
- 965 NICARAGUA. YNLU, Radio Managua, Managua. Noted 11/19 1954 to 2016 when gave positive ID, "Radio Managua," advertises Mejoral, so you were right 10/6 issue. (Hathaway, Ill.)

(OSL's as Linz on verie cards), heard with unusually strong signals 11/24, at 2330 s/on, when most Austrians were up strong. (Dangerfield, Pa.)
- 1034 UNID TA(s). 11/24 at 0005, one domina to Some audio. 2nd a cyclic sort of het. Presume Portugal and Tallin. (Seaver, Calif.)

- 1125 COSTA RICA. TISR, R. Popular, San Jose. Found at good level, for fine log 2100 to 2130 11/28. Popular music, vocal and instrumental, in Spanish. Slogan and time check between each record. Only two commercials in entire period. (Callarman, Texas)
- 1133 INTL. WATERS(England). R. London with Top Pops, clear ID as "R. London 0205 11/16. Excellent strength. (Wood, Ind.) Noted with loud whistle between WRVA/WNEW as early as 1600 some nights, and audio noted around 1630. (Schmidt, Pa.) Strong and perfectly readable 11/17 0137-0200+ with hit music programme and time checks.

 Heard on HC-100 and only slight CRM from WNEW. (Calkin, N.B.)
- 1140 JAPAN. Possibly JOER heard 11/22 at 0308 and 0502. (Seaver, Calif.)
- 1187 HUNGARY, Szolnok, logged 2300 to 2320 11/16 for report. (Gustafson, Ill.)
- 1210 CHINA. IS as shown in 1965 WRTVH heard 11/23 at 1000; does ye Ed. "crystal ball" give any hint as to location? (Millar, Wash.) Setting the crystal ball atop my FBIS log, I find Peking and Shanghai, both local stations, listed here. (Ed.)

CHILEAN FREQUENCY AND CALL ALLOCATIONS

By Ronald F. Schatz

The seven international frequencies assigned by treaty for the exclusive use of Chile are 570, 660, 760, 1060, 1140, 1380 and 1500 kc/s. All stations operating on these frequencies are located in the capital - Santiago.

Chilean callsigns are unique. They consist of the prefixes CA, CB, CC or CD followed by the stations frequency in 10's of Kilocycles; e.g., CBll4 in Santiago, according to its call, operates on 1140 kc., and CD57 on 570 kc., etc.

Each callsign prefix is assigned to one of four regions of the country as follows:

CA Norte Northern border south to Coquimbo Province
CB Centro Aconcagua Province south to Santiago Province

CC Sur O'Higgins Province south to Concepcion & Nuble Provinces.

CD Antartida Arauco & Bio-Bio provinces south to Tierra del Fuego.

Using an example of the above information, station CB73, solely according to its callsign, is located in the "Centro" region of Chile and operates on 730 kc.
