





Your very complete report can only be matched in kind. It was good of you to send through such a complete verification. I hope that the information I now enclose will be of as much interest to you.

KWIL is a 250 watt local channel station, with an RCA-250-K transmitter, employing two 210 tubes in parallel, high-level modulated by two 828 tubes, operating class-B.

The antenna system consists of a Windcharger tower, 194-feet high (190-feet above insulator), series fed, with a ground system consisting of 120 radials of number 12 copper wire buried from 12 to 18 inches deep, radiating out for a distance of 350-feet. The antenna is fed by an overhead four-wire feeder system.

Thank you again for the report. Although not the finest to look at, I hope that the enclosed verification card will find a place in your collection.



We had to do some long PUT-OFF work on our RIG and we don't happen to have a Dummy antenna, so we just had to do the next best thing.

Our Rig consists of a 42 xtal osc. , 807 Bifr., into an 836 (class B ) driver., Driving a pair of <sup>211</sup>~~811~~-A's....These are Modulated by a pair of <sup>838</sup>~~811~~'s and thats about it. We only run 100 watts as you probably already know so naturally we appreciate all DX replys and verifications.

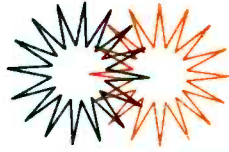

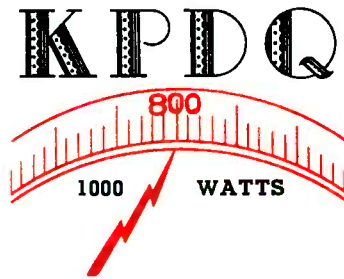

Thanks for your warm and comprehensive letter of the 5th informing us of our equipment check broadcast. You can't imagine what a relief it is to hear from you! However, I don't think you are exactly a stranger to me. It seems to me as though I heard from you sometime along at this same time of year a year ago when I was chief engineer for KD-HI in Twentynine Palms, California. If not; certainly another DXer in Walnutport for I distinctly remember the name with good reason. At that time I was also a Dj for KD-HI and had as part of my station break "People in (name of city) listen to KD-HI" On this occasion I spoke the name of Walnutport and darned if someone didn't call me up and said they were from Walnutport and wanted to know who had written me from there. Does any of this strike a responsive cord? It was either out of a DXer in Walnutport or in someplace in Texas that I got a write-up in the DXer mag, too.

Anyhoooo.. You certainly heard K-WAY; and I'm tickled that you did and also that you had it logged so accurately. It means a great deal to me as this is my first job as manager/chief engineer..I had just moved all my broadcast equipment (except the transmitter) into a fifty-five foot trailer and this was my very first broadcast from there (I was doubtful that it would work so well); It was the first time we had ever pulled an after hours check; it was the first time I was solely responsible for the quality and correctness of the test. You can see a lot of firsts and the reason why I am so glad to hear your report.

I just wish you had been listening from midnite to 1220 Am on 1240 Conelrad frequency for we also did that one the same night and I'm still in doubt as to the results of that. If you think about it; we go on 1240 with a Conelrad the first Monday (Sunday night at Midnite) of every even month. The next one will be August 5th. Sure hope you can listen and give a report.

I do thank you for your well wishes, too, Kermit. We need it. We are hopelessly understaffed here at K-WAY and I am doing so much of the work personally; and putting in such ungodly hours that I often wonder what's happening.

Technically, our equipment was something to be desired a month or so ago; but thanks to your report our indicators MIGHT be right after all. our transmitter is a Gates 1000 Watter, our tower 206 feet, good ground system...wet and marshy.

Thanx, again, Kermit, for your complete report. And I'm happy that you could add K-WAY to your list.

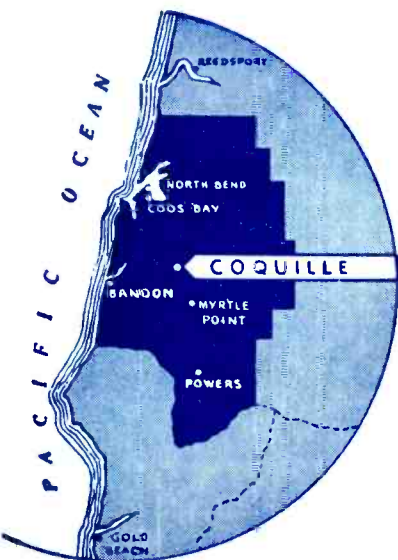



Please accept this letter as verification of your reception report which stated that you heard KUMA from 12:38am to 1:32a PST on November 6, 1955 in Walnutport, Penn.

KUMA went on the air for the first time on August 26, 1955, with 1000 watts on 1370 kc. We currently are a daytime station operating from 6:00 a. m. to local sunset. KUMA studios are at 1815 S. W. Emigrant Ave. in Pendleton, and the transmitter and tower operated by remote control, located two miles east of the city center. KUMA's call letters were chosen to represent the county of which Pendleton is the County Seat....UMAtilla! Umatilla is an indian name. Pendleton has a population of approximately 15,000 persons, with 47,000 in the county.

All equipment at KUMA is RCA, including a BTA-1M transmitter; BC-2B Console, Magnecord tape recorders, RCA turntables, RCA pick-up arms and heads. We are concentrating on a library of HI-FI music as much as possible.

At this writing, KUMA has an application before the FCC for 5000 watts, directional day and night on 1290 kc. We are, of course, eagerly awaiting a grant.

I received your letter some time ago, and am sorry of the delay in answering .... however Holidays teamed up with illness on the staff here has kept me pretty busy for the past few weeks.

I was certainly glad to hear from you, and this letter will verify that the station you picked up wasn't KRUL on a frequency check with the RCA test station at Point Reyes, California.

We here at KRUL run the test program the second Monday of each month at 1:30 PST and 2:30 PDT

5 x 3 for a two fifty watt three thousand miles away is fine, and of course I have to give credit to the equipment that you have there at home. Your antenna is of course beamed in our direction for maximum reception and selectivity. From your description of the ground I'd say that you have quite a set up there. We have been picked up on the Eastern Coastline quite a few times but this is the first report in many months from your section of the country, so we certainly like to know that at times, with luck we can hit in there.

The tone modulation however that were picked up during the reception were probably from a station closer to you .... for the full fifteen minutes from 1:30 to 1:45 we are constantly programming and blasting our modulators. Immediately after the station identification, we get off the air and break for home ....

Once again Thanks for your letter, and please let us hear from you again, if you succeed in hearing our signal.

The best of luck to you, and I'd like to wish you and Yours a Happy New Year.

Incidentally for the book, our Xmitter is a G.E. 250 Watt, and the console and associated equipment is all Gates, the Console being a 400 about two years old.

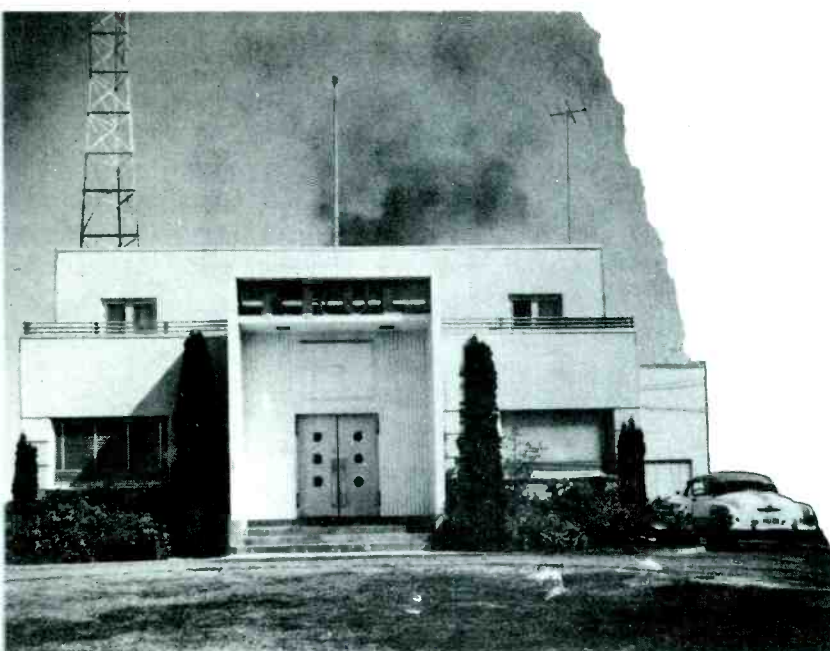



Thank you very much for the reception report of KSHA's ET-DX of Tuesday morning December 4, 1962. Your report coincides with our broadcast log for the time period of 12.05 to 12.53 am PST. We were broadcasting a 1000 cycle tone, and about 12.37 am, dropped it to 250 cycles and up to 2300 cycles.

KSHA began broadcasting April 7, 1962, and this was the first test coordinated with the National Radio Club. I hope in the future to have several more such tests. KSHA is a member of the Pacific Adult Radio network, a sales organization, and will soon become a member of the Mutual network. We operate daytime only with 1000 watts. Our remotely controlled Gates BCLT transmitter feeds one 285' tower which has 120, 300' radiators providing its grounding. We utilize Gates equipment throughout, but the bulk of our programming is provided by a Schafer 1200 series automation. KSHA features "quality" music on its regular schedule.
