NETWORKS

NATIONAL RADIO NETWORKING IN THE UNITED STATES

Greg Monti of National Public Radio is Technical Manager for the project that is refurbishing and enhancing public radio's eleven-year-old satellite interconnection system.

Network radio is as varied in its structure and programming as is local radio. Some networks exist to distribute a single program. Others offer a few hours of specialty programming daily. A few schedule hourly news reports as well as commentaries and play by play coverage of major sporting events. Some provide stations with all the programming needed to fill an entire twenty-four hour broadcast day.

Forty-seven companies provide some form of national radio network programming. They operate a total of eighty-eight individual network audio services. A number of other companies, not listed here, offer regional, state and sports network services.

Following unprecedented growth in their ranks throughout the early 1980's, numerous consolidations have reduced the number of companies playing the national network game as we enter the 1990's. Several announced ventures never began service; others failed after a short time on the air. Since the 1989 edition of the M Street Radio Directory, Capital Cities/ABC, Inc., purchased Satellite Music Networks and the Transtar Radio Networks merged with the United Stations Radio Networks.

Network programming generally falls into four categories:

- newscasts (news reports of less than fifteen minutes duration)
- features (short programs other than newscasts)
- long-form programming (complete programs of 30 minutes to several hours in length)
- format delivery (programming that can fill a station's entire broadcast day)

All national radio networks in the United States are delivered to local stations by satellite. Some use a digital transmission service provided by GE American Communications from either Vernon Valley, New Jersey, or Culver City, California, that is commonly abbreviated "DATS" and is delivered on Satcom 1R. Others use analog transmission, either single channel per carrier (FM SCPC) or FM subcarrier (called "FM squared" when provided by United Video). Generally, FM SCPC radio networks are located on Westar 4, on Galaxy 2 or on Satcom 1R. Subcarrier operations are scattered among many satellites with many on Spacenet 3.

Here is M Street's current compilation:

ABC/CAPITAL CITIES owns both the ABC RADIO NETWORKS and SATELLITE MUSIC NETWORK. The seven ABC Radio services provide mainly news and features. The ten SMN services, acquired in 1989, provide formats.

News and Talk Services:

- ABC INFORMATION network is used by news, talk, full-service and other stations. The most popular program in all of network radio, "Paul Harvey News," is carried by this network.
- ABC DIRECTION and ENTERTAINMENT networks tend to affiliate with other adult-formatted radio stations in markets where Information is already in use.
- ABC CONTEMPORARY network is intended for contemporary hit formatted radio stations.
- ABC ROCK network is often found on album rock stations.
- ABC FM network is targeted to stations which appeal to 18 to 34 year old adults.

- ABC TALKRADIO provides long-form telephone talk programming.

Format services:

- STARSTATION is adult contemporary.
- COUNTRY COAST TO COAST is modern country.
- STARDUST is adult standards.
- HEAT is contemporary hits.
- HEART AND SOUL is adult urban contemporary.
- PURE GOLD is rock oldies.
- KOOL GOLD is a second rock oldies format emphasizing music of the 1950's and early 1960s. It consists mainly of the live programming of Adams Communications' KOOL(AM) Phoenix.
- Z-ROCK is heavy metal album oriented rock.
- THE WAVE is new-age music, also called new adult contemporary.
- TRADITIONAL COUNTRY is produced by KNIX(AM) Tempe, Arizona, a station owned by Buck Owens.

Owner: Capital Cities Communications/ABC, Inc. ABC Radio originates from New York. The SMN services originate from Dallas, Phoenix and Mokena, Illinois. DATS on Satcom 1R (ABC); single channel per carrier on Westar 4 (SMN Heat) and analog FM squared on Spacenet 3 (all SMN services).

AGRINET provides seven daily farm news feeds. DATS on Satcom 1R and FM SCPC on Galaxy 2.

AMBASSASOR RADIO NETWORK provides religious programming. FM subcarrier on Spacenet 3 and on Satcom 4.

AMERICAN PUBLIC RADIO provides long-form programs to public radio stations. Its most popular performance programs are "Garrison Keillor's American Radio Company of the Air" and eruns of the show it's based on, "A Prairie Home Companion." "Saint Paul Sunday Morning," and other music programs are also carried. APR's news shows are "Monitoradio," which it markets for the Christian Science Monitor, and "Marketplace." There are two overnight, long-form programs: a classical music service operating seven days a week called "Music Through the Night" and a weekend jazz service called "Jazz After Hours." In addition, APR distributes an American version of the BBC World Service which runs 24 hours, 7 days. Owner: Minnesota Public Radio and others. Origination: Saint Paul, Minnesota, and elsewhere. FM SCPC on Westar 4.

AMERICAN RADIO NETWORKS provides a live call-in talk show format intended for use by AM stations. Origination: Albany, New York. DATS on Satcom 1R and FM SCPC on Galaxy 2.

ASSOCIATED PRESS RADIO NETWORK provides newscasts, features and long-form programming for stations of any format and audience. Owner: Associated Press newspaper cooperative. Origination: Washington. Non-DATS digital transmission on Spacenet 3 and FM SCPC on Westar 4.

NETWORKS

BEETHOVEN SATELLITE NETWORK provides long-form classical music programming in evening and overnight hours. Owner: WFMT(FM) Chicago. Origination: Chicago, but programmed separately from WFMT. FM SCPC on Westar 4.

BIBLE BROADCASTING NETWORK provides a Christian programming format. FM SCPC on Westar 4. Origination: Chesapeake, Virginia.

BUSINESS RADIO NETWORK provides business news and features which may be used as a complete format. Origination: Colorado Springs, Colorado. DATS and FM SCPC on Satcom 1R and FM subcarrier on Galaxy 3.

CADENA RADIO CENTRO provides a Spanish programming format plus sports, features and specials. Origination: Irving, Texas, and Mexico City. Owner: Organizacion Radio Centro of Mexico. FM SCPC on Westar 4.

CATHOLIC TELECOMMUNICATIONS NETWORK OF AMERICA (CTNA) RADIO NETWORK provides religious programming via FM subcarrier on Westar 5.

CBN RADIO NETWORK, a part of the Christian Broadcasting Network, is a format service providing contemporary Christian music, a daily one-hour talk show and a daily 30-minute newscast. CBN has also announced plans for a second network, consisting of politically conservative talk shows, originating at its WNTR (AM) Silver Spring, Maryland. FM subcarrier on Galaxy 1.

CBS RADIO NETWORK provides newscasts, features and long-form programming to stations of any format and audience. CBS RADIORADIO caters to album oriented rock and contemporary hit stations. Owner: CBS, Inc. Origination: New York. DATS on Satcom 1R.

CNN RADIO NETWORK provides newscasts, features and long-form programming used by both news-talk and music stations. Provides about 15 minutes of news and features per hour during prime times, less in off-hours. Owner: Turner Broadcasting System. Origination: Atlanta. FM subcarrier on Galaxy 1, on Spacenet 3 and on Telstar 301; also DATS on Satcom 1R.

CONCERT MUSIC CONSORTIUM provides classical music and other fine arts programming to commercial and public radio stations. Owners: stations WCLV Cleveland, WFMT Chicago and WCRB Boston. Origination: Chicago. FM SCPC on Westar 4.

DRAKE-CHENAULT/JONES INTERCABLE provides three format services.

- ADULT CONTEMPORARY,
- PRIME DEMO, a soft adult contemporary format and
- GREAT AMERICAN COUNTRY.

FAMILY RADIO provides religious and classical programming format to radio stations owned by the Family Stations group. Origination: Oakland, California. FM SCPC on Westar 4.

GREEK RADIO NETWORK provides a Greek ethnic radio format. Galaxy 1.

NETWORKS

INTERNATIONAL BROADCASTING NETWORK provides religious programming the most interesting of which is a live, call-in show hosted by Denver evangelist Bob Larsen. FM subcarrier on Spacenet 3.

INTERSTATE SATELLITE NETWORK provides a contemporary Christian format service originating at KYMS(FM) Santa Ana, California. FM subcarrier on Satcom 3R.

IN-TOUCH NETWORK provides fulltime programming consisting of readings of newspapers, magazines and books intended for "print-handicapped" audiences. Origination: New York. FM SCPC on Westar 4 and FM subcarrier on Satcom 3R and 4 and on Galaxy 3.

KAYLA SATELLITE BROADCASTING NETWORK provides two formats:

- NORTH AMERICA ONE, a country and talk service intended for use by small-town radio stations and

- SUN RADIO NETWORK, an all-talk format.

Origination: Tampa, Florida. FM SCPC on Galaxy 2 and FM subcarrier on Spacenet 3 and FM subcarrier and DATS on Satcom 1R. At press time, North America One was in the process of moving from Richland Center, Wisconsin, to Tampa, Florida. When the move is complete, NAO may be on the same satellite(s) as Sun or it may remain on Telstar 303 and on Satcom 2R.

LIBERTY RADIO NETWORK provides religious programming. Owner: Dr. Jerry Falwell's Liberty University. Origination: Lynchburg, Virginia. FM subcarrier on Galaxy 3.

LOTUS SATELLITE NETWORK provides features, public affairs programs and sports to over 100 Spanish language affiliates. Origination: Los Angeles.

MOODY BROADCASTING NETWORK provides religious-oriented newscasts, features, and long-form programming to Moody-owned and -affiliated stations, including satellite-fed translators, scattered around the country. Owner: Moody Bible Institute. Origination: Chicago. FM subcarrier on Galaxy 1, on Spacenet 3 and on Alascom Aurora.

MONEY RADIO NETWORK provides a business and financial news and talk format. Originates at KMNY (AM) Pomona, California. FM SCPC on Westar 4; both DATS and FM SCPC on Satcom 1R.

MOTOR RACING NETWORK provides live coverage of auto races sanctioned by the NASCAR auto racing circuit (principally the Winston Cup series) plus call-in and related programming to stations of any format and audience. Operates on Tuesday evenings and on most Saturday and Sunday afternoons, also at other times when races are scheduled. Owner: substantially controlled by the same interests as NASCAR. Origination: Daytona Beach, Florida. FM SCPC on Westar 4 and on Galaxy 2; also DATS on Satcom 1R.

NASHVILLE NETWORK RADIO, THE (TNNR) provides a country music format. Owners: Group W Satellite Communications and Opryland USA, Inc., part of Gaylord Broadcasting Co. FM subcarrier on Galaxy 1.

NATIONAL BLACK NETWORK (NBN) provides newscasts, features and long-form programming to black oriented stations. Owner: Unity Broadcasting Co. Origination: New York. FM subcarrier on Satcom 4 and on Spacenet 3.

NETWORKS

NATIONAL PUBLIC RADIO produces newscasts and long-form programs for public radio stations. NPR's main programs are "Morning Edition," "Weekend Edition," "All Things Considered," "Performance Today," "Afropop Worldwide" and the newest entry, "HEAT with John Hockenberry," a late-night talk and music show. In addition, top of the hour newscasts (actually at one minute past the hour) are offered from 5:01 AM to 10:01 PM ET. Origination: Washington and New York. FM SCPC on Westar 4.

NORTH AMERICA ONE. See KAYLA SATELLITE BROADCASTING NETWORK.

OVERDRIVE RADIO NETWORK provides news programming for long distance truckers.

PROGRESSIVE RADIO NETWORK provides a new-age contemporary format called **THE BREEZE**. Origination: Minneapolis, Minnesota. FM subcarrier on Spacenet 3.

PUBLIC RADIO SATELLITE SYSTEM is a "blocks of time for sale" operation providing newscasts, features and long-form programming totaling about 2,500 programs a month intended for use by public radio stations. It allows individual radio stations or small producers to have a national reach for their programming. Distribution to commercial stations is also offered. Owned jointly by participating public radio stations. Operator: National Public Radio. Origination: Washington and 20 other cities. FM SCPC on Westar 4.

SATELLITE JAZZ NETWORK provides a jazz format by satellite. Origination: KKGQ (FM) Los Angeles, but programmed separately from KKGQ. FM subcarrier on Satcom 3R and on Satcom 4, DATS on Satcom 1R and FM subcarrier on Spacenet 3.

SATELLITE RADIO NETWORK provides religious-oriented talk programming. FM subcarrier on Galaxy 1 and on Satcom 3R. Origination: Charlotte, North Carolina.

SHEEN RADIO NETWORK produces and distributes talk programs on finance and investments and on other subjects. Origination: Boca Raton, Florida.

SHERIDAN BROADCASTING NETWORK (SBN) provides newscasts, features and long-form programs mainly to black oriented stations. Origination: Pittsburgh. FM subcarrier on Westar 5 and on Satcom 4.

SKYLIGHT provides an adult, Christian format with mostly light, classically-oriented religious music. Owner: Northwestern College. Origination: Roseville, Minnesota. FM SCPC on Westar 4.

SUN RADIO NETWORK. See KAYLA SATELLITE BROADCASTING NETWORK.

SUPERADIO provides a weekend contemporary hit program called "Open House Party." On Satcom K2.

THE NASHVILLE NETWORK RADIO (TNNR) see NASHVILLE NETWORK RADIO.

TIDEWATER RADIO NETWORK provides programming oriented toward black religious stations. FM subcarrier on Satcom 4.

NETWORKS

TRIBUNE RADIO NETWORKS provides farm coverage plus an overnight country music and information service called INTERSTATE RADIO NETWORK. The program is hosted by Fred Sanders and is intended for use from midnight to 5 AM, affiliate local time. Galaxy 2.

UNISTAR RADIO NETWORKS is the result of a merger of the Transtar and United Stations networks. The combined company, based in Arlington, Virginia and in Colorado Springs, Colorado, provides eight format services, two news services and a syndication/long-form program service.

- UNISTAR 1 is a newscast service used mainly by contemporary hit and adult contemporary stations.
- UNISTAR 2 is a second newscast service used mainly by country, adult contemporary or adult standards formatted stations.
- UNISTAR PROGRAMMING NETWORK provides long-form programming.
- AC II is an adult contemporary format
- COUNTRY
- FORMAT 41 is a second adult contemporary service aimed at slightly older audiences with a median age of 41.
- THE OLDIES CHANNEL is rock oldies, mainly from the '60's and '70's.
- AM ONLY is an adult standards format targeted to listeners aged 35 to 54 but avoiding big-band music.
- NICHE 29 is a contemporary hits format targeting 21 to 36 year olds.
- SPECIAL BLEND is soft adult contemporary intended for easy listening stations making the transition to soft AC.
- MUSIC OF YOUR LIFE is an adult standards format including big bands, produced by Al Ham. The satellite version of MOYL, unlike its mailed-tape counterpart, includes network-provided announcements of song titles and artists.
- Unistar is also the exclusive distribution agent for CNN Headline News audio service and for the CNN Radio Network format service.

Origination: Arlington, Virginia, Colorado Springs and Los Angeles. FM subcarrier on Spacenet 3 and Telstar 301 and DATS on Satcom 1R. Owners: C. Terry Robinson (from Transtar) and Nick Verbitsky (from United Stations) are co-CEOs; other major ownership interest: Bill Hogan, Ed Salamon and Dick Clark.

UPI AUDIO NETWORK provides newscasts, features and long-form programming to 000 stations of any format and audience. The UPI SPANISH RADIO NETWORK provides newscasts. Owner: Infotechnology, Inc. Origination: New York. FM SPCP on Westar 4.

USA RADIO NETWORK serves commercial Christian stations. Owner: Soma Communications, Inc. FM subcarrier on Telstar 303, on Spacenet 3 and on Galaxy 1 and 3.

WALL STREET JOURNAL RADIO NETWORK provides newscasts and features with a business and financial specialty. THE WALL STREET JOURNAL REPORT is intended for AM, talk, news or full-service stations. THE DOW JONES REPORT is intended for FM or music stations. Owner: Dow Jones Publications. Origination: New York. DATS on Satcom 1R.

NETWORKS

WESTWOOD ONE owns the Mutual and NBC Networks, which offer mainly news and talk services, and a long-form service under its own name.

- NBC RADIO NETWORK and MUTUAL RADIO NETWORK provide news, features and long-form programming to stations of any format and audience. Mutual's best known program is the overnight call-in "Larry King Show."

- THE SOURCE, "NBC's Young Adult Network," caters to album oriented rock, contemporary hit and adult contemporary stations.

- TALKNET provides long-form telephone talk programming in evening and overnight hours intended for stations which appeal mostly to adults.

- MUTUAL PM, marketed separately from Mutual Radio, provides news and features for stations in the western United States.

- WESTWOOD ONE RADIO NETWORK provides long-form music programming to contemporary stations.

Owner: Norman Pattiz, others. Origination: Culver City, California (Westwood One services) and Arlington, Virginia (NBC and Mutual services). DATS on Satcom F1R.

WINNERS NEWS NETWORK provides inspirational talk segments intended to promote the personal and financial successes of listeners. Short talk segments by authors of motivational books and articles are repeated in a rotation like hit records. Promoted as "The Motivation Station." Owner: Nightingale/Conant Enterprises. Origination: WWNN (AM) Pompano Beach, Florida. FM subcarrier on Spacenet 3 and FM SCPC on Galaxy 2.

WASHINGTON THIS WEEK

It Ain't Over, Even When the Fat Lady Sings. The call letter change of WKJY-1550 Parsons TN to WKJQ this week ends the latest instance where an FCC reversal caught - and cost - a broadcaster. WTBP-1550 had been granted the calls WKJY last Spring by the FCC, even though another WKJY had existed for years in Hempstead NY. The FCC misplaced a card file containing the record of the existing station.

Last week, WIOI-FM Brunswick GA was stung when the FCC reversed an earlier

decision allowing WIOI to place a high-power booster 60 miles away in Jacksonville FL. The booster had substantially altered WIOI's marketing and increased the station's value. Earlier this month, an FCC-approved settlement agreement allowing the contesting parties to sell to Rowland Broadcasting was reversed at the FCC's initiative - after Rowland hired staff and signed programming contracts for the new FM it had "irreversibly" been granted. These and other examples raise an interesting question: when, exactly, does an FCC decision become final?

FCC Releases Revised New Rate Card. The FCC has issued several revisions to its new fee schedule. New rates will take effect "as early as June 1." Fees not listed in the previous fee schedule include:

Call sign modification (AM/FM/TV)	55
STA (other than to remain silent) (all)	100
Extension of time to construct or replace CP (AM/FM/TV)	200
Petition for rulemaking for city of license or channel (FM/TV)	1565

ELSEWHERE

Thomas Root, the Washington communications lawyer involved in a bizarre plane flight and shooting last summer, was indicted last week on 33 counts of fraud, filing false and altered documents, forgery and obstruction of justice in dealings with the FCC and with clients trying to obtain new Docket 80-90 FMs. Alleged incidents include double-billing clients, forging FAA clearances and letters to and from the FCC, and misrepresenting negotiations for land leases.

Atlanta's New FM? This week's rulemaking proposal to move WHMA-FM-100.5 to Sandy Springs GA is part of an elaborate plan by new WHMA-FM owner Tom Gammon to convert the station into a major Atlanta FM. The shift, if approved, moves WHMA-FM nearly 90 miles east into Atlanta; creates a new Anniston FM; limits the upgrade potential of several other Atlanta area FMs; and downgrades WSSL-FM-100.5 Greenville SC from Class C to Class C1. The uproar over WHMA-FM's potential move includes protests and outrage among local listeners upset at "losing" Anniston's only FM; reluctance to sanction the move in Fulton County, which is trying to block the efforts of Sandy Springs to incorporate; and resentment among several Atlanta FMs. Cap Cities/ABC, owner of country rival WKHX on adjacent 101.5, has pulled all business from Gammon's former company, American Media Brokers, to protest the move. While the FCC has approved moves of such distances before, they have never involved existing stations, major FM facilities or major markets; the move if approved would increase WHMA-FM's value by 400-500%.

APRIL BFM CALENDAR NOTES

Quarterly Issues/Programs Lists for Jan.-Mar. should be in stations' public files by Apr. 10. Federal taxes for stations filing calendar year individual returns are due Apr. 16. By Apr. 15, stations with tower lights must conduct and record quarterly tower light inspections.
