DX NEWS

SEPTEMBER 12, 1934

Well here we are back again with more DX news, just a week after the DX Season has been officially declared open. We hope that all of you are getting started very successfully.

First of all we have several more new members to welcome into the club at this time: Fred Stone, Kintnersville, Penna; John J. Donaldson, P. O. Box 471, Greenville, Penna and T. E. Gootee, 1367 Roanoke, Springfield, Mo. We hope that these three members will find their membership in our club very beneficial and that they will derive the greatest of pleasure out of our Bulletins.

Your editor received a very fine letter from WMMN, Fairmont, West Virginia in which they advise us that they plan to start their DX programs about November 18 and each Sunday morning, thereafter, from 2:00 until 5:00 A.M., E.S.T. They have also promised to dedicate some of these broadcasts to the members of our club.

We wonder how many of you heard the excellent broadcast that Alec Kinghorn put on for our club this past Saturday morning over CMW in Havana. Unfortunately, we listed them as being on 590 kycs and after trying for them about 15 minutes on that frequency, we decided that they must be using some other frequency and after ye editor hunted around a bit, he found them on 910 kycs. They certainly did come in mighty fine and we want to take this opportunity to thank Mr. Kinghorn for the splendid amount of publicity that he gave N.R.C. during the course of this fine broadcast.

We heard the excellent dedication over KGBX for the members of our club last week and we want to thank them for the fine publicity they gave our club. They certainly did come through very fine and we are sure that those of you who tuned for them had no trouble hearing them at all. After hearing them, ye editor decided to hunt around a bit to see how the other stations were coming in and you can imagine his great surprise to hear 2BL, 4QG, 2YA and 3AR all coming in. We had not been expecting to hear any of the Aussies for another month yet. Therefore we would advise you to watch very closely for them, for we feel that from now on they should begin to improve. We would advise you to try as many mornings as you possibly can from now until the latter part of October from 4:30 to 6:15 A.M., E.S.T. which seems to be the time they are heard best around here.

Ray Lewis and Joe Becker advise us that they heard KWYO testing last Friday morning. We are making an effort to find out whether they are going to run this program as a monthly frequency check or whether it was just an ordinary test program. We will advise you just as soon as we find out definitely from either the station or the FCC.

Ray Lewis also advises us to tell you that he recently heard LS2 the new 40KW station in Buenos Aires at 7 PM EST. He says that they break through every now and then at that time during the evening before WOAI starts coming through. Both WOAI and LS2 operate on 1190 kycs and we would suggest that you try for LS2 as soon as possible, before the night time starts setting in too early, for WOAI will start coming in earlier as the nights get longer and hence they may prevent your hearing LS2 so therefore do not miss a single opportunity to try for them.

RULES AND DEFINITIONS CONCERNING SINGLETON AND ELIMINATOR CONTEST:

SINGLETON - A verification recorded by one member only. This, when verified and recorded by another member, becomes ELIMINATED, and the second veri is known as an --

ELIMINATOR * and is noted as such in the Bulletins.

POSSIBLE SINGLETON - This is a list of stations as yet verified by no member. This includes all eligible stations published in Radex, our authority, and in addition it is understood to include all stations not published in Radex, unless noted otherwise in the list of eliminated stations in each publication of the contest.

RULES OF CONTEST:

1. The first member's veri to be recorded will receive credit due.
2. Deleted stations, whether held as singletons, or listed as possible singletons will be dropped from the list in question.
3. New stations, or new call letters will be added to the possible singleton List.
4. Call letters alone will count. Changes of location or power do not count unless a new call is issued.
5. If a deleted station which has been dropped from the records of the contest is reinstated, we will replace it to it's proper place. If it had been a singleton, it will again be so, etc.
6. Outlaw stations are not eligible in the contest.
7. Envelopes must accompany letters - something to establish the fact that it was mailed from the location of the station. If this rule is not followed, we cannot use the veri in the contest.
8. Genuine veris - the originals, not copies must be sent for competition. (We've never lost one yet, as any contestant will attest.)
9. Keith L. Freas, 115 Wabash Ave., Kenmore, N. Y. will be the sole judge, and all veris for the contest will be sent to him. In case of any reasonable dispute, he will confer with a committee composed of Robert Weaver and Charles Huber, and the net result will be final.
10. In any case of attempted fraud, as termed by the committee, the member will be suspended, and will not be eligible for reinstatement except at the discretion of the committee.

We therefore do not know now, whether they will continue broadcasting from 12:00 to 2:00 A.M., E.S.T. on Wednesday mornings for the members of our club or whether these broadcasts will take place at the time they first mentioned, namely from 3:00 to 4:00 A.M.
