KAGO-1150 HONORS N.R.C. WITH DX BROADCAST 1/23

On Monday morning, January 23, 1961, from 3:00 to 3:30 a.m., E.S.T., Station KAGO in Klamath Falls, Oregon will present a Special DX Program for the National Radio Club. KAGO operates on 1150 kilocycles with 1,000 watts of power, and is directional eastward, which should make reception of KAGO quite possible at really long distances from Klamath Falls. This station was formerly known as KFJI, having changed its calls to KAGO (Kay-Go) in December of 1959. Many NRCers need this station in their logs, and here is the opportunity to fill that void, and log this much-sought station. Station WCOP in Boston is generally on AN Monday mornings, but they are probably the only other station which will be on 1150 at this time, so here's wishing KAGO and all you good NRC DXers good reception! We thank Mr. Ernie Cara, Program Director of KAGO for this Courtesy Program, and reports should be sent to him.

As a result of their December 19th equipment test, Station KCEE-790 received 20 reports, from Washington (2), California (4), Pennsylvania (2), Massachusetts (2) and one from each of the following: New Jersey, Colorado, Texas, Iowa, Illinois, Minnesota Ohio, New York, Rhode Island, and Ontario. Mr. Ed Hepp, the engineer who made this test was very pleased to learn how far out his station could be heard and wishes to thank the NRC and its members for their co-operation. (information from Len Kruse)

We urge all members when sending in their Musings Reports to the above address in Brooklyn, to use Eastern Standard Time throughout to avoid confusion, and also to give the frequencies of stations logged, and the date and time of these loggings, to help others who might want to try for these stations, and please double space!! Thank you.

First of all, I would like to say "hi" to everyone from the SW corner of British Columbia. try to get a report in every issue and keep the DX NEWS thicker.
