(Many will remember Ed O'Donnell as one of the speakers at the '89 NRC Convention.)

It wasn't too long ago that Ed O'Donnell of WIBW-AM walked into a college arena lugging his radio equipment and people boked at him as if he were E.T. when he announced he was there to broadcast the Kansas State women's game.

Women's college basketball on radio? It just wasn't done.

"Our first few years of having the (K-State) men's network, there was nothing in our contract that said we had to do women's games," said O'Donnell, executive producer of the Wildeat Sports Network since WILDEW bought the rights in 1980. "But we said, "Well, we'll see if we can bein them out."

At first, WIBW broadcast just a couple of games, including Kanasas-K-State. Then it did five ut six games. The third pear, it did all the road games, plus a few swleet home games. The number grew steadily. This season, the station will air 21 regular-season games.

"It's been amazing," O'Donnell

The really amaxing thing is O'Donnell, who delights in being reserved to as the "Voice of the Lady Cats," no longer is a Lone Ranger as a broadcaster of women's college basketball.

KTOP-AM in Topeka has joined the game locally, adding the Kansas Lady Jayhawks and more of the Washburn Lady Blues to its lineup.

KTOP will carry all the KU women's games in an arrangement with 'independent producer Bernie Bottenberg. Pat Krueger handles the play-by-play and Peg Wittmer provides color commentary.

The station already carried Washburn men's basketball, and it committed to carrying all the women's conference games, as well. That was made easier because the men and women's programs play doubleheaders in the Missouri Inter-

conseguate Athless association. Ron Simon and Galen Brown handle the broadcast duties.

Around the Big Eight Conference, the story is much the same. A survey of sports information departments reveals that every Big Eight women's program has at least a few games broadcast, in fact, lows Shite is the only school that doesn't have at least 17 games scheduled to be broadcast; the Cyclones will be on the air only five or six times.

Suddenly, broadcasting women's college basketball on the radio is in vogue. Why? "We're a big believer in women's

"Were a big believer in women's sports in the 1990s," said Greg Philips, operations manager at KTOP.
"It's going to make big gains in interest, and we want to be able to say we were on the ground floor."

Said O'Donnell, "We think there's
a need. There are a lot of Lady Cat
fant. Their program always has
been a well supported program.

"We've got some very good sponsorship. People in Manhattan support it with their advertising dollars and people listen."

Ah, there's the point. The local stations are not so much providing a public service when it comes to women's basketball as they are being good oi capitalists.

Quite simply, Lady Cat broadcasts are profitable for WIBW.

"It's not a money loser, we make money on those broadcasts," O'Donnell said. "I tell this, to other broadcasters and it blows their minds. They find that hard to believe."

Bottenberg believes it; he'd just like to see it happen for the KU women's broadcasts.

It was Bottenberg who approached KTOP about a package of Lady Jayhawk games. As he tells it, he was "sitting around talking about what wasn't in the (radio) market and thought. Why not women's college-level basketball?"

But it has been slow going intercially. Part of the reason was a late start, a few weeks before the season, part could be that KU's women's program traditionally has lacked the strong support from the Lawrence community that K-State has enjoyed in Manhattan; part could be that no one really has tried it before.

"We had the name in Coach Marian Washington and the records she had in the past and the accomplishments, but from that point on, it's been a learning experience," Bottenberg said. "It's not a good thing (financially), right now, more or less I'm financing it myself."

Bottenberg's budget is between \$12,000 and \$14,000. His equipment cost \$1,600. He needs to raise about \$500 to follow KU to a Miami, Fla., tournament after Christmas.

The advertising might be easier to sell if Bottenberg knew who was listening — the demographics as well as the numbers — but he professes

nell and Phillips. If they know the number of listeners their broadcasts attract, they aren't saying.

"I wish I could put my finger 100 percent on who is listening to the broadcasts," Bottenberg said. "I know someone's listening because we're getting calls. I wish there were 150 of them (calls)."

Phillips says KTOP also has received calls about the KU games.

ceived cains about the KD games. Still, he says, "I have no idea what kind of listenership it has. That's not going to be the thing that makes or breaks our decision at this point to carry the games."

Answered O'Donnell: "I have no idea. That isn't the point. We know there are listeners. Players' families listen. People tell me they listen. We know they're there."

Bottenberg believes they will be there for the KU games, too, along with support from sponsors. He simply believes there is a market for women's basketball broadcasts.

"Of course, there is a market," he said. "There's no question (he's committed). It's just discouraging at times. Other times, you get so pumped up.

"It's a scramble. Thank God, I do other things for a living." **Tony Fitzherbert**

Al also notes that WVSJ-1360, Washington Township, N.J., has signed on the air and is focusing on Gloucester County with news, talk, and sports, plus an adult standard music format.

Phil Boesma, of Spring Lake, MI, reports that WBMX-640, of Zeeland, MI is again silent. Maybe management ought to consider something really exciting, such as motivational talk.

And your editor noted while over in Westchester County, that WVIP-1310, Mt. Kisco, has dropped its Talknet feed to restore the music of the 40's to 60's that it played endlessly automated before the dabble into Talknet. And several stops further up Metro North's Harlem Line finds WPUT-1510, Brewster, adding CNN Headline News to its adult standard/light AC format. And on a quick trip to Boston, Beantown radio is static, although WRCA-1330 has added comedy in the evening, pre-teen programs on Saturday, and sports / talk on the overnight. WADN-1120 is still folk, and still sounds great!!

Geov Parrish reports that WXGL-1240 in Lewiston, ME is gone. It //'ed its FM with all oldies. WTME-1530, 400 feet across the Androscoggin River, which //'s WKTQ-1450, South Paris, 18 miles away, dropped 1530 kbz., returning the license to the FCC, and moved to 1240, Lewiston, which now gives the station a full time signal. WTHE broadcasts from a Christian book store, on Center Street, in East Auburn, and relays WKTQ programming from South Paris. Now, will WTHE use its 150 foot tower on Summer Street Extension in Auburn, or WXGL's 250 foot self supported tower off Sabattus Street, Lewiston? 1240 khz, for over 40 years was WCOU, a full service station in Lewiston - Auburn.

Answers to members' questions, from the basic to the technical

Hello, again. It's time for another edition of Answerman to hit these pages. In the last column, we devoted it to AM Stereo in its entirety. This time. the bulk of the column will be devoted to Beverage antenna questions, but first, however, we'll start with a correction to an answer I gave in the column before the AM Stereo one. I'll also mention what should be obvious, namely, that I'm making my first public attempt at doing this in two columns. We'll see how it goes, hi

QUESTION: The question was the one which asked for a comparison of the use of a crystal filter and a Qmultiplier.

ANSWER: The real answer is that a quartz crystal, as employed in a crystal filter, resonates as voltage is applied to it. This vibration simulates a very high-Q series tuned circuit. This then acts as an extremely narrow filter which rejects frequencies away from the resonant point. My earlier, erroneous answer indicated that the crystal produced a beat frequency to remove the unwanted signal. My apologies for the error.

QUESTION: I have recently purchased a Magnavox D-2999 SW receiver. On MW, I find strong open carriers on the following frequencies: 630, 755, 880, 1130, and 1380 kHz. These are at intervals of either 125 or 250 kHz. What could be causing these ?

Without knowing something about the receiver, I can't say for sure, but I'll offer some ideas. First, does the receiver have either a 125 or 250 kHz crystal calibrator ? If so, it may be on either by the intent of the manufacturer (in that it is always on, which I doubt) or that you've simply neglected to turn it off, or that there's a defect in the switching circuitry. What is the IF frequency of the rx ? Although I've never heard of either 125 or 250 kHz being used, I suppose that nothing is sacred. Is there some other selectivity device in the rx which is on and oscillating ? Hone that I'm aware of should do that, but, again, stranger things have happened. Try disconnecting it from all accessories, turn all optional equipment built-in off, and use a short wire as an antenna. If that solves it, systematically turn things on or add them back into the overall mix until you find something which brings the problem back again.

QUESTION: I have a Realistic DX-440, which I'd like to use for BCB. It has an external antenna jack which is for SW only. I'd like to use some sort of a loop antenna with it. Can I do this? I also have an Ameco TPA which I use for SWL. I live in a condo, and can't put up an outdoor antenna.

ANSWER: I'm not familiar with the DX-440 specifically; however, I don't believe that any of its predecessors had an external antenna jack which was limited to Sw. Are you sure on this? If it's not, then you can use almost anything. If it is, I'll have to solicit advice from one of the other DX-440 users out there. As to what types of antennas you could use, I've covered this issue in this column a number of times, but the best bet is either to build one (see the Antenna Reference Manuals, [both Vol. 1 and 2] as well as the reprints list for further info. The Radio West loop is still commercially available new. For a used loop, watch the DXChange section of the Editor's section of DX NEWS.

QUESTION: I am looking for a loop, either the NRC FET altazimuth type or something similar to use with an HQ-180AC. My location is subject to many powerful signals in all directions, so I need as good a loop as I can get. What would you suggest ?

ANSWER: Refer to the answer to the prior question for part of yours. As to the NRC loop, buying one used is possible, but not probable. Parts availability for someone to build one is greater and greater, considering that the parts specified date back 22 years. One member was building these on a special-order basis, but although I've asked him to respond in these pages, since I don't have an address, and I've had none, I must assume that he is no longer doing so, due either to supply problems or

QUESTION: I have several questions about Beverage (wave) antennas. A) Can I use various different gauges of wire, and twist connectors without hurting the effect ? B) Can I run the antenna along a barbed wire fence with metal posts ? Can I do this if the wire is insulated ? C) Does coiling the end of the length help ? D) I coiled the end of a 750' length [about 100'] and dumped it in a pond. Will this help ? E) Is

resistance, which is the most common seems to have no effect. F) For best coverage, how many lengths, and in what directions? If not terminated, does it even matter? Space is not an issue. G) Does wire size or insulated vs. not matter all that much? H) Can I use my Grove tuner as a phaser? If so, how? If not, where can I buy a phasing unit?

ANSWER: Whew ! Before specifically answering your various points, I'd like to mention that the NRC Antenna Reference Manuals [again, both volumes] contain a great deal of useful material which will be helpful on this subject. Now, I'll go on. A) Using various gauges of wire isn't a good idea, as it will affect the pattern and may induce unwanted noise. Electrical twist connectors have two major drawbacks for this type of use - first, tension will pull the wires out, resulting in disconnection, and second, the electrical connection is not as good as with either well-soldered, or no joints. That can lead to moisture build-up, corrosion, and much noise. B) Running the antenna along anything metal will seriously impair its performance, both in terms of pattern and noise. This is true regardless of whether the wire is insulated. The metal posts with uninsulated wire will simply ground your antenna, and making it useless. Metal posts with insulated wire won't be as bad, but will still impair performance. C) To the best of my knowledge, coiling the end won't add anything to the effect, and may harm it. D) Throwing the coil into a pond, however, may create an effect quite similar to a direct termination, which leads to the next point. E) Termination is not an absolute. It does significantly reduce signals from the opposite direction. Termination requires a good electrical ground, and the proper value of termination

cause of apparent lack of effect. The values must be experimented with, as per the various articles on the subject. F) How many lengths, and in what directions are ngually determined by geographic relation to the target stations and available space. Since the latter isn't an issue, eight wires, each terminated for unidirectional reception and spaced at 45 degree angles would cover all of the possibilities, but from your location and intentions, I would recommend eliminating the North, and East components as should be able to hear what you want to hear most of the time with any reasonable antenna. In order to do this, all should be terminated. Lengths of between at least 350° should be sufficient. G) Wire size does have an effect. I would suggest stranded copper wire, which is not cheap, of no smaller diameter than #12, and preferably # 10 or # 8, and preferably insulated. H) So far as I know, the Grove tuners are tuners, and not phasers, and the two are not interchangeable. I am not aware of any phasing units available from commercial manufacturers, however, at least one NRC member has built such units for others in the past. Should this still be the case, I hope that he will contact me, so that I can pass that information on. One note, however, you should be able to achieve your goal without phasing.

NDB's Operating In/Near the BCB

Back in Issue 8 Charles Reh of Learnington, Ontario had a logging of a Non-Directional Beacon station from Colombia. That got me to wonder what other NDB stations are operating in or near that Medium-Wave Band. So with the help of some Flight Information Publications published by that Defense Mapping Agency, I have compiled the following list. Although there are literally hundreds of these NDBs operating from around 195 to 1715 kHz, most are found in the 195 to 400 kHz range. Those with communications receivers are probably well-aware of their existence. I have singled out those operating from 500 kHz to 1715 kHz. Powers for these stations typically range from 20 to 500 watts, to as high as 10000 watts in a few cases. Good DXI

ERIC BUENEMAN - 5202 CROSS RIDGE CT. - WOODSTOCK, GA 30188-4380 Even though this will arrive way past the deadline for the Special Musings column, I will tell you about my work in radio anyway! Ever since I began DX'ing in '81, I knew that my hobby would eventually lead me to the DJ booth. I grew up listening to the likes of Ron Morgan on KSD-550 (now KUSA) and KSD-FM 93.7, Lee Sherwood on WMAQ-670 (and later KSD/KUSA), Johnny Rabbitt on KXOK-630, Bobby Day on KSLQ-98.1 (now KYKY) and KWK-1380 (now KGLD) and Jim White and the late Jack Carney on KM0X-1120, and those personalities were early influences on my decision to become an on-air personality. With the help of Kevin Vetter, who at the time lived 2 doors down from me in Hazelwood, MO, I got in at KCFV-89.5 Ferguson, MO in the fall of 85. From my start as the production assistant, I did my first airshift in December of that year, but there were some rough edges that needed to be worked out, so it was back to the production studio. I returned to the airwaves to stay in Auagust 86, first doing one hour air shifts then moving into primarily morning air shifts, with fill-in duty in all other time slots. In Feb. 88, I moved to the Thursday morning drive slot with a group of ranies called the New Morning Wrecking Crew. After my father's employer transferred my family to Atlanta, I was out of radio for several months, until trying to get on WRFG-89.3 Atlanta and 2 weeks later getting a board operator bob at WFTD-1080 Marietta. After finding that DJ's had been waiting for air shifts since 87, I decided to stick with WFTD-1080, working a volunteer board shift on weekends (the same time as Saturday weddings!) and later as a paid, fill-in announcer/operator. Feeling the urge to be a DJ again, I decided to reduce my responsibilities at WFTD and do an oldies show at WGHR-102.5 across town, which I did on Sunday afternoons and for one quarter, Friday nights. I also did contemporary Christian, Clasical and 80's music shows before being fired from this job (again, a volunteer job) in July, due to the fact that I didn't register for classes at the Souther College of Technology. My style was changeable with ten stations format, and my way of attracting listeners was through information, trivia and some commedy drop-ins, provided that it fir my personality. Since I got into the broadcast business, I believed in a broadcast business that prefers the most qualified people over friends, acquaintances and relatives of station employees and/or management, and a business that hires without regard to age and disability, in addition to race, sex, creed, national origin or religion. On the other side of the coin, I have not fared to well in my attempt to break in to commercial broadcasting, being turned down for employment at every commercial station that I have ever applied at (the total is 31 so far). I am hoping that my recent ads will change this that were run in Radio World magazine. Improvements have to be made, however, with problems for entry level announcers in the business, including violations to various laws and union restrictions.

DAVID GLEASON - ARSO RADIO CORP. - P O BOX 5725 - SAN JUAN, PR 00906 Greetings! The theme for this issue, members who work in broadcasting, caught my attention so here is a Musing! I have worked in broadcasting since '59, the year that marked my Hoining the NRC, too. Presently, I am Vice President & Director of Arso Radio Corp. We operate WPRM 98.5 San Juan & WIVA 100.3 Aguadilla, PR as well as WNEL-1430 Caguas, PR, WDSR-1340/WNFB-94.3 Lake City, FL and WTNT94.9/WNLS-1270 Tallahassee, FL. The two PR FM's are in a simulcast network much like Y104/Y106 in the Atlanta area. Together, they cover all of PR 3,700,000 pop. Programming is salsa with a personality approach. WNEL serves the Caguas area, PR's 3rd largest metro, with Spanish nostalgia programming and the NotiUno news network. In Lake City, the AM is 24 hours, running news-talk. At night, we run NBC Talknet and Larry King from Mutual. Daytime incl;des ARN from 6 AM to noon and Russ Limbaugh at 12. The FM is Unistar AC. The airstaff spends most of its time working on local news and features, which we could never do in a small market unless we had the satellite programming. WINT was the #1 station in the last Tallahassee Arbition, and programs Contemporary Country and is the flagship station for FSU sports. The AM previously as WYYN, programmed motivational talk (sick!) but is now (or will be by the time this is published), WNLS "Noles 1270" with satellite traditional country 6A-7P with Talknet/Larry King overnights. The AM carries FSU baseball, FSU's womens basketball and MRN auto racing on Sundays. All of our stations are 24 hour operations. We are going to rebuild the AM sight for WNLS soon and are in the process of switching to a microwave link from the existing phone line tie. We just assumed ownership of Tallahassee on 11/18 and have a bunch of improvements ready to go. One that most DXers will not pick up on is our association with the Sunstar Network, a FL only operation, whereby we share a 4 person Tallahassee bureau for a substanial enhancement of the stations news presence in the state capital. Of the DX note: WNEL has been operating for about 3 years with 5kw at night, up from the previous 500 watts. We get about 1 report a week from Scandinavia on the station, which are usually answered by our CE. I have not checked whether Tallahassee gets reports. WDSR in Lake City is now using a new AM transmitter and unipole antenna and might get out better, at least locally the signal is

First, a correction. The station we visited in Knoxville at the University of TN was WUOT, not
WUTK as I reported in my Musing in the 11/12 DX NEWS. Second, Laura's FF on 1460 has to be
CKRB-PQ which puts a strong signal in here in the wee hours. Dave asked for members who work

at radio stations to describe their stations. I don't exactly work at WOMR-91.9, I am a non paid volunteer DJ, on the air 61 hours a week. On Mondays, I do a 15 minute interview show called "Community Profile" on which I talk with people of interest to listeners in this area, such as local entertainers, elder service people, scout leaders, drama directors and actors from loacl theater groups from here to Harwich, clergy, fund-raisers for various charitibable organizations, etc. Then I host the 4 hour "Lower Cape Concert Hall" til 5 PM, then read "The Town Crier", a community calendar type listing to 5:15. Then on Saturday mornings I have 2 hours, the first "The WOMR-Land of Music" featuring concert in the park type band music or, when availble, locally produced musical concerts which I have recorded. Then from 11 to 12 noon I do my favorite program "Forward - March", an hour of marches from all around the world. I have over 300 albums and about 75 cassette tapes of such music of my own from which to choose. Our antenna is atop the water tower which is on the town line between Provincetown & Truro. It is a tow bay "weakie". I do my own boardwork and we use a Wheatstone board. We have 2 turntables, 2 cassette players. 2 reel-to-reel players, 2 CD machines and one cart machine. And there are times when all of them work and conversely, times when some of them don't! We have one on-air studio and one production studio, with 2 more turntables, one reelto-reel and one cassette player, not sure if we have a CD player in there or not. It's that time of year where AM DXing becomes appealing again. Interest increased from attending the convention, I start tuning around in the car as sunset skip and the drive home from work coincide. And being in a new, more remote location tops it off (logged over 400 stations in two school years at Nelsonville, OH). 10/23 had strong EE teletalk on 690, so took it home and got a strong WPDQ ID at 11P, they use a "'69" jingle surely from an old jingle pacakage meaning the year 1969. 10/28 I bagan to realize that some of the NYC regionals are weak down this way w/WSYB-1380 VT well over WKDM at 7P, this near NJ 18/NJ 79 in Marlboro. 10/29 likely WVOT NC on 1420 ending NC network news and W-OT ID at 6P. Normally, I don't get out of work til 6P, well beyond LSS in November, but I got out of UNIX class early a couple of Mondays. 11/5 had 1 khz hets on 890, 1350, 1520 around 4:45 P, I've heard of times where these tones as hets turn into audio with adequate signal strength. Interestingly, ERC had Saudi Arabia on 1521 around the same time the week before. DX at home included, the first showing of CHTX-990 at 5:06P with ingle/DJ talk sounding like '990 Jam' but 'Jam' could be talk for a custom mix or a set of songs-in-a-row. Another weaker NYC regional allowed WPDC-1600 PA between 5:15-6:01P at times loud. Contrary to log, they are CHR with "AM 1", the all hit AM' slogan, report & tape sent, first in several years. Also I wonder if their allocation has changed to be on that loud that late? ID was Elizabethtown-Hershey. Also logged CHOW-1470 ON on their version of "Tradio", 'The classified of Welland" ending 5:37P into country. MM 11/12 a couple of voice ID's, code ID's and one piece of march music pushed WARU-1600 thru nullable but pesty WWRL around 2:15A Unlike most, I've been to Peru, IN (cousin there) so glad to report it, tape sent as well. No luck with the CO test though, also getting sleepy, not used to those MM's til 3A+. Here's an UNID, M/F anc'rs in French, Radio Canada ID's around 3:30A on 1250, also had 3 stations, one each in EE/FF/SS on 1260. (SS was Miami, no doubt-DWS) Monday 11/19 using the Sony CFSW501 boom box this time, this rx is almost as sensitive and good at nulling as the TRF but makes up for that with digital readout, 7 pre-sets and a built in 5 band equalizer which can have abig effect on distinguishing a talker from a rocker on the same frequency. It's been replaced by the 505, having 10 presets plus a timer that will start recording a station, Bob Smolarek has one. DX highlights included finally hearing WAMS-1380 more than 5 miles away from DE at 5;05P w/ABC news and oldies. Tentative on s/off of WITM-1520 TN in WWKB null at 5;15P, call sounded more like WIGM, announcement mentioned 1000 watts, Christian broadcasting contrary to log. At first, an UNID religious talker on 1330 at 5;20P, urging people to call Rev. James Wade's prayer line at a 215 number. I called and asked what station it might be and got only "why do you want to know" or "listen again same time tomorrow" from him. WASA s/off at 5:43P (mentioning 500 watts night time) as 'Christian Family Radio' led to phone call confirming the Rev. Dr. And WWMD-830 NC w/REL, strong NC accented anc'r 6:06P then gone, late power-pattern change? Lastly, WLIF-1300 (Lite 102) and WMZQ-1390 (98.7 FM) simulcasting, and WHDH-850 w/unmistakeable Boston accented anc'r. That's it, 73's.

MARL V. JETER - 2115 SCARBROUGH ROAD - STONE MOUNTAIN, GA 30088

DX has been picking up a bit lately due in part to the CPC test scehdule which has been getting me in front of the radio at least, even if I haven't been able to hear them all! I was even trying for VT on 1380 (with local WAOK on) and SD on 1490, I didn't hear either one. I have a tenative on WARU-1600 on their 11/12 test, as I heard some distinctive tones between 2-2:30A but no ID's unfortunately, so a tenative report/tape sent to them. Definitely heard was the KSTL-690 test on 11/25 with mucho tones and music and even a few week voice ID's. Probably the best catch of the season so far was WTVB-1590 MT on 11/20 afternoon, I heard mentions of 'Branch Co." and a town of 'quincy' so i clued in and later heard an ad for "shop downtown Coldwater" so that was a nice surprise to say the least! I have been spending some time on the clears to see what's on with the dominant stations nulled. KGHT-880 AR has been pretty regular under WCBS, on 1120 have logged WCGM-TN with KMOX reduced, also WEZR-FL with BRN. They were running

straight ERN with absolutely no local spots, promos or news, only an ID several times an hour. They were last heard as WWOU last year while testing with audio from another station, WFSH-1240! I was curious about hearing WFSH on 1120 so I called and the CE explained that it was WWOU. He never did make good on his promise to forward my WWOU report to them so I'll try again, even though WEBR's address is listed as Shaker Heights, OH! A few veries have been filtering in: WEBN-1540, WLDW-1550-Test, WFLO-870 & WHCU-870, all with letters and the V/S have gone to Wayne (as soon as I get a page-full). JACK WOODS - BOX 1003 - WALDPORT, OR 97394

The KDKA 70th a universary article in #8 remids one of the research project at the University of WV which showed a relationship between troposheric weather and radio signal propagation. For 3 years, researchers at the Morgantown campus continuously recorded the signal strength of KDKA and also weather conditions in the area. They found a close relationship between night-time signal levels and barometric pressure, with higher signals received when a low pressure area was to the north of Morgantown. They found that changes in the signal from KDKA could be used to foecast Morgantown weather 12 to 24 hours ahead. A rising signal after nightfall would indicate an approaching storm while a falling signal would precede fair weather. Only about 5 percent of their predictions were in error. This research was the subject of several articles in the IRE proceedings. One article was 'Weather Forecasting by Radio Signal Intensity' proceedings of the IRE, V18,p533, March 1930. New subject: it has been reported recently in DXN that TP DX is coming back, after a couple of years absence. It looks that way to me also. HI signals have en quite good for about a month. During the morning of 12/1, KIKI-830 was in like a local. Haven't heard AK for several years, but I believe I caught a few words from KYAK with CISL nulled, a couple of nights back. Receiving AK has never been easy in my 5 years here. 73

Where would I be if it wasn't for the radio? Though my wife often expresses her opinion that I'm abnormal, I always answer that perhaps she would prefer that I hang out at the saloon or OTB instead of the attic! The test from KUWA-1290 was not heard, only KHSL and UNID's with CW music and Larry King. Local Alaskan Tidbits: AFRUL-890 is now on from a new site and tower, replacing the 50 year ald mountain top site and inverted V type antenna at Mount Moffett. New site is hear sweeper Cove, perhaps 1000 feet from water and much more accessible. Signal is still 250 watts but coasn't seem to get out as well as from the old site. Still, 200 miles for a 250 watter isn't bad. No local programming except for hourly ID. Relays AFRTS satellite audio, same as what used to be heard on SW. Also same format now heard by troops in Middle East, straight from AFRTS in CA. Back in 77-78, I used to work there while stationed in Adak. Even though KBBI Homer has moved to 890, and is a semilocal here, AFRN does still occasionally squeak in here in KBBI's null. KTYU-910 Galena has some local programming during AM and late PM but repeats about 2/3700 of its fare from KSKO-790. Also repeating is the new KNSA-930, getting it's programming from KDLG-670. KNSA just started up last summer and hopes to eventually do some local programming. Former KENY-980 is now KZXX with Classic Rock, no longer CW and never was news-talk as some sources reported, shifted calls and format in August. KAEN-830 remain silent as does their co-owned KXTZ-FM. Tried to eatch the test from KLER, LATL & KOJM but being stuck in bed with the flu, I didn't make it. Even if I do try for test, and don't receive it, I try to make it a point of dropping a post card to the station to say thanks. It seems to be well received as I have received 2 replies from stations this winter thanking me for trying, and enclosing results of where they were heard. Courtesy seems to pay off at times. Have been noticing that usual-regular until the earthquake KGO-810 is back to normal strength here. I presume they fixed their towers or are they still using temporary facilities? If so, their signal sounds normal. They have always been one of the strongest signals heard here for years. I just retired after 20 years military service in the Coast Guard, so I'm now working part time at local Public Radio KMXT FM with an afternoon shift. It's nice to get some real experience in radio now, and I'm really enjoying it. Trouble is I seem to be even more busy now than I was in the CG! At least I'm not underway on ships anymore sharing my luch with the Bering Sea! See ya later and happy holidays to all!

Dr. Browning said that there would be a 50-50 chance of a major quake here in this 120 mile long New Madrid seismic zone around Dec. 3rd. I would judge from my log sheet that the chances were even greater. In fact, I don't know how we escaped a major quake.

Thirteen tiny local tremors within a 15 mile radius were reported to me in seven days, plus CNN unedited satellite - picked up in California - reported six 1.0 to 1.1 tremors in this seismic zone on Friday, Nov. 30th, for that day alone. None of these were reported to the public here - and I understand none under a 3.0 will be, in order to minimize any panic.

Today I hear that the "non-reporting" level is being raised to 4.0. We do have a local quarry doing almost daily blasting, which could be a good cover, except that they always blast during lunch hour when all employees are out of the quarry. They were not blasting today, Sunday, at 9:30 A.M. when a light jolt knocked off some scrap lumber stored across the rear bumper of my travel trailer radio shack - while I was in it. No information available on it.

As I previously stated, tidal forces only affect my 14 monitored frequencies occasionally, but this combination of tidal forces very obviously affected them greatly, putting marious combinations of pressure and tension on the seven known fault lines within five miles of my location.

A dot on my log sheet indicates a station signal being where it ought to be on my vernier dial. As you can see, most of the 14 frequencies were "off" most of the time, a couple as far as four and five khz. And the changes were often in a rapid "yo-yo" effect, evidently due to relief of forces by all those tiny local tremors.

Times of frequency checks are in $U_* T_*$ so as to coincide with quake records from Golden, CO, and St. Louis University. I made checks as often

as possible, staying up all night one night and getting up on others.

If a quake had occurred "on schedule", several "unorthodox" (but quite effective) possible warning methods would have had an exception chance for funding for further development. Since it did not occur, and since all such funding is at the discretion of the U.S.G.S. and their tightly closed and locked minds, all such chance has evaporated. The public does not know how close they came to a quake and will have to be content with the same virtually useless warnings in terms of decades and Centuries.

P.S. We are still at high risk to a peak again 6n perember 31st, and a lower risk until enother peak on Jamuary 30th And I will be logging it all.
