730 WOHS NC Shelby: station now relays programming from WGNC-1450 Gastonia, NC. Also see 1590 below

800 WPLK FL Palatka: silent station is ON THE AIR

830 KPLS CA Orange: NEW station is ON THE AIR with Spanish language programming

1080 WXLN KY Louisville: station has ended its agreement to rebroadcast WXLN-FM in Eminence, KY and is once again simulcasting with WDJX-FM. We expect to see a call change here.

1220 WAYE AL Birmingham: silent station is ON THE AIR, seems a runaway truck mowed down their tower causing the temporary but extended silence.

1380 KKFH TX Beaumont: station is SILENT (as is their FM, KWIC) in part due to a bitter dispute between owner and former governor Mark White and famous billionaire H. Ross Perot. Look for a reprint from the Houston Cronicle elsewhere in this issue for the complete and amazing story.

1450 WTAL FL Tallahassee: according to a source at the station they are planning to apply for a move to 730 kHz with as much as 50000 watts daytime power, plan includes buying out and cancelling the license of WSTT in Thomasville, GA which has been SILENT for many months.

WCIE NC Spring Lake: station is SILENT

1590 WCSL NC Cherryville: station now relays programming from WGNC-1450 Gastonia, NC along with WOHS-730 Shelby, NC (see 730 kHz above)

WKTP TN Jonesborough: station now operates with 1600 watts daytime and 5000 watts night U3 for a very interesting reason. With the full 5000 watt day power the 5 millivolt signal contour would overlap with that of co-owned WKPT-1400. The FCC prohibited such an overlap in coverage areas for commonly owned stations of the same mode (AM) and the reduced power eliminated this overlap. When the stations had separate owners this wasn't a problem. At night WKTP can run full power since the 1400 kHz contour is reduced in size due to increased interference levels. Interesting.

White takes radio stations off the air

Perot objects to ex-governor's plan to sell off disputed properties

Former Gov. Mark White pulled the plug on his two Beaumont radio stations this week and filed a controversial plan in federal bankruptcy court to sell them to a group of investors

White closed KKFH-AM and KWIC-FM only hours after Beaumont's utility company threatened to cut off the stations' electricity because of \$2,750 in past-due

The FM station, which sent its rock music into Houston from a 2,000-foot Liberty County antenna, went off the air at noon Thursday after playing Riders on the Storm by the Doors. KKFH, a gospel music station, went off the air after its regular 10 p.m. sign-

The stations, purchased by White's Modern World Media in February 1990, were thrown into bankruptcy last fall following a bitter legal dispute between the former governor and Dallas billionaire H. Ross

Though the squabble began because White owed bank fees to Perot, the litigation centered on allegations that White mismanaged the stations.

Earlier this month, a Houston district court judge ordered all of the stock in

Modern World to be turned over to Perot.

Yet bankruptcy court documents filed earlier this week indicate White has signed a contract to sell the stations to an investment roup led by Dallas radio station owner Steve Allison

Allison, who operates a popular Dallas rock radio station, agreed to assume Modern World's debt, pay \$250,000 in cash for immediate expenses, and pay off other Modern World debts owed to Perot and First City Texas-Houston.

Allison is teamed in the deal with Houston real estate investor F. Gardner Parker. White, who has acknowledged that he

The billionaire, who did not know that the proposed sale had been filed in the Beaumont court, said that because of the Houston court order, he did not believe White had the authority to sell the station.

"I had no knowledge any of this was even going on," Perot said. "If you are asking if he (White) can do this, I don't think he can. All I want to do is get my money back."

White on Friday defended the deal. He noted that the Houston court order does not take effect until early

"This doesn't give the creditors a thing," said attorney Joan Kehlhof. "We are going to fight this tooth and nail. We are already preparing the pleadings.

If the plan is approved by the court, Allison said Radio Group will operate the stations under a management agreement until the sale is approved by the Federal Communi-

If that happens, Allison said KKFH immediately will go back on the air with the gospel format.

KWIC equipment will be upgraded and the station will return to the air with a new format, he said.

Since then, KWIC has gone through several different versions of rock and adult contemporary formats. The AM station started out as KJET and since 1981 has also operated under the call letters KTLK, KIEZ. KWIC-AM, KJUS and KKFII with black, talk, easy listening, rock, Christian and gospel formats.

Larkins bemoaned the passing of the AM station. "We were the only full-time gospel station in the area,

Larkins said that right before the station went off the air, one 82-yearwere still in arrears for back pay. She just cried."

3 Piedmont stations merge music, news AM outlets in Gaston, Shelby take advantage of new rule

Two of Gaston County's largest AM radio stations have joined with a longtime Shelby station to broadcast the same programming on all three stations.

WGNC-AM/WCSL-AM began to share up to 18 hours of music and news with WOHS-AM on New Year's morning. The three stations will have just one lineup of DJs and a single advertising sales staff. With the streamlining, two WOHS DJs are now unemployed.

The stations agreed to join forces when Watson Broadcasting. which owns WOHS (730 AM), agreed to sell the time on its station to KTC Broadcasting, the owners of WGNC (1450 AM) and WCSL (1590 AM). The stations would not say how much KTC paid for the time

Although all three stations will continue to carry Charlotte Hornets games, sports is the one type of programming they will not fully

News of the industry, of interest to DX'ers

... Greetings and happy new year to radio heads everywhere! ... The big news in the industry since the start of the new year is the demise of the Birch radio ratings service. The Fall '91 report was Birch's last. Birch leaving the radio ratings game leaves Arbitron alone in that arena. A Birch spokeswoman blamed the shut-down on a bad year economically for radio stations, saying "A lot of stations were unprofitable in '91 and those clients with both Birch and Arbitron-who had to cut one out-were retaining arbitron to cut costs." Added Birch President Bill Livek-"Stations just stopped paying their bills. The economy slowed some payments down and some clients simply stopped honor-ing their contracts. ... here bleak news on the economy for those who can't get enough - 1991 was an extremely tough year for radio. To give an example, here's some information on national spot revenue. All the figures were gathered by Radio business Report from various sources, based on Radio Expenditure Reports data. As of Sept. '91, national spot business in the Top 100 markets was down 1.9%, standing at almost \$775 million. Some market breakdowns between Jan-Sept. '90 and '91 - in the double-digit category, Monterey/Salinas was down 21.9%; San Jose was down 24.3%; El Paso was down 20,6%; Nashville down 11.2%; and the far and away "winner", the Coastal NC region, down 48.5%. Modest gains were posted in some cities, notably Miami/Ft. Lauderdale up 9.6%: kichmond up 9.9%; Harrisburg up 13.7%; and Chicago showing the biggest gain at 17.0% ... Inter-Urban broadcasting, a minority-owned radio chain, filed for Chapter 11 bankruptcy early in Dec. after failing to come to terms with Barclays Business Credit. I-U is disputing Barclays claim that the total now owed on a \$10.5 million loan is \$13.5 million. The bankruptcy filing covers WYLD AM & FA New Orleans; KAT' AM & FM St. Louis; and WIZF Cincinnati. I-U's WIZA Savannah is not included, Current management will contime to operate the group through reorganization ... WJDM 1530 Elizabeth MJ could finally get 24 hour service authorization if the president signs legislation recently passed by Congress. An amendment was tacked onto a bill that restricts telemarketing operations. The rider requires the FCC to find a fulltime frequency for any daytimer licensed to a community with a

population of more than 100,000 with no local fulltimer ... According to the latest Arbitron ratings, here are the top morning drive shows in New York and Los Angeles - in the Big Apple, The Howard Stern Show on WXRK-FM was in the #1 spot, second was Smith. C'Neill & DeAngelis on WINS, John R. Gambling on WOR was third, WRKS-FM had the fouth highest rated morning show with Webb & Fox, and in the fifth slot was the grand old man of the airwaves Don Imus on WFAN. Out in LA. wark & Brian on KLOS had the #1 show. NABC with Kent barkley was second. next was Rick Dees on KIIS AL & FL. KKET's John Loudon was fourth highest. and wark & Kim of KOST brought up the rear ... and a rare thing has happened recently here in the Capital District with an AM station being simulcast on FM. WTRY 980am has recently taken over the 98.3fm frequency vacated by WSHZ-FM. WSHZ, formerly part of "SHQ-FM", a simul-cast with WSHQ-FM in Cobleskill, recently went dark due to financial problems. WTRY is now renting the FM frequency, making WTRY "AM & FM 98," It's nice that an AM station is being simulcast on FM. instead of the other way around. Unfortunately, WTRY has altered it's sound as a result of the action, now sounding more like an FM oldies outlet than a fullservice AM oldies station, as it used to be. Top of the hour network news has been done away with, for instance. and some new jingles have been added with some old ones being benched. As a result, it just doesn't sound like the old "Great 98." Kind of sad....
