

"Like many inspired inventions, the creation of this magic company was accidental," wrote the *New Yorker* in 1973. "The time was 1946 and the place the Boston radio station WHDH. Bob had a morning record show and Ray gave the hourly news reports. In the manner of Sissle and Blake, Gilbert and Sullivan, Laurel and Hardy, and Ellington and Strayhorn, they discovered almost immediately that they had a telepathic bond." Proceeding to NBC, New York, in 1951, they quickly convulsed the rest of the country as well, and they have been present on the airwaves, in one form or another, ever since. They can currently be heard on "The Bob and Ray Show" over National Public Radio stations.

Bob and Ray's achievements also include a hit Broadway show, Bob and Ray: The Two and Only; many award-winning commercials, including those starring the famous Piel brothers, Bert and Harry; the movies Cold Turkey (in which they played, successively, Walter Cronkite, David Brinkley, and Arthur Godfrey) and Author! Author!; and specials and appearances on every major television network and cable. In 1981, Bob and Ray were inducted into the National Broadcasters Hall of Fame, and that same year were named "Men of the Year" by the Broadcast Pioneers. In 1982, the Museum of Broadcasting in New York presented a retrospective of their work that was held over for four months and broke all attendance records.



Foreword

BY ANDREW A. ROONEY

Bob and Ray have three distinct personalities. There's Bob's, there's Ray's and there's Bob and Ray's. Both Bob and Ray are interesting to meet separately because two duller people you never talked to. Every Sunday morning I meet funnier people down at the news store when I go out to get the paper.

If you run into Bob and Ray together, it's a different matter. Over a year's time they must give away a million dollars worth of comedy material free to people they meet on the street.

Several years ago, I met them in New York after not having seen them for a long time. We said "hello" all the way around, but that was the end of any normal conversation.

"You still writing the Phil Rizzuto Show?" Ray asked, referring to a workaday sports talk show conducted by the former Yankee shortstop.

I laughed, but before I could think of any clever response, Bob stepped in.

"We don't get a chance to hear it much," he said.

"No, it comes at a bad time for us, Andy," Bob added. "What time is it on?"

"We hear you're doing a good job, though," Ray said.

"Yeah, everybody's talking about it."

I still hadn't gotten a word in when Ray finished the conversation.

"I'll bet the Scooter's a prince to work for, isn't he?"

"Great to see you, Andy. Keep up the good work," and they walked off.

The next time I saw them, they spotted me from across the street. Ray doubled over, pointed at me and started laughing. Ray is usually the instigator. Bob saw me. He pointed, doubled over and started laughing. They laughed for perhaps thirty seconds, then they straightened up and walked off down the street. It was the beginning and end of our meeting.

It was absolutely as meaningful as most street meetings, but for me a great deal more memorable.

If you bend double and laugh at the humor in situation comedies on television, you've just bought the wrong book. You're going to hate this one and if it isn't too late, take it back.

You'd be wrong if you did, though. I laugh out loud reading it. I look around for someone to read parts of it to. I find myself wondering why I'm laughing out loud, because laughing is something you normally do as a signal to someone else that you think a remark or a situation is funny. If I laugh alone over this book, who am I signaling? I think I'm trying to let Bob and Ray know how deeply they're appreciated by me. Their humor is so special, I'm afraid they'll think they're alone in the world with it.

Fortunately there are a lot of people who think, as I do, that they appreciate Bob and Ray more than anyone else does.

G. K. Chesterton said that not much art is produced by anyone who talks a lot about art. Not much humor is produced by anyone who talks a lot about what's funny, either. I've known Bob and Ray for twenty years, although I haven't seen them twenty times, and I've never heard them talk about humor. They just are funny. All the characters in their sketches are absolutely serious. The characters never let you know they think there's anything funny about what they're saying. Bob and Ray's humor isn't like a joke that depends on remem-

bering the last line. Their sketches are just as funny in the middle as they are at the end.

I'm puzzled about what's funny and why some of us think one thing is funny and others don't. The question we don't seem able to resolve is whether things like humor, beauty, art or even broccoli strike us all the same or not. Does the difference lie in the way we respond to them, or in the way they strike us? If you eat all the broccoli on your plate and I leave all of mine, there's no way for either of us to know for sure whether it's because broccoli tastes different to you than it does to me, or because it tastes exactly the same but you like the taste and I don't. That's the way it is with humor but, unlike broccoli, I've never heard of anyone who ever listened to them who didn't like Bob and Ray.

Most of these sketches were originally done by Bob and Ray on radio. It's interesting to see how readily their spoken words adapt to the printed page. Nothing is lost and if you've ever heard them at all, you can hear every inflection in their voices as you read these words they spoke.

He's at Sturdley House out there. It's a great tourist attraction, we're told, so . . . come in please, Wally Ballou . . .

BALLOU

—ly Ballou at "Driftwood," the stately old mansion where Fabian Sturdley was born, and I'm talking with his grandson, Van Tassel Sturdley, who manages this museum.

STURDLEY

Thanks, Mr. Ballou.

BALLOU

Is it true that the house has been restored to the original run-down condition it was in old Mr. Sturdlev's time?

STURDLEY

Yes. They were going to tear down this grand old saltbox to make way for a combination car wash and bowling alley, but a group of public-spirited relatives banded together and have managed to save it, and have it declared a public shrine—with no taxes to pay!

BALLOU

Now, I know, of course, about Fabian Sturdley, but there may be some—especially children—who don't. Could you tell us something about your grandfather?

STURDLEY

BALLOU

And it was in this very room that he held his famous meeting with Henry Ford in 1899.

STURDLEY

Mr. Ford came all the way out from Detroit to offer half interest in his company for ten thousand dollars. Of course, Grandpa realized that the automobile would never be more than a plaything for the wealthy . . . and he turned the offer down.

BALLOU

I was noticing a couple of other things visitors will see when they come here to fabulous Sturdley House . . . Here's a pillow that says, "Greetings from San Juan Hill."

STURDLEY

Yes, it's filled with balsam needles. It smelled nice for a while.

BALLOU

. . . An ash tray from Franconia Notch, New Hampshire . . . And what's the significance of that hole in the wall with a frame around it?

STURDLEY

That was when Grandfather shot at a traveling tinker and missed. He was moody that day because the bottom had fallen out of puttees. And there was a tight money situation, too.

BALLOU

Now, there's a kitchen out that way . . . and through this door a small den. I can see a pile of *National Geographics* and a picture of a blank Mount Rushmore. Not many of those around, I bet.

STURDLEY

It's a rare, valuable possession, yes.

BALLOU

Upstairs, there are two bedrooms and a bath.

STURDLEY

Yes, but they're roped off with a red velvet rope. That's where we live.

BALLOU

Do visitors get to see the attic?

STURDLEY

Yes. There are more Geographics up there—and about eleven cartons of puttees.

BALLOU

How about the basement?

STURDLEY

Down there they'll see our cat . . . and our trash cans . . . and several hundred cartons of puttees.

BALLOU

And outside, there's a small parking area.

STURDLEY

They can park on the street, too, as long as they don't block the Henshaws' driveway next door. The Henshaws don't like that!

BALLOU

Well, I'd like to thank you . . .

STURDLEY

Let me say that a visit to Sturdley House should be a must in anyone's vacation plans. We're open from nine to five. Admission is five dollars for adults, two dollars for children, and eighty-five cents for pets.

BALLOU

And if one were planning to stop here . . . how much time should they set aside to be sure to see everything?

STURDLEY

Including the vegetable garden out back?

BALLOU

Yes, and allowing about fifteen or twenty seconds to look at the bullet hole.

STURDLEY

I'd say . . . about . . . four and a half minutes.

BALLOU

Okay then, and thank you, Van Tassel Sturdley, grandson of Fabian Sturdley. Incidentally, when did he pass on?

STURDLEY

Grandpa?

BALLOU

Yes.

STURDLEY

Who said he died? He's downtown—getting a haircut!

BALLOU

Wally Ballou, then, at Sturdley House in Kenosha, Wisconsin, returning it to Bob and Ray!

(Theme up briefly and then fade for)

As our action begins, Miss Agatha is staring thoughtfully out the music room window. Suddenly, she turns and speaks . . .

AGATHA

There's a strange car stopping out in front, Rodney.

RODNEY

I wouldn't exactly call it strange, Mother. Of course, I never cared for rally stripes on a Rolls-Royce myself. However...

AGATHA

Oh, my word, Rodney! I don't mean strange in that sense. I just never saw it before. And now, a strange man is getting out.

RODNEY

I agree, Mother. He is an odd-looking duck. Ears set too low . . .

AGATHA

Oh, Rodney—you're such a wimp. You never understand a word I say to you.

(Doorbell)

RODNEY (Calls off)

Come in. It's open.

(Door opens and closes. Then a long period of footsteps)

RODNEY (Calls off)

Over here—in the music room.

(More footsteps. Then door opens and closes. Then more footsteps)

RODNEY (Calls off)

Back here—in the conversation pit behind the Wurlitzer.

(Another long period of footsteps)

MAN

Quite a place you've got here.

RODNEY

Thank you. We like it. We have forty-six thousand, two hundred square feet here in the main house. Then, the twins live over in the annex, which has...

AGATHA

Oh, shut up, Rodney. Whoever this man is, I'm sure he doesn't want to hear you recite a lot of boring figures.

RODNEY

You're quite right, Mother. Perhaps introductions would be more in order. I'm the wealthy but spineless young executive, Rodney Murchfield. And this is my dowager mother, Agatha.

MAN

Pleased to meet you, Miss Agatha. I've been looking forward to this moment. You see, I'm your long-lost elder son, Skippy.

(Organ: musical sting)

RODNEY

I'm afraid there's been some mistake, you sleazy impostor. I'm an only child and sole heir to the Murchfield billions. Mother, tell him you never had another son.

AGATHA

Well, I'm just trying to remember. That would have been about thirty years ago. And there were so many events going on at the country club then that it's hard to keep track of everything.

RODNEY

But, Mother—he's obvously feeding you a cock-and-bull story.

MAN

It's no cock-and-bull story, pal. I've got proof. Look! Here's a picture of me when I was four, and Mom took me to see Santa Claus at Gucci's.

RODNEY

What does this prove? There's no one in the picture but you and Santa Claus.

MAN

Well, of course not. A guy wouldn't want his mother in the picture when he was talking to Santa Claus.

RODNEY

Apparently you take me for a complete fool.

MAN

Yeah-more or less.

RODNEY

Well, I'm onto your little game. You fortune hunters are all alike. You learn how my Grandpa Murchfield was exploring for oil in this land in 1912 when he struck lead. It proved to be the Mother Lode—a rich vein of drab, gray metal stretching as far as the eye could see.

AGATHA

Oh, knock it off, Rodney. You always tell that story as if you had something to do with it.

RODNEY

Sorry, Mother. I guess I get carried away with family pride. After all, he was my grandfather.

MAN

Well, he was mine too. I remember he used to take me on his knee and say, "Skippy, someday it'll be your job to get the lead out."

RODNEY

He couldn't have said that to you. He died before you were born.

MAN

Oh, really? Well, maybe I heard it someplace else then.

RODNEY

Besides, no one in this family would ever have a name like Skippy.

AGATHA

Well, maybe that's just a nickname. His real name could be something more socially acceptable—like Caldwell or E. W.

RODNEY

Mother, believe me—this man's a fraud.

MAN

Caldwell sounds okay to me. Yep. No doubt about it. That's who I am—Caldwell Murchfield.

RODNEY

See, Mother? You're playing right into his hands.

AGATHA

No. I don't think so. I always liked the name Caldwell. But no one outside the family could have known that. It's good to have you home, Caldwell. Now come along and meet the others.

RODNEY

I wish you'd reconsider all this.

MAN

Oh, I already know part of the family, Mom. Like for instance Rodney's ravishingly beautiful wife, Jennifer. I know her well. Yes indeed. I know her real well! (Evil chuckle)

(Organ: sting)

вов

Will this unknown man in the ready-to-wear suit be accepted as a Murchfield without any further questions? Can Jennifer provide some of the missing answers? And what about the butler who failed to answer the door when the stranger arrived? Perhaps we'll learn more next time when we hear Agatha say . . .

AGATHA

No. I didn't write you out of my will, Rodney. You were never in it.

вов

That's next time when we resume our story of decadence as it unfolds on Garish Summit.

(Organ: theme up briefly and then out)

Hard Luck Stories

(Organ: sad background theme)

RAY

Again today our scouts have been searching the railroad and bus stations for victims of misfortune. We've found that you listeners enjoy hearing these pathetic people tell their tragic stories. And of course, we all get a warm feeling when our generous Bob and Ray organization steps forward with its lovely gifts to solve each and every problem. So Bob—let's start the fun with that sad specimen there beside you.

вов

Sure thing, Ray. This is Mr. Morton Boatwright of Kansas City, Missouri. And according to your card, Mr. Boatwright—you became stranded in New York while you were attempting to begin a voyage to a virtually unexplored area of central Africa. I'm sure there must be quite a story that goes with that.

BOATWRIGHT

Well, no—at least not originally. I was just going to Africa because you can't buy a giraffe in Kansas City. But then, the tramp steamer I was planning to take from New York to the Ivory Coast left without me. And I've run out of money waiting around here for some other form of transportation. So I guess it has gotten to be quite an interesting story by now.

ВОВ

Yes. And I imagine it might become even more fascinating if we knew why you need a giraffe so badly.

BOATWRIGHT

Well, that's easy enough to explain. You see, I don't live right in Kansas City. I live in a suburb about twenty miles out of town. It's like most of your upper-middle-class suburbs where the neighbors all try to keep up with each other. One of them gets a new car—and then the rest of us have to. Next, one gets a boat—and then everybody else does. So I had to think of something that would really make the rest of them look shabby.

Like buying a giraffe, you mean.

BOATWRIGHT

That's right. It seemed like the ideal way to flaunt my wealth. A giraffe owner doesn't even have to mention that he's got a new giraffe. You just put him in the front yard and act casual about it, while the neighbors turn green with envy.

ВОВ

Well, it seems like a diabolical idea all right, Mr. Boatwright. But if you're only looking for a new way to flaunt your wealth—how do you happen to be appearing on our show as a hardship case?

BOATWRIGHT

Well, I do impersonations of famous military commanders in history. Quite a number of them became my heroes while I was at West Point. And I've worked up a little act built around my impressions.

ROISTER

Okay. That sounds like good clean entertainment. So the stage is all yours, Major Bertram Pudgeman.

PUDGEMAN

Well, first, here's my impression of a great favorite of mine—and I'm sure he's yours, too—General Mark Clark. (Shouts) To the rear, march . . . To the right flank, march . . . Forward, march. (Lowers voice) And that's all of him.

FLECKNOY

I'm afraid you'll have to wait a moment. I'm still buttoning my pharmaceutical smock to begin work.

ASHFORD

Very well. But I'm sure I don't need to tell you—it's rather urgent. (Sound: Running footsteps approaching)

FAPP

Hey, Mr. Ashford! What a break finding you here! Remember me? Eddie Fapp, cub reporter for the old *Hollywood Evening Graphic*.

ASHFORD

No. I don't remember you. And what's more, I have nothing to say to the press about the status of my on-again-off-again marriage to the lovely Brenda Hume.

FLECKNOY

Okay. I can fill your prescription now, Mr. Ashford.

ASHFORD

Just say I'll always remember Brenda as she was when I first picked her out of the back row of a chorus line and made her my wife.

FAPP

Oh, that's a great quote, Mr. Ashford. You know, getting this scoop could be a big turning point for me at the *Evening Graphic*. I sure hope so. Trying to support my chronically ill mother on a salary of only forty-two dollars a week has been rough.

ASHFORD

Well, I'm afraid I have nothing to say that would make a headline, son. Naturally, I miss Brenda desperately. But as the idol of the nation's women, I don't suppose I'll ever be lonely.

FAPP

The doctors say an operation might help Mom. But they don't promise anything. And on my salary, it's out of the question anyway.

ASHFORD

Even so, I'll probably dispose of the big house up in the hills. Eighteen rooms is too much for a man alone to look after.

FLECKNOY

If you've lost the prescription, I can call the doctor and get it again. That's one of the humanitarian things I often do.

ASHFORD

And, of course, every one of those rooms shall forever remain filled with memories of Brenda.

FAPP

Mom fell on the ice and broke her hip about five years ago. That was the start of the whole thing. Being bedridden just seems to leave a person open to all kinds of infection.

ASHFORD

I imagine I'll spend more time at the cottage in Palm Springs now. I've neglected my golfing because Brenda never liked the game.

FAPP

Just lying in bed that long weakens the lungs. And now Mom seems to look a litle worse every night when I come home from the office.

ASHFORD

I've neglected so many things because Brenda didn't like them. All I cared about was pleasing Brenda.

FAPP

I think I'd give the operation a try even if the doctors can't promise anything. But on forty-two dollars a week, it's out of the question.

ASHFORD

You'd think that would mean something to her, wouldn't you?

FAPP

Oh, it would mean the world to her. But I just can't swing it.

ASHFORD

Yes. I guess that's become the story of my life now—I just can't swing it.

FLECKNOY

I'm afraid I'll have to fill somebody else's prescription first if you won't give me yours.

ASHFORD

That's quite all right. You can take this gentleman ahead of me.

FAPP

Biff Burns's Sports

BURNS

Greetings and the warmest of felicitations to you, sports fans. This is Biff Burns emanating from mikeside here in the Biff Burns Sports Room. In the moments that lie directly ahead, we shall be scrutinizing all the highlights and sidelights from the world of sports. In addition, we'll be chatting with one of the truly dominant figures in sports, Edgar Bamhorst. And Edgar—suppose we begin with a most penetrating question: What have you ever done to become a truly dominant figure in sports?

BARNHORST

Well, it's really not what I've done so far, Biff. It's what I'm about to do. I'm going to end all the legal fights over contracts and salaries that professional athletes have been getting into lately with the team owners.

BURNS

Well, I'm sure that such an achievement would indeed be hailed by all the leaders of the sporting fratemity, including myself. But how do you propose to keep sports stars from getting into contract disputes with team management, Edgar?

You see, I plan to change the rules for all sports so they'll be a lot easier to play. Then, athletes won't have the nerve to demand so much money because they'll know they're not doing anything very difficult.

BURNS

Well, that may or may not be an ingenious idea, Edgar. It all depends upon what you're talking about when you infer that sports will be easier to play under your proposed rules.

BARNHORST

Well, I think basketball is a good example of what I'm talking about, Biff. Right now, you've got young guys just out of school squabbling with management over million-dollar contracts. And the only reason they're able to ask for that kind of money is because they're seven feet tall—but they're still graceful and able to move around well.

BURNS

Well, with all due respect, Edgar, I don't see how you propose to make a young man more clumsy if he has a natural tendency to be graceful.

BARNHORST

Well, I think you'll see that's now what I'm proposing to do if you'll

(Establish and under for documentary type theme. Organ)

MR. D. D.

I am the city's district defender. It's my job to defend the weak and the helpless as they come into daily contact with the parasites of society that lurk all around us. Any decent person could easily fall victim to the con man—the grifter—the hoaxster. All I can do is stand ready to wage war against evil from my office high atop the old Van Brewster Building. It was there that my latest heartbreaking case began . . .

(Organ: out)

LADY

Now wait a minute, Harold. Don't go trotting around like a chicken

with its head cut off. I'll bet maybe this nice-looking young man could help us.

MR. D. D.

I'm sure I could, dear lady. You and this man—whom I judge to be your husband—look like natural targets of the con man—the grifter—the hoaxster. Please sit down and tell me all about it.

MAN

Well, I really don't know whether we ought to take up your time. As I was telling Martha on the way down here—there are some winners in life and some born losers. So maybe we ought to just write off this whole thing and forget it.

MR. D. D.

Well, I can appreciate how you feel, sir. Nobody likes to admit that he's been a gullible fool. But as the district defender, I'm here to help. So just tell us your story from the beginning.

LADY

Well, Harold's been a gullible fool, Mr. District Defender.

MR. D. D.

LADY

LADY

LADY

FLINGER

Yes—except on the lines where Old Man Van Cortlant had provided the railroad ties. The wood in most of them was infested with termites. So that caused the locomotives to tip over before they had a chance to tie this country together into one great nation.

RAY

I see. But of course, Wainbridge Van Cortlant wasn't responsible for any of that.

FLINGER

Oh, no. That swindle of his grandfather's happened long before his time. About the worst thing Wainbridge ever did was ride down Wall Street during the Depression on one of his polo ponies. Several former stockbrokers were kicked as they stood on the sidewalk trying to sell apples. But later, Wainbridge gave them each a dollar to show that it was nothing personal.

RAY

Well, it sounds as if he was a decent sort of a fellow that any young girl might have worshiped from afar. But where is he now?

FLINGER

Well, Wainbridge lost everything during the war, Ray. He'd invested the family fortune in buying a South Pacific island. But the Japanese managed to sink it some way. RAY

FLINGER

RAY

Well, that's interesting. Where is Tumbleweed now?

FLINGER

RAY

FLINGER

вов

(Theme up briefly and then fade for)

BOB

As our action begins, strong-willed Agatha Murchfield is in the solarium, awaiting the arrival of her lawyer, Bodin Pardew.

(Door opens and closes. Then footsteps)

AGATHA

Is that you, Bodin?

PARDEW

Yes. I seem to be somewhere in the entry hall, Agatha. Can you talk me in from here?

AGATHA

Just hang a right through the music room and then cut across the west edge of the library until you get to the solarium. You can't miss it.

PARDEW

Very well. I'm on my way.

(About ten seconds of footsteps. The door opens and closes. Then more prolonged footsteps. Then another door opens and closes)

AGATHA

Ah, there you are, Bodin. It's been ages.

PARDEW

Yes it has, Agatha. But that's only because the carpet cleaners had the library blocked, and I had to double clear back through the dining room . . . I must say you're looking well, except that you seem drawn and haggard—as if you haven't slept in days.

AGATHA

Well, I have something preying on my mind that I need your help with, Bodin. A man has turned up here in Garish Summit who claims to be my long-lost elder son, Caldwell.

PARDEW

That's shocking, Agatha. We've known each other for forty years, and I always thought your weak-willed son, Rodney, was an only child.

AGATHA

Well, I thought so, too. That's the strange part I don't understand.

PARDEW

Well, you're a fabulously rich widow who's inherited the world's largest chain of lead mines. The man's probably a fortune hunter.

AGATHA

No. I've encountered those before. But this chap definitely claims to be the son I never knew I had. So, of course, it's just his word against mine.

PARDEW

Well, I'm not sure that's the case. But how can I be of help?

AGATHA

PARDEW

I suppose I could, if you like. The back of this envelope is blank, so all I need is a point on my pencil. Is there a sharpener around anywhere, Agatha?

AGATHA

Over there under the window by the tumbling mat.

PARDEW

Thank you. I'll be back in a jiffy.

(Prolonged footsteps, then the grinding of a pencil sharpener. A pause. Then more grinding of the sharpener)

AGATHA

My stars, Bodin! What are you doing over there?

PARDEW

It's all right, Agatha. Everything's being taken care of.
(More pencil sharpening. Then footsteps)

PARDEW

There, now. Shall we begin?

AGATHA

Well, first, I want to find out whether a birth certificate was ever issued for a Caldwell Murchfield. Then . . .

PARDEW

Just a minute. (Mumbles to himself) She-wants-me-to-find-out . . .

AGATHA

My word! How did a nincompoop like you ever get to be my attorney?

PARDEW

I don't know, Agatha. I suppose I could look in the files at my office and see if I have any documents covering that.

AGATHA

No. Don't waste any more time. Just find out if this mysterious stranger is really my eldest son. If he is, I'll want to rewrite my will to exclude my other boy, Rodney.

PARDEW

I understand. Incidentally, about this young man who calls himself Caldwell Murchfield. Where is he now?

AGATHA

Rodney took him moose hunting. Caldwell had wanted to go to the bank and rummage through my safe deposit box. But Rodney insisted they go hunting first.

PARDEW

Were both young men carrying shotguns when they left here, Agatha?

AGATHA

No. I remember that part distinctly because it struck me as strange. Rodney had a gun, but he told Caldwell just to carry a shovel.

PARDEW

Agatha, I think this has the makings of a dangerous situation.

AGATHA

Well, I told them that before they left. You can't bring down a moose with a shovel. But Rodney said not to worry. He said there's no space in the trophy room for another stuffed animal, anyway!

PARDEW

I'm afraid this is no longer a case for a lawyer. I'm going to call the police.

(Musical stinger)

AGATHA

Well, I guess the police couldn't botch things up any worse than you always do. But will they hunt for those old birth records I need?

PARDEW

A more urgent matter is involved here, Agatha. To put it as delicately as possible—one of your sons may have slaughtered the other.

(Theme. Establish and under for)

RAY

Must Agatha now face the loss of a son that she had assumed was lost all along? Can Caldwell be a murder victim if birth records show that he never existed? And what about the blank envelope that Bodin Pardew mysteriously found in his pocket? Perhaps we'll learn more next time when we hear Rodney Murchfield say . . .

RODNEY

I know it's only a raccoon. But I thought pasting these homs on its head might make it seem like more.

RAY

That's next time when we resume our story of wealth and intrigue on Garish Summit.

(Theme up briefly and then out)

Buddy Blodgett at the Polygon Ballroom

RAY

Now we've come up to music time here on the old Bob and Ray Show. So for your afternoon listening pleasure, let's swing out to the Polygon Ballroom in Larchmont for the haunting melodies of Herbie Waitkus and his orchestra.

(Finish of Glenn Miller's "In the Mood")
(Applause)

BLODGETT (Jovial)

Yes, indeed—indeed. This is Buddy Blodgett speaking to you from the old Polygon Ballroom in Larchmont, where dozens of sailors on leave have gathered to dance with the local girls and listen to the music of Herbie Waitkus and his orchestra. Now, I see that Herbie is again raising his baton. So here's another foot-tapping tune played in the distinctive Herbie Waitkus style.

(A few bars of Tijuana Brass) (Applause)

BLODGETT

Indeed—indeed. Herbie Waitkus and his fine orchestra with another of those short renditions that are so familiar in dime-a-dance joints like the Polygon Ballroom. And now, as the boys in the band take a short break, we're moving across the dance floor with our equipment to chat with the maestro. Greetings and welcome to our Bob and Ray microphone.

WAITKUS (Very suspicious)

Who are you and what do you want?

BLODGETT

I'm Buddy Blodgett. And we're beaming the haunting melodies of your orchestra out across the air lanes to our Bob and Ray audience.

WAITKUS

Well, I sure wasn't told about this. So I'd suggest you pack up your junk and get out of here.

BLODGETT

Well, I'm sorry, Herbie. But this pickup has been cleared with the management of the old Polygon Ballroom here in downtown Larchmont. And I'm certainly not going to leave after we've paid to have our lines run in here.

WAITKUS

Well, then get over to the other side of the room someplace where you won't be under my feet. Okay?

BLODGETT

Well, I certainly don't think our Bob and Ray microphone will be in your way. And I'd just like to talk a little bit about your group's distinctive style before . . .

Indeed—indeed. The melodic "Holiday for Strings" rendered by Herbie Waitkus and his orchestra. And now, as we move back to the bandstand to resume our chat with the maestro, I have just one question that comes to mind, Herbie.

WAITKUS

Are you still here? I thought I told you to stay clear over to the other side of the room

BLODGETT

Well, I just had one quick final question that came to mind, Herbie. How is your group able to get that big band sound into a song like "Holiday for Strings" when all you have is a piano player and a drummer and yourself on the oboe?

WAITKUS

It's not an oboe. It's a bassoon. And in addition to that—mind your own business.

BLODGETT

Well, I didn't mean to pry. But it just occurs to me that you began this medley with a number featuring a lot of saxophones. And then you

went into one requiring a big brass section. And now you've done "Holiday for Strings." But all you have up here is a pianist and a drummer and yourself on the oboe.

(A Xavier Cugat number)

BLODGETT

Now, our time is up. So amid the strains of another toe-tapping number played in the Herbie Waitkus style, this is Buddy Blodgett bidding you a fond farewell—and returning you to our New York studios.

(A few more beats of music, then sharp cutoff)

Special Report

вов

We now take you live to London. An American TV reporter has pitched camp on the lawn of Buckingham Palace and vows to stay until Prince Charles comes out and grants him an exclusive interview. This determined newsman is Rex Grippner of WVTV-TV in Baraboo, Wisconsin.

GRIPPNER

Now hold it a second! (Shouting through bullhorn): I know you're in there, Charlie! And the longer you hold out, the longer I'm gonna be.

вов

Was that the Prince of Wales you were shouting at?

GRIPPNER

Yeah. I thought I saw him peeking out through the drapes. But it may have been just a liveried footman or some other flunky.

BOB

You feel you have the right to yell threats at the Prince that way?

GRIPPNER

Look: He's kept me waiting five days for an interview. And I've got better things to do. There's a big cattle show in Belgium this week for one thing.

BOB

Put it this way. Why should the Crown Prince grant an exclusive interview to a reporter from Baraboo, Wisconsin?

GRIPPNER

Because he's big news. It's not just a local story when a prince gets married and goes on his honeymoon. People back home want to hear all the spicy details, too.

вов

And Prince Charles should come out here on the castle lawn and tell you all the intimate plans for his marriage and honeymoon?

GRIPPNER

If he didn't want the publicity that goes with the job, he never should have taken up princing! (Picks up bullhorn and shouts) I'm warning you, Chuck! I can wait this thing out as long as you can!

вов

Was he peeking again?

GRIPPNER

No. I thought I saw him through that next window, stepping into the shower. But I guess it was just some woman.

BOB

Well, Mr. Grippner, I'm appalled that you don't think the royal family has any right to privacy.

GRIPPNER

I never said that. I'm not even sure that woman in the shower is a member of the royal family.

вов

I'm talking about Prince Charles's marriage. He doesn't have to come out here and discuss it with you just because you're a news reporter.

GRIPPNER

Listen, Mac. That young fella visited the White House a couple of weeks ago. And it was the farmers in Baraboo, Wisconsin, who donated a thirty-four-pound turkey for his formal banquet. He owes us one for that!

вов

Well, that may seem like a valid point but . . .

GRIPPNER (On bullhorn)

I'm giving you just one more day to come out, Chuckie Baby. Then I'm coming in after you.

вов

Prince Charles held a news conference the day he announced his engagement. Why didn't you ask him your questions then?

GRIPPNER

I couldn't be here that day. I was too busy—back in the States—camping in the yard of one of the hostages from Iran. And he wouldn't come out and talk to me, either!

вов

Well at least your luck is consistent! Now, from Buckingham Palace . . . it's back to our main studio.

GRIPPNER (On bullhorn)

Okay, Charlie . . . this is it!

RAY

DEXTER

Yes. They are the world's largest living lizard and a ferocious carnivore. One swipe of the Komodo dragon's tail can render an enemy senseless.

RAY

Doctor . . . I believe we've just about exhausted the subject. I want to

thank you for coming here from Upper Montclair. I know it was a great hardship for you to get here today. Do you have a ride home?

DEXTER

No, I don't.

RAY

Well, maybe somebody from the audience will give you a ride home after the show. I know we all know a great deal more now about the Komodo dragon than we did a few moments ago.

ВОВ

BOB

Well, that's very kind of you, sir. But now, what about your editorial rebuttal?

BODENHAMER

(Sound: Footsteps and door slam)

ВОВ

(Sound: Dog bark)

вов

вов

(Theme up briefly and then out)

Public Service Announcement: Elephant Keepers

вов

We're happy to devote the next few seconds to an important public service announcement.

RAY

It's a message from the elephant keepers at the Bronx Zoo here in New York, and we're happy to cooperate. It's been brought to the attention of these keepers that certain citizens have been exploiting their elephants.

вов

You know, these elephants are supported at the zoo for the edification of the taxpayers of New York City—as well as guests from out of town.

RAY

And the officials of the Zoological Society take a dim view of certain promotion-minded characters who have been painting advertising


slogans on these elephants. For example: "Subscribe to the Casserly Memory Course and remember like me!"

(Noticing half of the moustache is missing)

вов

Will you tell us how it happened, Martin?

LESOEUR

You mean my dapper little trademark?

вов

Yes.

LESOEUR

Well, I just wasn't thinking when I shaved this morning . . . and half the trademark went on the floor.

вов

I might add that Martin has agreed very generously to go through with this performance. But he has canceled all other engagements till it grows back. We're very grateful to him.

LESOEUR

My doctor tells me it will grow back in about three or four weeks.

BOB

Martin, everyone here is waiting, of course, for some of those stories that you're famous for, and only you can tell, and which we all remember and love. Could we have one of them now?

LESOEUR

Sure, Bob. As you know, when I first started in this business I was a cub reporter for the old St. Paul Ledger, Dispatch, Eagle Tribune, Courier Citizen, Beacon Journal, Plain Dealer, Deseret News and Daily Item.

ВОВ

That was a famous merger, wasn't it?

LESOEUR

Yes.

BOB

I remember reading about that when I was at Yale.

LESOEUR

I was in the city room one day and I heard the phone ring. I heard the editor talking . . . Seems that there was a man hanging from a ledge on the fifteenth floor of the Vaseline Building on Sixteenth and Walnut. So I said to the editor, can I go over there and cover that story.

ВОВ

That would be a big break for you as a newspaperman.

LESOEUR

Oh, I don't know. So he says, sure . . . take public transportation and go on over there.

BOB

What was that?

LESOEUR

Trolley car. So I get over there about twenty minutes later and he's still hanging there. There's a crowd of people, policemen, firemen with their nets. So I asked if anybody had tried to use any humor on this fella. Tell him a few jokes, get his mind off his problem, talk him in.

BOB

Were you known at that time for having a sense of humor?

LESOEUR

Not particularly. So I asked if they would mind if I tried. So they said go right ahead. So I go over to the building and there was no elevator.

вов

LESOEUR

BOB

вов

Martin, maybe that will come back to you later in the program. I remember when you were here not too long ago, you told us a great story about fishing off the Grand Banks.

LESOEUR

Oh, my, yes. I was doing a fifteen-hundred-word article for a magazine on fishing in the North Atlantic.

вов

That is a cold, rigorous, tough life, isn't it?

LESOEUR

It's not for me. It was in the middle of November, we were on a fishing smack, the *Rita B.*, up off the Grand Banks of Nova Scotia. And they're pulling in all this cod, mackerel, haddock, and halibut, and everything . . . and I look over here to the starboard and I see a submarine surface with a foreign insignia on it.

вов

Was this wartime?

LESOEUR

No, no. So I turned to the captain . . . and "Captain," I said . . . (LeSoeur points to his left and again can't remember the finish to the story. He looks to his right and points as if to remember the first story . . . then back to the captain. Bob glances at his watch. Long pause)

BOB

ВОВ

Good.

LESOEUR

вов

Okay! Good! Now—What is the story that leads up to that ending? (LeSoeur looks blank. Fiddles with the paper. Long pause)

вов

RAY

And now, through the courtesy of the Ashenfelter Whip Socket Company, we take you back to . . .

вов (Echo chamber)

April ninth, 1872! Harlan Spivey, Junior, invents the safety pin. Bob and Ray was there.

(Sound: door shut)

мом

My stars, Junior. What have you been doing down in that basement workshop of yours? It seems as though you've been there for hours.

SPIVEY

Actually, it's been longer than that, Mother. This is the first time I've come up from the basement in eight months. I was determined to stay

down there until I thought of a successful invention. Then I can make enough money to get an apartment of my own.

MOM

An apartment of your own? My word, Junior. I don't know what gets into young people's heads these days. Why would you want to run away from home?

SPIVEY

Well, I don't look upon it as running away from home, Mother. I'm forty-three years old. I've just never been financially able to make it on my own before now. But look what I've invented to change all that.

MOM

Well, it's a cute little thing. But what in the world does it do? It just looks like an oval-shaped piece of metal wire with a spring at one end.

SPIVEY

Well, it only looks that way when it's closed, Mother. But see what happens when I press against the side of the metal wire. The clasp opens and a pointy end pops out over here.

MOM

Yes. I see it does. Un-huh . . . You know, Junior—it's foolish things like this you do that have made me keep you here at home all these years. I can't imagine who'd want a piece of bent wire that has one pointy end fitting inside a metal clasp.

SPIVEY

Aw, for Pete's sake, Mother. I don't know why you have to belittle everything I invent. It's no wonder I've never built up enough self-confidence to leave home and get my own apartment.

мом

Well, Junior, we went through all this before when you invented the telephone and the electric light bulb. You're just lucky I was here to make you see that nobody would want those things before you went out and made a fool of yourself. Now you've come up with another invention that's just as silly.

SPIVEY

But this isn't silly, Mother. Let me show you. See how you can run the pointy end through these pieces of paper—just as simple as an ordinary straight pin. But then after you've got all your papers together—you can put the pointy end back inside the clasp so you won't stick yourself with it.

MOM

Well, I guess that would hold papers together. But it seems like an awfully complicated device for doing it—just to keep from sticking yourself with a pin point. What do you call this gadget, anyway?

SPIVEY

I think I'll call it a paper clip, Mother. And I'm convinced that the world is ready for it.

MOM

Well, I don't know what to say, Junior. It just seems as though you ought to be able to make something out of metal to hold papers together that would be cheaper to manufacture.

SPIVEY

Aw, Mother. You're just determined to find fault with every invention I think of. All you care about is keeping me here at home. There couldn't be a better gadget than this to hold papers together—and you know it.

мом

Well, throwing a tantrum about it isn't going to do you any good. You'd be better off trying to think of some way to improve this paper clip of yours. That pointy end's still dangerous. And besides—if you wanted to take one paper out of the middle of the stack—you'd have to unpin the whole thing and then pin them all back together again.

SPIVEY (Getting hysterical)

I don't want to hear any more of your criticism. This is a real good invention—but you just won't admit it. Show me a better way to hold papers together if you're so smart.

MOM

Well, I suppose you could just twist an ordinary piece of wire around until you made some kind of clamp out of it. Then you wouldn't need a pointy end and a clasp that opens and closes and all that.

SPIVEY

No! It wouldn't work. And you're a mean old woman to say it would.

MOM

Now, Junior. If you want to hold your papers together with one of those things—Mother won't object.

SPIVEY

No! I don't want to anymore. You've spoiled it all now. And I'm going downstairs and break the mold for this gadget into a million, billion pieces.

(Sound: Footsteps and door slam)

RAY

And so Harlan Spivey, Junior—in a fit of rage—destroyed his machinery for making the first workable safety pin. However, his efforts did inspire his mother to become rich and famous through her invention of the first workable paper clip. And what sort of day was it? A day like all days that alter and illuminate our times. The date?

вов (Echo chamber)

April ninth, 1872. Harlan Spivey, Junior, invents the safety pin. Bob and Ray was there.

The Do-It-Yourselfer

RAY

Now it's time once again to pick up some valuable tips for you home handymen as we pay another of our regular visits to the basement workshop of Fred Falvy, the do-it-yourselfer. And Fred—I'm glad I found you at home today. When I saw all those rolled-up newspapers out in your front yard, I was afraid you might be away on vacation.

FALVY

Oh, no, Ray. I rolled up all those papers and scattered them around the yard about a week ago. It's part of a do-it-yourself project I'm involved in.

RAY

Well, I can't imagine what it is, Fred—unless it has something to do with all the burglars you'll attract by creating the impression that you're away from home.

FALVY

No. I admit that having all those rolled-up papers in the yard does attract a few prowlers who think the place is deserted. But what little they steal is more than offset by the money I save from leaving papers out there until they get good and soggy.

RAY

You just leave them out there in the rain and snow until that happens, eh?

FALVY

Oh, yes. You see, the idea is to let nature convert the newspapers back into wood pulp. And then you can burn them in the fireplace just like logs. Only the cost is much less, of course.

RAY

Well, it certainly sounds like another wonderful example of better living by doing it yourself, Fred. But how long does it take for the natural elements to turn newspapers back into wood pulp?

FALVY

I'm really not sure, Ray. I read in a book where it would take about two hundred thousand years for paper to become converted into coal. But I'm certain that changing it into wood pulp wouldn't take near that long.

RAY

Well, then I suppose it could even happen within our lifetime. And it'll be a real money saver if it does. Now, I know that all our beloved friends of the radio audience are anxious to hear about the do-it-yourself project that you've chosen to describe today.

FALVY

Today, I've chosen a real money-saving project to describe for our beloved friends of the radio audience, Ray. I'm sure most of us are aware that handmade lampshades have gone up in price faster than the general cost of living.

RAY

No. I wasn't aware of that, Fred.

FALVY

Well, most people are aware of it, Ray. However, it's not generally known that do-it-yourselfers can make lovely lamp shades right in the basement workshop—just using some inexpensive equipment and a few simple tools.

RAY

Well, I noticed that you have some blue paper stacked up here on the workbench. Is that what you're using for your lampshade project?

FALVY

Yes. This paper is good, sturdy twenty-pound bond, Ray. It comes cut into eight-and-a-half-by-eleven sheets as a rule. And the color of these particular sheets is blue.

RAY

Yes. I didn't know about the size and weight. But I noticed it was blue.

FALVY

Well, you can get it in almost any color you want, Ray. It's just ordinary mimeograph stock. And the paper mill here in the neighborhood where I bought these sheets also had it in white and pink and yellow. I don't think they make mimeograph paper in black. But you probably wouldn't want to use black for a lampshade anyway.

RAY

No. I imagine black paper would absorb too much light. So what do you do after you've selected the color for your lampshade? Do you make some kind of wire frame to stretch the paper across?

FALVY

Oh, no. You don't have to get into all that. You just roll a sheet of paper into sort of a cone shape—taking care to leave the small end large enough to fit around a bulb socket. And then you staple the edges of

your paper together using an ordinary office stapler filled with Number Five wire staples. Here. I'll show you how that's done.

(Sound: Stapling machine)

RAY

Fred is stapling along the edge of his rolled-up sheet of paper. And that certainly is making it stay in the conical shape you want, Fred. But I don't quite know what you're going to do with it now.

FALVY

Well, the rest is actually quite easy, Ray. I just unscrew this bulb hanging down from the ceiling here. Then I put my blue paper shade around the socket—like this. And then as I screw the bulb back in, that holds my cone-shaped piece of paper where I want it. That's why I rolled the paper into a cone to make the shade in the first place—so the bulb would hold it in place.

RAY

I see. Well, of course, this piece of blue paper you've stapled together makes a fine shade for a naked bulb hanging down from the ceiling. But there aren't many fixtures like that around any more. What if you want a shade for a regular lamp?

FALVY

Oh, well, you can buy those at any lampshade store, Ray. It's the ones for these old-time ceiling fixtures that are hard to locate. I went to six or seven stores and couldn't find a one.

RAY

Well, then, you can save time as well as money by making your own—if you happen to be one of those rare individuals with an old-time ceiling fixture. So we could certainly say that this is just one more prime example of how to live better by doing it yourself. And we've been privileged to hear all about it directly from the basement workshop of Fred Falvy, the do-it-yourselfer.

RAY

And now the United States Mint . . . one of the nation's leading producers of fine new money . . . presents another dramatic story from the files of *Emergency Ward*.

(Organ: Dramatic theme)

SNUTTON

Greetings and welcome. I am Doctor Gerhard Snutton—handsome young physician who has not yet established a practice of his own. Instead, I work in the emergency ward of a big city hospital. The emergency ward is a place where the saga of human misery unfolds twenty-four hours a day. Take the other evening, for example. I was utilizing a spare moment to engage in some medical research when my associate, Nurse Rudehouse, turned to me and said . . .

RUDEHOUSE

Why are you standing on top of the desk waving that flyswatter around, Doctor?

SNUTTON

MAN

Yeah. I'm sorry about that. I tried not to damage your paint. But this all ties in with my medical emergency. You see, my wife tried out a new recipe on me tonight. And I didn't like it. So she got mad and stuck this salad fork in my ear.

SNUTTON

I'll have to prepare you for X-rays. It could be a punctured ear drum.

EMERGENCY WARD 105

MAN

No. I think it was tomato aspic with little pieces of pineapple in it. But you don't have to take X-rays, Doc. I didn't swallow any of it.

SNUTTON

I mean X-rays of your ear to see if there's been damage, dumbbell.

MAN

SNUTTON

Well, that's only a natural reaction that you shouldn't be alarmed about. It's the law of gravity. I studied it in medical school.

MAN

Gee. It's really nice to have an educated man like you around to explain these things when they happen. But anyway, I seem to be cured. So what do I owe you, Doc?

SNUTTON

Well, the X-rays would have been seventy-five dollars. But since we never took those I guess a dollar and a half should take care of everything.

That seems about right—considering how serious my condition might have been. So here you are—and thanks for everything. Good-bye.

(Footsteps and door closes)

SNUTTON

Well, Nurse Rudehouse, you have just seen another hopeless victim walk out of here in radiant good health—thanks to the wonders of

RAY

Wally Ballou Visits a Paper Clip Factory

RAY

We've been conducting a cross-country search for inflation fighters—industrialists who've been going all-out in their efforts at cutting costs, eliminating waste, and contributing to the economic health of our nation. This week, Wally Ballou visited the Great Lakes Paper Clip Factory in Napoleon, Ohio—and here's his report.

BALLOU

—ly Ballou at the Great Lakes Paper Clip Factory in the office of its president, Mr. Hudley Pierce. And I want to thank you, Hudley, for the warm welcome you've given me here.

PIERCE

It's quite all right, Wally-always glad to have guests.

BALLOU

I might say I was amazed to find such a big plant as yours here is devoted to the production of such a small item as the paper clip.

PIERCE

Well, actually, there are much larger paper clip factories than ours, Wally. We're really one of the "little fellows" in the industry. But I guess we have to fight the same battles as the big boys. Battles against inefficiency . . . waste . . .

BALLOU

Now, I've only been through that one building, but I imagine there are others. In the one I saw, I was surprised that there's no machinery in there at all!

PIERCE

No, we don't have any machinery. We just buy wire in long strips. Then, our workers cut the strips into shorter pieces and bend them into paper clips.

BALLOU

Well, if all of this work is done by hand, I imagine you have to get a pretty hefty price for your product.

PIERCE

No. Our clips are priced competitively. So far, I think we've managed to hold the line on inflation—and we expect to keep on doing that. Our clips retail at ten cents for a box of one hundred.

BALLOU

Wow!

PIERCE

And we sell them there at the factory for six cents a box. In gross lots.

BALLOU

Astounding figures. How many boxes can a plant the size of yours turn out in, say, a week?

PIERCE

Well, when we have all three shifts working, we can produce right around two hundred boxes a week. If we can sell them all, that means we take in twelve dollars.

BALLOU

And you can afford to operate a big plant like that when your weekly sales only mount to twelve dollars?

PIERCE

Yes. We have a very low wage structure. Here, again, we've been able to hold the line on costs. Our average worker makes about fourteen cents a week.

BALLOU

Well how in the world could anybody live on that?

PIERCE

Apropos of that, I noticed on my visit to the plant that all of the fellows working there were dressed in rags. And they seemed to have strips of cloth tied around their feet!

Well you can't wear shoes when you make fourteen cents a week. That should be fairly obvious to anybody.

BALLOU

Probably explains why they seemed to be grumbling, too . . .

PIERCE

Possibly . . .

BALLOU

I just can't understand how you can get people to work for a salary like that!

PIERCE

Well, the union contract has quite a few loopholes in it. For example, it doesn't mention wages at all. But, it does have a clause that makes a worker subject to prosecution—and imprisonment—if he tries to quit!

BALLOU

I imagine the union will have that changed the first chance it gets.

PIERCE

Fortunately for the firm, it's a ninety-nine-year sweetheart contract. And it still has almost eighty-six years yet to run.

BALLOU

Well it's certainly been interesting to chat with you, Hudley, and we tip our hat to you in your valiant fight to cut costs and eliminate waste.

PIERCE

Thank you.

BALLOU

Now, this is peripatetic Wally Ballou returning it to Bob and Ray.

You have Abraham Lincoln driving to his inauguration in an automobile!

NELSON


Yes. That is a definite error.

Did you check on that at all? I mean . . . it should have been fairly easy to . . .

NELSON

Oh, there are several glaring errors in the book that, unfortunately, I didn't catch. There was one referring to the Father of Our Country.

You have "Nelson Washington" under his picture.

Yes. I was just thinking of my last name, I guess. Because, of course, his first name was George. It's an honest mistake.

One of many. I seem to remember you listed the publisher of *Poor Richard's Almanac* as Benjamin French.

NELSON

Yes. It should have been Benjamin Franklin.

Through the eighth grade.

вов

And you wrote an eleven-hundred-page history with only . . .

NELSON

Even so, an eighth grade education in American history is not enough to qualify a person, be he genius or not . . .

NELSON

That's what you say!!

ВОВ

Well, this book proves it.

I had all the facts. It was the names that were wrong. And the dates. For instance, I had the Civil War happening in 1911 . . .

Yes, I know.

NELSON

Which was wrong. That, of course, I could have checked by asking almost anybody. But here, again, when I sit down at the typewriter, I just like to take off and go. Know what I mean?

NELSON

Yes, it's a shabby piece of work. I'm one of the first to admit it.

NELSON

INSPECTOR

And that strikes me as strange because there's a diamond necklace right there on the table. Of course not. And I appreciate getting your thoughtful insight on the President's address. Now, this is Wally Ballou . . . sending it back to our main studio.

(Music: Documentary theme. Establish and under for)

вов

Now . . . welcome to *This Place for Heroes*—a dramatic re-creation of events in the lives of ordinary people who have battled for the common good without giving thought to their own personal safety. Today's dramatization tells the heroic tale of up-and-coming young prizefighter, Kid Quertus. And we'll be meeting the real Kid Quertus . . . right after our factually documented story.

(Theme up and out)

QUERTUS (fading in)

So that's the way I feel about it, Packy. It doesn't make any difference if they don't pay me at all for fighting Killer Musgrove. I still want you to set up the match. Somebody has to take on that bully, if the noble art of boxing is to survive.

PACKY

Now, now, now, me boy. Don't go getting yourself all riled up. This Killer Musgrove is no mere bully, you know. He's a madman, he is. And they'd be barring him from the ring for life—if he wasn't heavy-weight champion of the whole state of Connecticut.

QUERTUS

That's exactly why somebody's got to stop him, Packy. He kicks and gouges and half kills every opponent he meets. But they won't take his license away until there's a new state champ. And that's going to be me.

PACKY

And what, might I ask, gives you the idea you can whip Killer Musgrove? You think you're so high and mighty. Why, I've seen Killer make mincemeat out of bruisers who outweigh you by fifty pounds, me boy.

QUERTUS

Maybe so, Packy. But in my case, there's one big difference. I have decency and righteousness on my side. It's my mission to rid the fine old sport of boxing of dirty fighters like Killer Musgrove. And I'll gain strength just from knowing that honest people all over Connecticut are with me in spirit.

PACKY

I do admire your moxie, Kid. But let's not be getting carried away by the melody of our own voice. There's others charged with the job of keeping boxing clean. That's no affair of yours.

QUERTUS

Well, I'm making it my affair, Packy. The boxing commission's even more afraid of Musgrove than all the heavyweights in the state. So now, he's there on top with nobody who'll stand up to him. His dirty methods are paying off, Packy. Think of the example that's setting for all the young people in this state. Do you have any idea how many children there are in Connecticut?

PACKY

No. But there must be thousands.

QUERTUS

You bet there are. And I'm not going to let them grow up thinking that the way to succeed is to gouge and cheat and fight dirty. I'll get into the ring against Killer Musgrove and beat him fair and square—for the good of our young people—for the good of all Connecticut.

PACKY

You've already inspired me, Kid. I'm with you all the way.

(Theme up full and then fade for)

RAY

The big match was arranged—and Kid Quertus drew his strength from little people everywhere to achieve the seemingly impossible. The Kid knocked out Killer Musgrove to put the Connecticut state championship back into the hands of good, clean, decent people. The sport of boxing was saved. And it was the heroism of Kid Quertus that saved it. Now, let me ask the real Kid Quertus to come out here and receive the tribute he justly deserves.

(Applause)

QUERTUS

I'll be right there. It's a little hard to use crutches when both arms are broken, too.

RAY

I see now that you have both of them in a cast—along with one of your legs. And I really can't understand how you managed to beat Killer Musgrove on a T.K.O. after he broke that many of your bones.

QUERTUS

Oh, he didn't hurt me like this in the fight. I beat him with a lucky punch in the first round. Then Killer really got mad. Up to that point, he'd only despised me. But when I took his title away from him on a fluke, he took it personally—and worked me over out at my house the next day.

RAY

Well, I know what a painful experience that must have been. But you

did win the Connecticut heavyweight championship. And nobody can take that away from you—just by throwing a temper tantrum.

QUERTUS

That's true. Nobody can take it away from me. Of course, they've taken away my car and my furniture and my house to pay medical bills. But the championship has no cash value. So they let me keep that.

RAY

Well, that mythical crown is one you can wear proudly, Kid. It's your badge of courage for all the world to see. You're a hero, Kid Quertus—the very kind of hero we're proud to honor, here on . . . This Place for Heroes.

(Theme up briefly and then out)

BODRY

Seven and a half—fifteen and a half—thirty-two.

RAY

Let's get to the fundamentals. What is your name and where are you from?

BODRY

Fahnstock P. Bodry, from Moline, Illinois.

RAY

Well, congratulations, Fahnstock. Incidentally, I have been requested by the Most Beautiful Face Committee to remind you of the obligations you assumed when you were crowned a few moments ago. You know, of course, you'll be showing your beautiful face all over this country of ours this coming year?

BODRY

Yes. Will I be chaperoned on that tour?

RAY

I'm sure you will be. Incidentally, should you do anything to bring disgrace to or cause public scorn to fall upon the Most Beautiful Face Contest, Committee, and/or its sponsors, then your title will automatically pass to the first runner-up.

BODRY

I don't plan to do anything wrong.

RAY

Well, the Committee just can't take that chance. Now, Fahnstock, can you tell us of the magic moment when you heard your name announced as winner. Did you cry a little?

BODRY

Oh, a little, I guess. I guess you could say I was dumbfounded. That's how I'd describe it.

RAY

Now that I look at you . . . you know I think you really do have a beautiful face at that.

BODRY

RAY

Classic Grecian, I'd say.

BODRY

I'm told they're Roman.

RAY

I don't know. I know your eyes are well set apart. Tell me . . . how did you come by all this beauty?

RAY

Do you have any pretty brothers and sisters at home?

BODRY

No, I'm a beautiful only child.

RAY

Well, are you the least bit . . . er . . . self-conscious . . . I mean are you . . .

BODRY

Embarrassed to be so beautiful?

RAY

Yes.

BODRY

No, I'm used to it by now.

RAY

You get used to that. Do you find women stopping and staring at your beautiful face on the street?

BODRY

Yes, but I get used to that too.

RAY

Well, as a possessor of a beautiful face, do you take any particular precautions? Like when you shave, for instance?

BODRY

No, but I use a fresh blade every day.

RAY

Well, how about the wintertime? Do you put a protective muffler about your face to protect your features from the cold?

BODRY

No, I just walk with my back to the wind.

RAY

Well, you know, this year, like all happy times, will fly by for you, Fahnstock. Have you given any thought to the future? Is it Hollywood and the movies or a television career or what?

BODRY

Oh, I've thought about that life of glitter and tinsel and glamour and so forth. But I've really decided against it.

RAY

Oh?

BODRY

Yes. I don't want to be just another beautiful face!

Anxiety

RAY

And now, it's time for another story of drama and tense emotion . . . a tale well-designed to keep you in . . .

(Organ: sting)

RAY

Anxiety! . . . Here with us again to set the stage for our latest thriller is the noted author and world traveler, Commander Neville Putney. Commander, I'm sure you've reached into your amazing file and brought forth another tale well-designed to keep us all in . . . Anxiety!

(Organ: stinger)

PUTNEY

Oh, indeed I have, young man. Today's hair-raising yarn concerns two promising young bank tellers named Warren Hughie and Weldon Glimbiter. Both had received considerable praise from their branch ANXIETY 183

manager for displaying the ability to make change and add figures correctly. It seemed as if promotion for the pair were almost certain. Then, one terrible mistake brought them face-to-face with . . . Anxiety!

(Organ: stinger)

PUTNEY

The two heroes of today's drama had struck up a casual friendship with one of the bank's wealthy clients who chanced to be president of the Amalgamated Step Ladder Company. It was he who tipped them off that Amalgamated was about to unveil a new model that would glow in the dark. Warren and Weldon saw a chance to double their money overnight by embezzling funds from the bank to buy Amalgamated stock. They were certain they could replace the money before it was missed. But as Weldon returned to his desk after phoning the stock broker to sell at a big profit, his eyes were downcast. Warren noticed immediately.

WARREN

Weldon—I noticed immediately that your eyes are downcast. But you don't need to feel bad if we failed to double our money overnight. I'll gladly settle for a gain of fifty percent. Just so we can sell out and replace what we embezzled before Mr. Prouty notices the shortage.

WELDON

PUTNEY

No. As I recall, they merely sold their Amalgamated Step Ladder stock at a profit of several hundred thousand dollars. So of course, that enabled them to replace the bank funds they'd stolen, and still have plenty left over to retire to the French Riviera.

RAY

But I don't understand, Commander. In your story, Weldon and Warren's broker told them that Amalgamated Step Ladder had dropped as far as it could go—and that he couldn't even give it away.

PUTNEY

PUTNEY

Why, you cheeky young blighter. You haven't the vaguest notion of what you're talking about. Now I'd suggest that you read your closing announcement before you find yourself in very serious trouble.

RAY

Well, after that clinker, I think we're both in serious trouble. But I'll try to get through this closing announcement . . . Friends, join us again next time when Commander Putney will again reach into his amazing file and bring forth a tale well-designed to keep you in . . . Anxiety!

(Organ: stinger)

Edible Food Packaging

RAY

The Patent Office has issued a patent to a manufacturer who plans to turn out food products wrapped in packages which are, in themselves, edible. We've come to this supermarket in King of Prussia, Pennsylvania, to get the reaction of a person who would be dealing first-hand with this new development in food processing, Checker-Outer Number Twenty-Three. His name is Leonard Bonfiglio. Leonard . . . have you heard of the edible food package?

BONFIGLIO

No, sir, I haven't.

RAY

Well . . . we came all the way down here to King of Prussia, Pennsylvania, to get your reaction. It's a package you can eat . . . You haven't heard about it?

BONFIGLIO

No, sir, I haven't.

RAY

Well... as long as we're here, let's see if we can get a human interest story... a supermarket human interest story... er... Leonard... does this Twenty-Three have any special significance?

BONFIGLIO

Yes, it means that this is checkout counter Number Twenty-Three.

RAY

You always work here on Twenty-Three?

BONFIGLIO

No. A few years ago, I used to work over on Sixteen.

RAY

Is there any difference between Twenty-Three and Sixteen . . . other than the obvious seven?

BONFIGLIO

Yes. When I worked on Sixteen, you had to take in bottle returns.

RAY

We're talking with Leonard Bonfiglio here in a supermarket in King of Prussia, Pennsylvania. We came to get his reaction to the edible food package story, but it seems that he hasn't heard about it. Now we're trying to get a human interest story. Leonard . . . what's the favorite food that you like to check out?

BONFIGLIO

RAY

RAY

RAY

Incidentally, if you like to cook with charcoal, be sure to use it outdoors. Cooking with charcoal indoors, there's a danger of carbon monoxide poisoning.

BONFIGLIO

I never heard about that.

RAY

This is Leonard Bonfiglio, here in a supermarket in King of Prussia, Pennsylvania. We're trying to get a human interest story. Leonard? Any important people ever come through here? Any celebrities?

BONFIGLIO

Yes. Xavier Cugat came through here once. He had his chihuahua with him.

RAY

I didn't know they allowed dogs in supermarkets.

BONFIGLIO

They don't usually, but he had it in his pocket, and I guess they overlooked it or something.

RAY

I'm getting a hurry-up signal here. Leonard, is there any supermarket anecdote, any supermarket joke, you fellas like to tell each other? Anything to lighten up this otherwise serious interview?

BONFIGLIO

Well, you might like this one. A fella came in here about a year ago . . . and he came up to me and he said . . . "Before I go back inside, I want to make sure that you can change an eighteen-dollar bill."

RAY

BONFIGLIO

I said: "Sure! How do you want it? Two nines or three sixes?"
(Bonfiglio shakes with laughter)

RAY

And there's our human interest story from King of Prussia, Pennsylvania!

RAY

Each year, more state and local governments are allowing television cameras in their courtrooms. Today, correspondent Wally Ballou is visiting another community that will soon be taking that step. Come in, please, Wally Ballou.

BALLOU

—ly Ballou reporting from the chambers of County Judge Merton Claypool in Lost River, Ohio. Judge Claypool has handed down a ruling that will permit TV cameras in his courtroom beginning next week. Your Honor, what's the thinking behind that decision?

CLAYPOOL

Well, I've watched televised trials in other areas recently, and I decided that—comparatively speaking—I'd be a smash hit on the tube.

BALLOII

Well, you do cut an impressive figure, sir-but . . .

CLAYPOOL

It's a certain star quality that I have about me, Mr. Ballou . . .

BALLOU

I guess that's the term I was groping for . . .

CLAYPOOL

Perhaps I could show your viewers what I mean by that. It's such an undefinable thing.

BALLOU

A demonstration might help.

CI.AYPOOL

Well, this is just a little piece of stage business I've been working on. But it shows how my magnetic personality reaches out and grabs an audience.

(Pounds gavel)

CLAYPOOL

The witness is directed to answer the question or be held in contempt!

(Puts gavel down and lowers his voice)

That's about it—basically.

BALLOU

Beautifully done, sir!

CLAYPOOL

Thank you. But do you think I should do it that way—banging the gavel before I yell? Or should I speak the line and then do the gavel bit at the end? You know, as sort of a snapper?

BALLOU

Gee, it's been so long since *Perry Mason*. I don't recall which works best. I think you can do it either way.

CLAYPOOL

Probably so . . .

BALLOU

But tell me, sir—when you first got the idea for letting TV into the courtroom.

CLAYPOOL

Oh, I guess I've had a little greasepaint in my blood ever since law school.

BALLOU

Really?

CLAYPOOL

Yes. We used to put on a show every year. I remember once we did a school pageant based on the Bill of Rights. I was the Ninth Amendment.

BALLOU

I don't believe I know that one . . .

CLAYPOOL

I'm not sure either, after all these years. But I think it deals with coveting thy neighbor's ox.

BALLOU

Is that in the Bill of Rights?

CLAYPOOL

I don't know. As I say, I've been out of law school for years. But I still have a newspaper review of that pageant. The critic wrote: "Young Merton Claypool handled his supporting role as the Ninth Amendment with aplomb."

BALLOU

With what?

CLAYPOOL

Aplomb. It describes first-rate acting. Years later, I read a review saying Marlon Brando had portrayed the Godfather with aplomb. So Brando and I have the same thing.

BALLOU

Then you really approve of having cameras in court just so you can put on a performance?

CLAYPOOL

Why not? I never sav anything I wouldn't want your kids to hear.

BALLOU

But a man could be on trial for his life . . .

CLAYPOOL

Not in my court. They don't let me handle that big stuff. In fact, I'll be opening next week in the case of the Elmdale Water District versus the State Public Utilities Commission.

BALLOU

Well, it sounds as if that one will need all the punching up your talent can give it, Judge. So good luck and now, this is Wally Ballou, saying . . . until next time . . . This is Wally Ballou saying so long.

The Four-Leaf Clover Farmer

вов

We came across a gentleman in Henderson, Vermont, recently. His name is Nelson Malamon, and his story struck us so much that we invited him to tell it himself.

MALAMON

And I want to thank you and the generous Bob and Ray organization for underwriting my trip, too. It's a wonderful experience.

вов

You deserve it . . . particularly with the run of bad luck you've had. Tell everyone what it is you do, Nelson.

MALAMON

Well, I own a four-leaf clover farm back in Henderson. I developed a breed of hybrid four-leaf clovers some years ago.

BOB

And you found a market for them?

MALAMON

That's right. I sell them to novelty makers who put them into little plastic cases as good luck tokens . . .

ВОВ

I've seen those. I used to get one of those from my insurance man every year.

MALAMON

Right. Anyway, I thought this was going to be a banner year for my business until last June.

вов

That's when your troubles started.

MALAMON

It was Friday the thirteenth—that's the funny part—and my assistant, Neil, was taking my entire first crop by truck to Bellows Falls. From there it goes to my biggest customer in New York.

What happened?

MALAMON

The truck went over a cliff and we lost the entire crop. Neil was unscathed, however.

BOB

He was lucky, anyway.

MALAMON

My second crop came out rather badly. It takes about six weeks for a crop to be ready for harvest.

BOB

I was going to ask you that.

MALAMON

I couldn't tend it properly because I was laid up . . . I got hit in the head with a horseshoe that was hanging over the door of my greenhouse.

ВОВ

Yes, I can still see the lump there.

MALAMON

No. That's the way it always was!

ВОВ

Well, go ahead.

MALAMON

Besides me being laid up, the crop-dusting plane crashed, so a lot of the clovers ended up with leaves eaten away—and there's nothing more worthless than a four-leaf clover with only two or three leaves!

ВОВ

I agree. Looks like this whole year past will have to be written off as a disaster.

MALAMON

You know the rest. The day you visited me back in Henderson was the day the telephone pole fell on my greenhouse—destroying the entire third crop.

вов

And that bit of misfortune involved your neighbor, if I remember correctly.

MALAMON

Yes. He raises hares . . . for rabbits' feet. Well, he had his truck laden with rabbits' feet and was headed for Bellows Falls . . . when he swerved to avoid hitting a black cat . . .

BOB

... and hit the pole-knocking it onto the greenhouse.

MALAMON

Hardly any wonder you thought my story worthy of telling on Friday the thirteenth!

вов

Right, and you certainly have had a tough time this year.

MALAMON

Well things are looking up, though. I recently met a glass blower, and we're going into business. He's made up some beautiful crystal glass four-leaf clovers that'll be surefire sellers. Would you like to see them?

Sure would.

MALAMON

I'll get them.

вов

And so I guess you'd say there's a silver lining behind every dark cloud. Mr. Malamon's story of incredible bad luck apparently has a happy ending after all...

(Loud crash of glass backstage)

ВОВ

On second thought . . .

Search for Togetherness

(Dramatic organ music. Establish and under for)

RAY

And now—Search for Togetherness—the touching story of people just like yourself, who struggle to overcome their misery in a small Midwestern town where the steel mill has been closed permanently.

(Theme up briefly and then fade for)

RAY

As our scene opens today, Doctor Honeycutt—the recently widowered young surgeon—is paying a surprise visit to the office of Sanford Bluedorn, kindly editor of the Roaring Falls Advocate.

(Door shuts)

BLUEDORN

Well, Doctor Honeycutt. This is a surprise visit, I must say.

HONEYCUTT

Yes, I was afraid that was the way it might seem to you, Sanford. And heaven knows—I'd hoped I wouldn't have to come here.

BLUEDORN

Now, now. There's no need to feel that way, Doctor. The people in this town have been coming to me with their problems for forty years or more.

HONEYCUTT

I know. But I thought I was made of sterner stuff than the rest of them. However, Agatha's murder trial is scheduled to go to the jury this afternoon—as you may have heard.

BLUEDORN

Yes. I've been following the case closely. And of course, my best young reporter, Lance Wakefield, is covering the case for the Advocate.

HONEYCUTT

That's what I've come to talk to you about, Sanford. I wish you wouldn't put too much trust in the stories that young Lance Wakefield is writing about Agatha's trial.

BLUEDORN

Oh, come now, Honeycutt. I know what you're thinking. But . . .

HONEYCUTT

No. I don't think you do know what I'm thinking, Sanford. I happen to be young Lance Wakefield's personal physician.

BLUEDORN

That has nothing to do with this. However, I know what you're thinking.

HONEYCUTT

No. I'm reasonably certain that you don't know what I'm thinking, Sanford.

BLUEDORN

But everyone in Roaring Falls is thinking the same thing, Honeycutt.

They know that young Lance Wakefield spent four years in prison for a crime he didn't commit. And they think his bitterness about that experience makes him unfit to cover Agatha's trial for the Advocate.

HONEYCUTT

I've been thinking the same thing, Sanford. And that's what I came here to talk to you about.

BLUEDORN

I was sure you would—sooner or later.

HONEYCUTT

Really? And yet you said that my visit here came as a surprise. Why?

BLUEDORN

Oh, I don't know. Perhaps I couldn't think of anything more appropriate to say when I saw you standing there in the doorway. After all, this visit has come as something of a surprise.

HONEYCUTT

I guess I should have known it would. I was hoping right up until the last minute that I might be able to stay away.

BLUEDORN

Nonsense, Honeycutt. There's no need to feel that way. The people in this town have been coming to me for forty years or more.

HONEYCUTT

I know. But I'm supposed to be made of sterner stuff. I'm a doctor, you know.

BLUEDORN

Yes. I'm aware of that. In fact, I believe you're the personal physician of my top young reporter, Lance Wakefield.

HONEYCUTT

That's right. And it's Lance Wakefield that I've come here to talk to you about.

BLUEDORN

Now, Doctor-I know what you're thinking. But . . .

HONEYCUTT

No. I don't believe you do know what I'm thinking. Lance Wakefield is covering Agatha's murder trial for the Advocate. And that trial is scheduled to go to the jury this afternoon.

BLUEDORN

Really? I didn't know it was going to be so soon. Lance Wakefield hasn't filed his story on the trial for the early edition yet.

HONEYCUTT

Sanford—I wish you wouldn't put too much trust in the stories that young Lance Wakefield is writing about Agatha's trial. That's what I came here to talk to you about.

BLUEDORN

BLUEDORN


No trouble at all, Doctor. I'm glad we had this little talk. Very glad indeed.

ВОВ

And now, ladies and gentlemen, it's time for one of the most eagerly awaited features on the Bob and Ray show—one that always fills a much-needed gap: Bob and Ray's News in Depth.

(Theme up and out)

вов

Our first guest on News in Depth today is a gentleman who heads up a little-known yet vital governmental department. He's regional Eastern Interbureau Coordinator of Administration for the New England states, Ohio, and Southern Indiana. Mr. Clyde L. "Hap" Whartney.

WHARTNEY

Thank you. Everybody in Washington watches your show.

вов

Thank you. We're very glad to hear that.

WHARTNEY

Now, I've taken the liberty to go ahead to prepare some questions and answers here so that there will be no misunderstanding as to the function of my office and just what it is we do down there in Washington. Here's our script.

(Takes two sets of papers from his pocket and hands one to Bob)

ВОВ

Well, I was just going to fire away questions off the cuff.

WHARTNEY

It will be easier this way. Now where it says "Bob"—that's for you, see . . . and I have the answers written down here.

вов

All right, Hap. (He reads)

There seems to be some confusion in many circles as to the responsibility of the World Bank vis-à-vis as to the Federal Reserve Board and Bank. Could you clear it up for us?

WHARTNEY

I'm glad you asked me that question. The Federal Reserve Board is a semi-quasi-governmental agency that operates the Federal Reserve Bank and also proposes interest rates that member institutions should charge.

(Pause)

ВОВ

And the World Bank?

WHARTNEY

I was getting to that. The World Bank's function is to loan money, capital, that is, to emerging nations to encourage their growth. Next question?

вов

As I understand it, the interest rate charged by banks has a definite relationship to the prime interest rate suggested by the Federal Reserve Bank.

WHARTNEY

That's not even a question. I think I know what you're trying to ask, though. Member banks borrow money at little or no interest in order to have funds to lend to business and individuals at prime rates.

вов

You certainly know your subject matter. Allow me to congratulate you. So many of my guests come here and don't seem to be familiar with their own jobs.

WHARTNEY

That is very kind of you. We at Interbureau Coordination pride ourselves on our complete dedication to the serious responsibility that is squarely placed on us. I'm sure our broad shoulders will more than bear up under the tremendous pressure.

BOB

I want to thank you, Mr. Whartney, for coming here tonight, and so brilliantly describing your office and its functions. You have spruced up an otherwise ordinary program.

WHARTNEY

You are more than kind, and I might add, very discerning.

вов

I want you to know the welcome mat is always down for you, Mr. Whartney, and the door is always open. Good guests like you are hard to come by.

WHARTNEY

Thank you, and goodnight.

вов

We now switch to anchorman Wally Ballou, of the Bob and Ray

election coverage team, who has just predicted defeat for candidate Neil A. Sturbush in the race for county commissioner. What makes this interesting is the fact that Mr. Sturbush spent more money in waging his campaign than any office seeker ever spent before. Let's go right now to Sturbush headquarters for what will undoubtedly be a speech of concession . . .

(Convention background)

STURBUSH

Would you all simmer down out there please . . . Simmer down . . . (The sound fades)

STURBUSH

I guess you all heard Mr. Ballou when I did. He's predicted my defeat; I guess I lost. Well . . . those things will happen. I'd like to say a few words if I may . . . I know that after my opponent has been in office a couple of months . . . the people will come to me and say . . . I wish now I had voted for you, Sturbush. He's a bum—you're okay. Won't you please run again? You know what I'm going to say to them? NUTS! You had your chance to vote for me and you didn't—NUTS! I'm not going to run again. I've spent a fortune in television and radio. All I have left is what I've got in my pocket. In conclusion, I'd like to say one thing . . . You're just not going to have Neil Sturbush to kick around any more!

(Convention sounds up again)

RAY

Now to analyze Mr. Sturbush's speech, here is the Bob and Ray News in Depth specialist—David Chetley. David . . .

CHETLEY

In exactly one hundred and fifty words, Neil A. Sturbush has left little doubt that he has lost this race . . . and further, that he does not intend to run again. With some degree of circumlocutory skill, he has couched the absinthian vehemence of his address in a periphrastic bit of casuistry, which is paralogistic on the one hand, and incapacious on the other. Indeed, his jeremiad—his threnody—call it what you will—can only be accepted for what it is: an atrabilious amphigory. This is David Chetley.

RAY

Thank you, David. You took the words right out of my mouth!

RAY

Now—we have been asked to make the following announcement by the Treasury Department. Citizens, our money is your money. We print it for you to use. It is for your convenience. Make more use of money. It's handy, it's dependable, it's trustworthy. Money orders, checks, bank drafts, credit cards are good in their way, but money is better. It is easy to carry, transfers quickly, and is soft to the touch. It comes in a lovely green color, which is pleasant to the eye. It has pleasing pictures on it of Alexander Hamilton, George Washington, Andrew Jackson, and the White House. The numbers are large and clearly legible. If you want money, just write and tell us how much and in what denominations. Use money every day. It's the American way!

(Patriotic music)

вов

And now back to News in Depth, and another guest. The story of this man's trial has been front page news in papers across the country these past few weeks. He is the corrupt Mayor of Skunk Haven, New Jersey—Mayor Ralph Moody Thayer . . . Mayor Thayer . . .

THAYER

Thank you.

вов

Is the jury still out, by the way?

THAYER

Yes, it is. But my attorney is negotiating with the foreman of that august group now, and we feel we have nothing to fear. We believe that you can attract more flies with honey than you can with vinegar.

вов

Mayor Thayer, to go back over your checkered career . . . You were a petty forger, a master swindler, a convicted embezzler . . .

THAYER

And convicted of perjury several times.

ВОВ

How does one start on a life of corruption such as you have built for yourself?

THAYER

Oh, I guess it started when I was a kid. I used to cheat in exams in grade school. I used to tell malicious lies about my fellow students to the teacher. You see, I've always believed I could build myself up by tearing somebody else down.

вов

Now after your formal schooling was completed, I think you developed an interest in financial matters . . . money lending . . .

THAYER

Loan sharking.

BOB

Yes.

THAYER

I did that for several years until the criminal element in town asked me to run for public office. I took that as a mandate.

BOB

I remember that first election. It still stands as the crookedest election in Skunk Haven's history.

THAYER

Thank you.

вов

And from then on, it was all downhill, really . . . Over the years you've riddled every department of your administration with corruption. All

the way from the top to, well, right on through to the Visiting Nurse Association. I'd like to ask you a final question, Mr. Mayor, and don't answer right away. Give it some thought, if you will. Would you say it's easier to be corrupt today, than it was, say, ten . . . even fifteen years ago?

THAYER

Oh my, yes! You see, ten or fifteen years ago, it was a disgrace to be corrupt. Now it's a very fertile field. I recommend it to anybody with a devious mind, who is willing to put in long, long hours, without working hard. They will find it terribly enriching. Fully rewarding.

вов

Well, I'm sure we will all be able to draw something from your words and I want to thank you very much for coming by. We will be anxious to hear what the jury decides when it comes back in.

THAYER

Don't give it a thought! I'm not!

ВОВ

Thank you, Mayor Thayer . . . And thank you all for tuning into News in Depth. Before we go, however, let me remind you that . . .

RAY

The opinions expressed by our guests are their own—and do not necessarily represent the views of the Bob and Ray organization.

вов

Also, they should not be construed as the opinion of this station . . . or its subscribers . . . or members of their families.

RAY

And it must also be remembered that questions asked by the panel are not designed to reflect any particular viewpoint.

вов

We should mention, too, that our panel members are speaking only for themselves—and not as representatives of their employers or members of their families.

RAY

But in any event, this program is presented solely for the enjoyment of the viewing audience . . . and any rebroadcast or reuse without specific permission is prohibited.

ВОВ

Likewise, any admission charged by owners of TV sets for watching this broadcast is similarly prohibited.

RAY

The entire contents of this program remain the sole property of the Bob and Ray organization—and may not be used for any commercial purpose by the New York Jets—or the commissioner of the National Football League.

BOB

That includes reproduction in whole or in part, Ray.

RAY

Absolutely, Bob. However, it should be understood that portions of this program may have been recorded earlier for broadcast in this time period.

вов

This is done solely for the convenience of our audience—and not for the purpose of editing or deleting controversial material.

RAY

In so doing, some passages that have been retained may be considered offensive by various ethnic groups or religious organizations.

ВОВ

Therefore, discretion is urged among members of such groups or organizations in listening to the material presented.

RAY

Parental guidance is also suggested. And in no case shall children under the age of sixteen be permitted to listen to this program.

вов

This ruling applies not only to the public at large—but also to employees of this station and members of their families.

RAY

Any application for exemption from this order must be received in our office before midnight tonight.

BOB

On all such applications, the decision of the judges is final . . . and in case of duplication, ties will be awarded.

RAY

However, the awarding of all prizes is subject to availability. Substitutions for announced prizes may be made at the discretion of the Bob and Ray organization.

ВОВ

But in any case, at least half of this program must be completed in order for it to qualify as an official broadcast.

RAY

If less than half is completed for any reason, then the entire program will be rebroadcast from the beginning at a later date—as determined by the commissioner.

вов

That's correct. Now, was there anything else we wanted to add?

RAY

Yes, some of our departing guests will receive gift packages of our subscribers' products.

вов

I know they'll enjoy that. Well, that brings us to the end of another broadcast day. Join us soon for another look at more controversial issues on News in Depth.

RAY

Research director for News in Depth: Carl J. "Fat" Chanz.

ВОВ

Our program director was O. Leo Leahy.

RAY

Producer: T. Wilson Messy. This was a Messy Production. Now, this is Ray Goulding, saying—wait a minute, folks—we have an important announcement! Don't we, Bob?

Yes, indeed, Ray. Here's the news you've all been waiting for from the Monongahela Metal Foundry. We've got a winner in our giant sweep-stakes contest to select a trade name for Monongahela's new Number Four size steel ingot!

(Fanfare)

RAY

Our lucky first prize contestant is: Mr. Elroy K. Depew . . . of Rural Route Number One . . . in Carthage, Missouri.

(Applause)

вов

Congratulations, Mr. Depew!

RAY

And the winning name suggested by Mr. Depew was . . . ALFRED! (Applause)

RAY

Congratulations again to you, sir . . . and your fortune in prizes will be on its way to you first thing tomorrow. And now this is Ray Goulding, saying . . . Write if you get work.

вов

And Bob Elliott, reminding you to hang by your thumbs. Goodnight, folks.

RAY

Goodnight.

"Like many inspired inventions, the creation of this magic company was accidental," wrote *The New Yorker* in 1973. "The time was 1946 and the place the Boston radio station WHDH. Bob had a morning record show and Ray gave the hourly news reports. In the manner of Sissle and Blake, Gilbert and Sullivan, Laurel and Hardy, and Ellington and Strayhorn, they discovered almost immediately that they had a telepathic bond." Proceeding to NBC, New York, in 1951, they quickly convulsed the rest of the country as well, and they have been present on the airwaves, in one form or another, ever since. Their most recent program, "The Bob and Ray Show," was heard over National Public Radio stations in the fall of 1982, and will resume in 1983. The series earned them their third Peabody Award.

Bob and Ray's achievements also include a hit Broadway show, Bob and Ray: The Two and Only, dubbed "one of the zaniest shows to hit town in many a season" by The New York Times; many award-winning commercials, including those starring the famous Piel brothers, Bert and Harry; the movies Cold Turkey (in which they played, successively,

Walter Cronkite, David Brinkley, and Arthur Godfrey), and Author! Author!; a regular segment on Hodding Carter's PBS series, Inside Story; and specials and appearances on every major television network and on cable. In 1981 Bob and Ray were inducted into the National Broadcasters Hall of Fame and that same year were named "Men of the Year" by the Broadcast Pioneers. In 1982, the Museum of Broadcasting in New York held a retrospective of their work, which was held over for four months and broke all attendance records.
