Group Ownership

Listed here are individuals and companies with multiple station holdings. Included are all those controlling three or more radio stations and/or two or more television stations. FCC rules limit multiple ownership to 12 AM stations, 12 FM stations and 12 television stations, as long as the 12 TV stations don't reach more than 25% of the nation's television homes. UHF's are assessed for only half of a market's television homes. Group broadcasters may own up to 14 stations in a service if two of the stations in each service are controlled by minorities. Ownership of cable TV systems, as reported by these stations, is also listed. Unless otherwise noted, the first station listed is group headquarters.
