A fine way to build up good will for all DXers. For those writing to "Radio Cima" send your mail to Sr. Carlos E. Cordoba N., Gezente. No call letters are shown on pennant. letter or envelope. In a letter from "Radio Peking" I was advised they would like reception reports on all their stations and specifically mention the one on 1190 kc/s which programs English on many hours of their broadcasting time. They sent me a form report very similar to those we used to use years ago in reporting to stations. To date I haven't heard their station on 1190 but it should be possible as they operate with at least 20 kw. and up to 150-300 kw. power. From contents of letter I would say that they will verify all reports. Western DXers should watch for the one on 1190 kc/s. Have just finished reading some of the comments re LA verie problems following Hank Wilkinson's plea for discussion on the subject. My feeling is that there just isn't any really effective formula to be used in writing to these stations. Some members use Spanish form letters; others send tapes; a few attempt to compose their own Spanish letters; some write only in English. I have tried all methods except tape, and see little difference in results. Right now I am using the NRC Spanish Form, International Reply Coupons (except Mexico for which I have Mexican stamps) and a Spanish language dictionary. I have gotten better results with brand new reports than I have with f/up letters. I use correct QRAs and named v/s when known, also submit such information as fast (or as slow) as I get it. I look for easy-to-describe program details and positive ID, and make every attempt to use the station's correct local time. All this effort isn't worth a darn, and we all know it, if the station doesn't feel like replying, and nothing - not even the United Nations - can in my ppinion find a way to accomplish this. I think we have to be prepared to kiss some postage good-bye in order to get some of the veries we want. My returns are running from a third to a half on LAs and I figure that is about normal. Speaking from only two and a half seasons of verie collecting and having only 50 foreign veries, I do not consider myself an expert on the subject. In my limited collection I have had some better than average success with Venezuela, Costa Rica, Puerto Rico, and Guatemala (although slow all percentage-wise, but am still wondering when I will crack Cuba, Honduras and Pan-I am forture to be located where TAs are receivable, because these have come ama. through almost 100% for me.
