Hospho Tape Recorder, West German Akkord portable, and anything else I can use! The HQ tunes b-r-o-a-d, but otherwise very good. The Hosho (now Concord) recorder is real neat, has remote control, and monitor earphone. Wired up a button just below the HQ, and all I have to do is to push and I'm recording! The Akkord is portable, and AC, seven tube job. Covers .54-12 mg.s. in three bands, and FM. Got Japan on it. friend has Hashikhi, nine transistors, two bands. Since Christmas he has gotten JOBK and YVOD-780. I started DXing 11/59 with the HQ and have done OK. So far. 450 different stations, 43 states, 15 countries (U.S., Canada, Mexico, Cuba, Virgin Islandss Swan Island, Colombia, Guatemala, Nicaragua, Japan, Okinawa, Red China, Philippines, Australia and New Zealand.) Veried about 110, sevencountries, 38 states. Best veries: WTYC-1150 Rock Hill, S.C. CE said "This is the first time we have received a report from that far away. Your information was 100% correct." Japan, JOQR-1130, 50 kw., Tokyo, veried by five very colorful cards. Heard 2-2:30 a.m. PST, 4/4/60. Also JOKD-1070, Kitami, verified after six months by QSL. Other Japanese heard: JOEK-670 JOBB-830 JOIE-750 JOLE-870 JONR-1010. Australia: 4QN-630 5RM-800 3LO-770 2GB-870. New Zealand: 1YZ-800 in like local Mondays, Kurming, Red China-700 135 kw. twice, 3/7/60 2:20-2:30 a.m. and 11/20, 4 a.m., S-9 plus. What happened to Alaska? Haven't heard them for over eight months. Oh yes I got Japan on 780 and 990, but don't know which one on that frequency. Maurice Ashby- I also received unID SS on 697 kc/s 4:20-4:40 a.m. PST, played semi-classical music with cultured announcements in Spanish, but no ID. Help anyone? What are the Weyrich and Jones Logs, and where can you get them, etc.? Glen Kippel, what happened to your 50¢ foreign station log? Sent check 9/8/60. Jim Critchett, I can't find your phone number so would you call me at JU3-1449? I would like to thank Pete Taylor of KHVH and John Callarman of KIXZ for help and interesting veries. What's wrong with summer DX? Last summer I got 1YZ and 3LO. Does anyone know if KOMA KIMO KHBC KULA verie? This DX location isn't very good. We have 27 150' Eucalyptus trees that seem to absorb signals. They're neat antenna supports if you can climb 60' straight up without using any branches. A mysterious noise comes on about 4:11 p.m. and lasts to 6 a.m. It drowns out reception for about four miles around. (Welcome to NRC, Earl, and we'll be looking for more. Had to cut you at 30 lines. ed.)

Wayne Plunkett - 124 John Street - Weston, Ontario Before I get into the DX which has really improved the last couple of days, I want to mention that I called on another of our new members, George Kuycke, during the holidays. He has a tremendous collection of Canadian veries including every province - about 130 in all, I think. The night I was there (Dec. 30) the Cubans and some other Carrdbean were flooding the dial while on my car radio all I could get were the usual powerful U.S. group. On Jan. 20 after getting my fill of Inauguration Day ceremonies I turned on the car radio (my best at the moment) to find the band literally flooded with DX. All the following stations were received between 4:30 and 6:00 p.m. VEAM-1390 Arlington, Va., WTOD-1560 Toledo, WCYB-690 Bristol, Va., WGOH-1370 Grayson, Ky., WMAZ-940 Macon. Ga., WANY-1390 Albany, Ky. plus scores of others not IDed. tion, between 5:00 and 6:00 p.m. there was a mess on 930, almost always exclusively WBEN property. Positively IDed under, over and between WBEN were WRRF-930 Washington, N.C. and WIST-930 Charlotte, N.C. As usual when CX are too good (!) there were a number of puzzlers. Two of these were 1590 Johnson City (what calls and what state?) and what I'm pretty sure was WJFG-1440 (where? I see there is WJPG-1440 Green Bay, Wis. but I don't think it was they.) Then between 1:00 and 1:30 a.m. Saturday morning a new one, WAIL-1460 Naton, Rouge, La. was heard. Also KWK-1380 St. Louis, 690, Western U.S. (probably KHEY, El Paso) and what sounded like KDAL-610, Duluth through WIP/WTVN Then KNX and KFI Los Angeles were heard in the clear for the first time since last winter. WHBQ-560 Memphis and WATE-620 Knoxville heard weekly practically every night were coming in like locals around 1:20 a.m. On 710 there was a real fight between KEEL Shreveport and WHB Kansas City with no sign of WOR. Then finally at 1:30 with 550 kc/s. clear, KTSA-550 San Antonio was heard weakly. Sof for the day, six new stations were heard as well as quite a few not around for a long time. Now as I am writing this around 10:30 a.m. Sunday the 22nd KXEL-1540 is putting in off and on the equivalent of a good nighttime signal. Best of DX to all and remember the cry, Hamilton in '62!
