While their 0.5 mv/m curve passessthrough these suburbs (just short of Newark) WNJR-1430 (my #1 problem) has their XR in the middle of these localities at Union, N.J. He said he took measurements of WCTC's signal and found it was getting up there but WNJR was making it totally unreadable by its splatter which he indicated he thought was caused by over-modulation (with the loop at WNJR's null here, I get a grabling sound under WCTC on 1450 and on 1410, while 1440 and 1420 are clear, except for some normal splatter. This would seem to indicate the definite presence of spurious responses from something like over-modulation). Thus, he wants to know if this interference is steady (it is to my observations) so the programming of WCTC can be directed to those localities receiving a clear usable signal.
