Well, a v/c finally arrived from Cairo! Looking back over the record I find it took 11 reports since 1/63. These covered reception on 818 kc/s. & 773, & in some cases both frequencies w/comparison of reception at this end. There was plenty of verifyable material, but I just couldn't seem to get a reply. An expensive verie in time & money. I tried enclosures such as view cards of Boston (to an engineer who had studied here at one time), NRC DX Slips & other things that kept increasing my weight for airmail postage, hi! I even sent a PP stamped w/return U.A.R. airmail stamps which had a brief verie statement in Arabic, no less, traced carefully from one such card I had received that contained identical statements in Arabic & EE! And of course all letters contained IRCs or U.A.R. stamps from DX Stamp Service. I sent reports to El Sherifein St. Propagation & Monitoring Dept., Maspero, & P.O. Box 1186. Second f/up to the latter did the trick.. I was still writing to some of the boys who had received recent veries asking how they did it when my card arrived. It verifies reception on both 773 & 818 specifically, & it lists the hour as 5:59 to 6:52am GMT. The hour is correct, but was local time in Cairo, not GMT. And they really have the date fouled up, verifying reception on 15/3/63! My report was for 9/7/64! But I'm not about to argue the peint! I know when to quit! I'll just file it w/a copy of the report to keep the record straight. Thanks to the fellows who offered helpful into on this one over the past year or so. Other veries since last report are WIBS St. Vincent on 705 and the Grenada station on 535. (Card still shows 540 kc/s.). Surprised by HOS22, Radio Mia, who sent letter for 1/12/64 reception. DDR sent usual card for station on 782, & duplicate cards have arrived from Hungary-1187 and Dakar, Senegal on 764. No dial twisting here of late, so guess that's all the news. Last issue of DX NEWS must have been delayed sometimers, but more often than not arrives on Saturday, so I can't complain.

I fully realize that the "beginner" has to have 500 veries or 25 countries verified to receive one or both of these but if the certificates were too easy to receive, then there wouldn't be much value to them. Hank TyndaI went from 6200 veries & 149 countries in 10/63 to 6500 veries & added seven more commetries by 4/65. Ben Dangerfield added 24 new countries in 16 months. He now has 100, Roger Anderson came back to life & added nine countries in nine months. Hilding Gustafson added 18 new countries in 12 months. Ron Schiller added 210 veries and 49 countries to his totals in 28 months. Bob Bot zum raised his total veries from 4300 in 12/ 63 to 4418 in 4/65 & added five new countries, too. Chicago is the only city w/direct connections w/Cedar Rapids. Round trip from Chicago to Cedar Rapids is \$35.30 plus 5% tax via propeller plane - no jet service to Cedar Rapids. The easiest way to get to Cedar Rapids is to take ANY plane to Chicago, & then get connections to Cedar Rapids. Round trip from New York or Newark to Chicago is \$87/40 plus 5% tax. So, from N.Y. to Cedar Rapids is \$128.84. This price is for third class jet, N.Y. to Chicago, & propeller fare from Chicago to Cedar Rapids. Here is a listing of round trip fares from some cities to Chicago; then add 5% tax. N.E./Newark to Chicago, \$87.40; to Cedar Rapids, \$122.70. Baltimore/Washington to Chicago, \$75,40; Cedar Rapids \$110.70. Boston-Chicago; \$101.70; Cedar Rapids \$137.00. Cleveland-Chicago, \$44.00; Cedar Rapids, \$79.30. Philadelphia-Chicago, \$81. 50; Cedar Rapids \$116,80. Pittsburhg-Chicago, \$56.00; Cedar Rapids, \$91.30. All fares to Chicago are Jet Coahh (the least expensive way). Your consideration of these matters, Hank, will be appreciated. I am using this method of communication as I feel many of these fare far from unique to me, & my line of thinking may be of interest to others debating some of the same questions, John C., Ben D., etc. In Europe: Wales is counted from verie of "BBC Welsh Home Service" on 881 from Washford, England. Local programming from studio in Cardiff was logged, so I count it as Wales I do. Scotland is counted from verie of BBC-1214, no specific location. Of the high-powered XRs on this frequency, Westerglen is closest, so Scotland it is in my book. Italy is counted from a QSL, which while specifically worded, lazks frequency, date, etc. & was in response to tentative inquiry on multi-lingual program logged on 845 during AN sked of Roma-II. My feeling is this simply could not have been anything other than Roma-II. Holland is counted from a very specific QSL detailing frequency & time of tentative reception of a TT which could have haraly been from anyone other than Hilversum-I-746; cover letter is of no value. In Asia, Sarawak is counted from a v/q which while positively worded didn't answer my specific enquiry re programming heard & was in nature of a tentative report. Formosa is counted on a standard BCC v/q which specifies frequency & time but nothing about program I reported on, which, like Sarawak, was very much of a tendative nature. In NA: PJD2-1295 is counted as a separate country, St. Maartin, although the Netherlands Antilles are also verified. "Radio Swan" & successor, "Radio Americas" are counted as Swan Island, although some question raised as to actual location. David F. Gleason, General Manager, Radio Musical, Casilla A-57, Cuito, ECUADCR, writes: "Often I have noted in IDXD reports mentioning "LA music" or "Popular LA music" in description of the type of music played on the station reported. First, as a generality, there is no such thing as "LA music"... no more than there is "US music"... for what is US music ... Jazz? Folk? RnR? R&B? C&W? LA music has many divisions: Musica de la Nueva Olax -- is the expression for rock and roll. (If it were US rock, it would be the same expression with "Norteamericana" tagged on to the end.) MUSICA tropical -- is Latin beat music ... cha-cha-cha, merengue, dengue, porro, gaita, cumbia, mambo, etc. (Incidentally, the distinctive upttempo tropical music heard on Colombian stations is Cumbia or Gaita generally.) HJED and XEB are pure tropical. Música nacional -- is music distinctive to one country ... in Colombia it is distinguished by the emphasis on the guitar... typical examples are found on La Voz Amiga-650 at 0500 and on R. Cordobesa-1220 at s/on. In Ecuador, it is sadm music, with emphasis on flats, making it sound off-key. HCEW2 on SM plays Ecuadorian national music similar to that of Colombia, with heavy guitar and bright tempo. In Mexico, national music is made up of the Nortemas and rancheras, which are both the XE C&W Music. So in reports to both the stations and to DX News, it would be a big aid if greater distinction were given to the music. On a frequency occupied by several stations, it would be easier to identify each if the types of music could be better described." Good thought, Dave, and I wonder if someone with the knowledge of and the access to various fhases of this music could cut an instructional tape thereoff to make available to ANARC affiliated radio clubs.

Dave also writes re reports to SS stations in English: "I know of a Culto station that answered a report from an NRCer which was actually a report for the programming of a YS station. They answered the report simply because i t was addressed to them ... and was in EE, and they could not read the rest. IA stations can, at times, make use of DX reports to sell advertising, but only if the report is in SS. And, an SS report makes a good impression on the station staff, mainly because they are used to the typical US diplomats who does not know Spanish or bother with it. So, why take the possible positive effects out of a report by writing in EE? There are available SS report fromrs and SS-EE dictionaries... why not try a littlem harder? I read English, but I would not answerm an English report... the DXer is asking me for something and not giving me any useful information ... in the commercial Sense."

MORE FROM DAVE GLEASON -- "... it would help to explain much better that a verie is wanted, and that it is for BCB. Many stations dow not answers shortwave reports because they get so many...but if the exact idea of the report is clear, a reply might be given. Do not forget that many LA stations have SW, and get so many reports that the economics prohibits a reply to them. Follow-ups should carry a different wording, and maybe a fuller explanation of what you want than the original report. A vocabulary of SS radio terms does not hurt, and may impress the station. An ad is a XXXXX "cuma", announcement "anuncio", announcer "Locator", or, ch record programs "discjockey" and so on." Dave, thanks for what I consider to be valuable information, and I hope we will hear from you more often. We truly have an "INTERNATIONAL" DX Digest. (Ed.)

Americas, Swan I., is often heard. Now for some other news: Ecuador. HCJB Antenna system for Mw 700 kcs consists of 345 feet vertical radiator. Since March, HCJB txs have been supplied from a hydro electric plant. This low cost power and HCJB hopes to be able to increase power in the future. From my log: Tunis-962 heard with English program, poor signal; R. Popular, Valencia (1151) fairly good signal here 2315 GMT; R. Las Palmas (1313) good signal around 2400; R. Caroline South 1493 heard with strong signal in the daytime, often gives call in Dutch as well as English; Berlin International (1511) heard in English at 2015 GMT, GRM from Brussells; R. Caroline North (1520) still testing at 2300 in Dutch, German and English, but GRM from Prague with tone signal. A new pirate station should be on the air very soon, broadcasting to Wales and the West of England. This will be operated by the same firm as Radio City. Hope to have more details later.

Michael A. Silvera, 5 Trenton Ave., Kingston 8, Jamaica, writes: "DX conditions are pretty bad here now; besides we usually have a lot of rain around this time of year. Besides yours truly is attempting to absorb some knowledge but still I've been able to come up with something. How much does an HQ-180 cost? I think I'll get one even if I have to save for the next ten years, which is exactly what I will have to do. Also, does it have a short-wave band? and is it better than the HA-230? I would appreicate any information about it. On, by the way, I've noted HIAU-1350 La. Voz de Liberted, Puerto Plata with ads and all, a few times since Civil War began. Nothing yet from JBC. Seems they need another visit this ti a I'll see the general manager himself, but It will have to be after exams about the attacked beginning of July."

Gordon Nelson, in letter and at greater length in phone conversation outlined an exciting new breakthrough in reception predictions ... or perhaps we should say a kind of Reception Possibility Guide. "The computer program to calculate propagation effects is working very well. I'm currently concentrating on the TA fadeout-dawn problem add the results have been very exciting. By considering that the primary mechanism causing fadeout at dawn is the exponential production of indic species in the E-layer region, by taking a fairly complex model for the ionosphere it is possible to predict the time beyond which a given TA station (At a given date) cannot in principle be heard. I've been going over IDXD and my own logs, and the predictions are really good." Gordon encloses some very telling graphs, and says that predicted dates and times that certain rare stations, especially Africans, can be heard will be forthcoming. "I know that if I had had some of this data last season, I would have been saved many hours of fauitless listening." We'll be hoping to have details in next month's IDXDI

Calculated fadeout time checks well with Malawi and is quite likely them. DF bearing confirms that is Central African. Not a chance in the world that this is Baghdad. (Nelson, Mass.)
- 791 KENYA. Re BD's unid. on 3/16: my calculations indicate that Mombassa would very likely have feded out by 2249 on that day, therefor the IS heard at 2330 most likely was not Mombassa. (Nelson, Mass.)
- 809 SPAIN. EAJ7, R. Madrid, exceptionally high and clear going AN on 5/31; gone by 2338. (Nelson, Mass.)
- 840 CHINA/JAPAN/PHILIPPINES. Re Jac's unid. Oriental on 3/16, computer says DYSR could have faded in around 0436 at earliest, Nanching around 0423 or so, so it's pretty much a tossup. AP recently reported that Mainland China recently has begun Tagalog transmissions that are heard on transistor radios around sunset in the Philippines. (Nelson, Mass.)
