

Randy Seaver - 2110 39 Street - San Diego, California - 92104 I plead guilty to Roy Millar's remarks of 10\$23 issue, but the assumptions were justified in each case he quoted, I believe. The point is valid, in any¢case. Two NHK-I stations are fairly simple to find on an MM. MHE-II is a lot easier to find a parallel to. The Peking-1000 in question had a woman announxwe who has, to say the least, a distinctive voice. Roy, it is possible your 840 Chinese may be a weaker outlet than the Kiangsi outlet, which has been IDed on 843 by some Chinese friends of Gray's. It is odd to note that the Chinese time is given as "Peking Time" & that most of the country is on this one time. On 890, I have a mystery here, two ISes @ 8am, one very high, the Jap, typical NHK. The other had four pips before the NHK started, a fifth is audible through the NHK IS, & any others unknown. If Chinese, the fixth pip will be higher, & hence harder to hear. What does South Korea's IS sound like, Roy, if you know? Needless to say, this season has probably been the best TP season in a long time. At the present time, I have mystery TPs on 575 620 730 (pips go 'lo-hi-ho-16-ZZZZ (that's static), 795 799 890 (mentioned above), still outstanding. There are other mysteries on such odd frequencies as 695 705 738 820 955 (Burma?) 1008 1123 & 1125. Any help? WCers? Oh yes, Roy, you might try 843 at 6am for IS. No TAs have been heard w/aiudio yet, due mostly to TVI in the evenings (SMs & MMs until 3:30), but plans are being laid for a two week sojourn o/Christmas in a next-door apartment, sans TVI, & w/a loop, hopefully. That's about it, 73. Oh yes, Ernie, did you know "oy vay" in Vietnamese is "troi oi"? Pronounced "choy oy". Just thought you'd like to know, in case you ever (or I ever) make it to that immediate vicinity.

What is the call for Summer, Wash. on 1560? Sounded like KGSI when heard on ET 10/3 at 3:30am. KSWS-1020 ET of 9/16 was reported then, but still no verie or answer to query about RS. TAs from Europe were neard here for the first time from 10/16 thru 10/22. None since. BEC-1214 was in every night during that period. CSB2-1034 was logged for several hours on 10/22. The ID given on the 843kc/s. Chinese station on 10/17 @ 6am, When translated from the Mandarin, reads, after four low-pitched tones, "The last tone you heard was 1900 hours sharp, Peking Time. Chiang-shi (Kiangsi) People's Broadcasting Station." I believe this is the station heard last year w/strong signal on 840 kc/s. Nothing but JOQK heard from the Orient on 840 kc/s. this year here, but I haven't tried after WHAS' fade. Hot WM on 10/25, but I did get JOCK-730 & 2QN-1520. It's a great DX year here on the WC. 73.

Not exactly in mood for Musing w/10/23/65 issue of DX NEWS at hand, but don't want to be negligent, so - 10/24. WAYS-610 Charlot te, N.C. ID 5am, just momentarily topping AN WIP. 10/25- WWYN-1260 Erie, Pa. s/on 4:30an nicely atop channel. 10/28- WBEV-1430 Beaver Dam, Wis. s/on 5:28am., just barely readable in QRM. Veries: Murmansk-656, Khabarovsk-1250 (both from Moscow, & as result of f/ups on receoption of last Winter). I wonder, if in view of fact not too much Domestic DX to report on if it would be of interest to any to do a little bit of "frequency analysis" concerning my own DXing thereon, along following lines (to spread around a bit I'll report by 100 kc/s. increments, 540, 640, 740, etc. 540 shows six verified (CBK XEWA KFMB KBRV KVIP 4QL) plus HJKA logged. Currently I tape this frequency on Thursday mornings. CBK being off. 640 (and appertmeant 'solits') show seven verified (CMHQ KFI WOI TGW WNAD &YX BBC-647 plus HOK, Radio Peking, Guadeloupe, CMQ JOPC & Radio Peking-645 logged. This is a MM only channel @ KFI, & even on MM rough w/CMQ thereon, as well as frequent testing by KFI. 740 & splits show 14 verified (KCBS KTRH KBIG KLER CBL CBXA KGU (yes, oh 740!) WNOP KVFC KWBY CFRA (really odd; listed 560 kc/s., never explained why on 740) CBRN CBX, Hilversum-746) plus KYME logged. Never DX this channel at present as don't think any period clear of KCBS and/or CBX. 840 & splits show eight verified (four continents plus a fifth on split) in WHAS HJKC XEBA Radio Peking 4RK HJBI PRH9 Roma_II plus CMAN JOPG JOQK WITUF TG -- logged as well as an unID on 843 (oriental). A nice clear channel to DX on after TG-- s/off until WHAS s/on. Though for this trip. 73.

- 575 UNID. Very strong every night, reaching peak at 2015. (Goldfinger, N.Y.) ____
- 590 ALASKA. KHAR, Anchorage. "Heart Radio" announces as 24 hours, 7 days. (Fox, Yukon)
- 611 MCROCCO. R.T.M., Sebaa Aloun, f ir to good early evenings, as are 701 and 935. 701 is best. (Gustafson, Ill) 620 UNID. ARABIC. Presume chanting here 2211 10/18 is Egypt. (Fox, Yukon)
- 630 CUEA. CNHC, Santa Clara. Noted 10/18 0336 0-5, S9 15 db. Anyone have station verified lately? I'd surely appreciate the (TH, Verie signer, etc. (Hathaway, Ill.)
- 637.5 GUATEMALA. TGW, Guatemala. Found on this freq. 10/26 and very clear between 2100 and 2130, and a lot of U.S. big band music. Not noted 10/28, so must be back on 640. (Dangerfield, Pa.)
- 638 CZECHOSLOVAKIA/SPAIN/CYPRUS. Three carriers visible here on 10/18: BEC Cyprus who signs on nightly 2150-2155 during October; Prague OC and TT on early; and RNE briefly with OC 2150-2203 off. Cyprus still not formally logged. Antenna pattern from Cyprus seems to be highly unfavorable.for U.S. reception. (Nelson, Mass.)
- 645 PANAMA. HOS-22, R. Mia, Panama. Is AN and is heard until sunrise here; makes logging the Chinese outlet on 645 difficult on E.C. (Nelson, Mass.)
- 650 LIBERIA/HAWAII/BIG MYSTERY. Previously reported tentative ELEC is now positively identified as the English speaker after WSM, s/off 0130. ELBS good on scope under WSM 00 0110, but faded out by 0120 on 10/25; no audio with WSM on. WSM off 0131, leaving clear channel, but ELBC faded up very suddenly at 0134:30 and gave good solid copy for five minutes, then faded very rapidly leaving only traces of KCRL on this channel. On the basis of E2O assumptions, I should not have heard ELEC on this date; This is the greatest African anomaly noted so far. ELEC heard 22 minutes after E20 time on 10/25, although behaved properly at E20 time. Suspect that magneto-lonic splitting gave rise to an alternative path in this case. Liberia logged as country #107. KCRL, Honolulu, up with very clear ID 0358 on 10/25, R&R programming, KORL was fading in and out around 0417 when a second English station faded up briefly with a religious program. Accented English on this second station, and DF said was on a N-S path (190°), then out quickly, leaving only KCRL. I'm really puzzled over this one, my equipment does not have images, and the bearing excludes Pacific stations, etc. Must be that a U.S. station has a weak spurious radiation on 650, and the program was canned. Second station extremely weak; my setup up full gain for first time since last winter. Who? (Nelson, Mass.)
- 655 NCRTH KCREA. R. Fyongyang relogged with weak signals during Far East opening on 10/20 at 0519. Best preliminary DF on this one gives a longitude of about 125° E at a latitude of North Korea; this is quite near Pyongyang. Usual fast auroral fade. (Nelson, Mass.)
- 656 EAST GERMANY. R. D.D.R., E. Berlin, on 19/19, the El Salvador station gave him fits; hard to get good copy on him because of all the yacking. (Gustafson, Ill.)
- 676.59 JORDAN. Unfamiliar IS and s/on in unid. language 2229-2231 on 10/24; still not formally logged since didn't recognize IS and too much WNAC slop to ID lingo for sure. So still working on this one. This is the wandering Jerusalem outlet, I suspect... (Nelson, Mass.)
- 683 SPAIN. R.N.E., Sevilla, seems to run AN. (Gustafson, Ill.)
- 708 EGYPT. Cairo stations heard one night at 2300 here, 773 and 818 kc/s. (Gustafson, Ill.)
- 720 CUBA. Does anyone have the call, verie signer and OTH for this one? I'd surely appreciate neceiving it so I could get a report off with more hope of getting a reply. Heard 10/17 0330. (Hathaway, Ill.)
- 725 UNID. S.S. Heard at 2020 on 10/28. (Goldfinger, N.Y.) Likely TILX, R. Solumbia, Costa Rica. (Ed.)
- 730 EL SALVADOR. YSR, Circuito YSR, San Salvador, here fair to good 0010 til 0059 s/off 10/25. (Silvera, Jamaica
