Anywa, I read & digested the WENT report in the preceeding issue & also read (and presumably digested them as well, my stomach hasn't brought back the verdict yet) the comments in this week's DX NEWS - very interesting indeed! Now to the topic: I have read that NRC once had a small booklet w/a title similar to "How to Send a DX Report" w/all the controversy over poor reports to stations, perhaps a resurrection of this publication would be of use in this battle gainst the massed enemy of the poor report. IRCA had this idea - few dozen months ago, but as far as I know nothing every came of it. Mebbe this time, like a joint club publication? In my reports, I pride myself on verbatim station IDs, & completeas-possible live spots for local advertisers, & general info on ET-type spots & promos I surely hope I am not bragging, but I run about 89 (very low, sniff) to 96% verie-reply, & a few stations that didn't reply were not sent f/ups. For example, I logged & reported CKWX-1130 & CJOC-1220 while they were in their "unpredictable periods", so new reports will be sent off one of these days. KONO-860 is another example of the "seasonal verification." The next time, though, a PPc will be sent, as this more or less assures a reply to a good report. Only one PPc hold-out this year, KZOL-1570, 250w.D. Farwell, Tex. SRS catch of 1/17 I think inotes are not especially handy right now). Oh yes, before I go back into the pits, one thing bags me quite a bit. The idea that once a person has joined a club, he sends excellent reports from there-on in NOT SO! I think most CEs would prefer a snort, precise report instead of a ldng two-page letter full of too many trivial items. Also, to comment on your statement of not sending a f/up. To me, a f/up is another completely different report sent to a station that has not answered your first report. So as a result, I have never sent in a "carbon copy" f/up. I may be wrong on the definition of a f/up, but that's just my feeling toward it. Enough said, 73 & good DX to all. ### RADIO STATIONS FROM THE PEOPLE'S REPUBLIC OF CHINA

By. K.G. Serimgeour

Inverted up this list of stations heard by NRC and IRCA members since September 1965 that are believed to be located in Mainland China. Only a few of these stations have been assigned Accations, because no local ID's are given on so many of the programs. 795 kHz is definitely Shanghai, and both 835 kHz and 843 kHz gave Kiangmain the ID's. The 843 station might be a rebroadcast by Thailand, since some Thai stations are reported to be broadcasting Peking programs.

The foreign service on 1040 kHz is heard most often on the West Coast, and programming is in Japanese with Peking Hoso ID's. The 1120 (variable station is also foreign service, with several languages (including Russian (Govorit Pekin ID heard).

Most stations are home service outlets. Central People's Broadcast stations; these are characterized by the 5 low; I high time pips on the hour (semetimes without a break in programming). The national lanaguage in China is Mandarin, and is the language that we hear on the home service usually. The 1030 kHz station possibly is in the home service, or a local in Kwiechow or ??? The time pips are not standard, but 2 low, 1 high. In some cases, the only identificable material heard was the 6-pip interval signal, but these stations are listed below anyway.

There were other unidentified oriental stations (e.g. the second station on 955 kHz under Burma, 738 kHz, 810, and 900) that might also possibly be from China.

Most of the less common stations were logged between late September and Mid December. The strong transmitters (635, 1040, 1120) were heard almost all year. Here are the details, Sparse as they are, on these Chinese outlets:

Since it's not even possible to get much of a verie from Peking, yet, I suppose that we'll have to keep piecing together what information we can get. Perhaps someday China will publish a decent log of stations, and again give more specific veries.
