

Mike Levintow - 2650 Haste Street - Room 607 - Berkeley, California Congrats for including Loop plans! For one who had trouble getting loops to work properly your plans were certainly welcome. After a slight amount of rewiring I could fin nally tune all the way to 540k & below. The old construction, based on some Poptronics plans, could tune only to 700. However, what's happened to the CPC? Now to DX. I haben't been doing much since Summer because of a miserable static-trap & antennaruin I'm stuck in, a dorm in Berkeley. Only time for DX is when I go back to my family in Kentfield, on the other side of the Bay. DXing o/Christmas vacation, I noticed considerable improvement in CX since Summer. When atmospherics are winzed minimal, I get good to rxcellent signals all day from KAFY KCNO KUGN KVCV KNGS XETRA KMPC KNX XERB KRDU KSL KPTL KIBS KPOL KIQS. Getting to tougher things, I heard a weak one around noon u/KMJ, w/KMJ nulled. (KFXD & KWIN seem equally likely). Also around the same time unIDs w/semi-locals KJOY KSTN KSOL & KTOB nulled. Here I'm quite ignorant although station u/KSOL might be KVML. KUBA might also be on the list except I followed up the station under it & it turned out to be KASH. Don K., I tried logging KWZZ-800 & had the same problem, aggrevated by KGO slopover & a weak image from KNBR. seems to be there but it's not good enough for a log. This was my best signal every from Vemezuala. 1/7- 5:36pm, WKVM-810 w/telephone calls (requests?) & rr in SS. A mystery, @ 6:06pm I heard tones before & after announcements which were given between NX items in SS. This is the style used by Rumbos-560. The frequency was either 730 or 740. Now, is there an affiliate on that channel? It sure sounded like a Rumbos hookup. At 6:15-10:28pm (w/interruption) I took an extensive log on SRS-725. I THINK it was Surinam! When they put a new dial cord into the RX the calibration was thrown off & I'm still trying to get accustomed to it. So at first I thought the frequency was 715 until CMCN-720 came on between WOR -710 & this mystery. The mystery station was between CMGN & the Cuban/Mexican/FF on 730. At any rate, whoever they were they played American mx, sung in EE, w/mx which sounded like Arabic. In fact the announcer spoke a language which sounded more Semitic than anything else. According to my 1962 WRH, Surinam broadcasts in Hindustani, so this might have been it. I also read in IDXD (What an aid that is!) that Surinam s/off @ 10:28 w/an anthem. So it must have beem they. From a rickety bus parked in the lot of UNM Stadium in Albuquerque, a driver education inztructor yells instuctions to his students weaving through to obstacle course in their cars. The XR is of quite low power (he is not sure just what it is) but radiation is aided by connecting the longwire antenna to a longwire fence running N/S. On my rather insensitive car radio I have been able to catch the station up to o/six miles away on groundwave; & at my home location 1.15 miles N of the stadium, a fine signal is audible. Perhaps some of you are in a position to try for this one via SSS. Station operates weekdays on days when school is in session at approximately 5:30-7:30pm EST, & in addition during the day from about llam EST Saturdays. It is easily recognizable by the long pauses, lack of IDs, & strident no-nonsense tone of speaker. Because of the low power, such operation is sanctioned, but not licensed, by the FCC. (Brooklyn 11226) with it, and met with this sort of reception, 'Ha ha ha - hey Joe - look at this - this is one for you - ho ho ho!" They told me "they'd take care of it." Then, a third one came back to me & this time I sent it to the Postmaster General of the U.S. in Washington, who wrote back, telling me the case was referred to General Post Office, New York N.Y. 10098. DX conditions remain essentially unchanged from last week, although there are some indications that the TA's are beginning to return. "DX conditions have been exceptionally poor in California in past weeks," (IRCA) - "I am finding conditions very unfavorable to TAs and other long distance stuff, but note many LAs, so all is not lost." (Ben Dangerfield)

Pirate Province. Gregg Calkin of New Brunswick provides us with the latest news of the British situation: "Radio 390 resumed their transmissions January 1st on their old frequency (773). In doing so they are violating British law technically because because once having been judged guilty of illegally operating a radio transmitter in violation of the Wireless Telegraphy Act of 1949 as they were, they can be fined 100 pounds per day for each additional day of illegal operation. Mr. Ted Allbeury, Managing Director of Estuary Radio Corporation, owners of R. 390, said that the station had decided to resume broadcasting after a new hydrographic survey made for it had shown that a sandbank in the estuary was permanently covered in water. The previous conviction had been based upon the testimony of a Naval offic er who had stated that this particular sandbank was sufficiently far off-shore that when the low-water mark was measured from it, the fort in Red Sands was judged to be in internal waters. Mr. Allbeury considers the information that the sandbank is permanently covered has created a new situation. Therefore until he is again prosecuted Radio 390 will remain on the air. Although not mentioned in official AP reports I assume that this is from the fort in Red Sands. The ship that I mentioned a couple of weeks ago may come into use in the near future."

Great news about Peking's Sinkiang xmitter on 1525 from Rolf Blodorn in Germany:
"The Chinese transmitter now has 3 additional Russian language programs, from 17001755, 1800-1855, 1900-1955; final close-down at 1955. At least I noted this on Jan.
6, 7, and 8. At around 1955 the signal strength here was still QSA 3-4! (Of course these may have been only test transmissions. Time will show if it will stay on the air so late every nite now) Also, at certain times, I have noted Russian stations using 1525, e.g., on January 8, between 1800 and 1855, I noted at least 2 Russian stations over/under the Chinese: one carrying the Russian Mayak program, and one carrying jamming noise. (I suppose that the jammer is located in the USSR - who else would jam Peking's Russian program?)" Nothing unusual about reception from western China at 1955 on that date, Rolf; sunrise isn't until 2048 and E20 is considerably later than 2100 on the path to you. If this station continues with such late broadcasts, reception in North America should be possible until at least March. But it's going to take some good detective work to untangle the Chinese and Russian stns on this frequency. (Ed)

EL SALWADOR: Confusion About 1145 *By Richard Wood*

Here are listings from four much-consulted foreign logs:

1130 YSG Radio Chaparristique, S. Miguel (2 kw inactive: WRTVH '66; 2 kw: Gleason & FBIS '65; 500 watts: FBIS '66)

1140 YST Radio El Mundo, S. Salvador (1 kw: WRTVH 166 & Gleason; 3 kw: FBIS 166)

1145 YST Listed here by FBIS '65

1150 YSCF Ondas Orientales, S. Miguel (1 kw: all sources agree)

Reports by DX'ers recently have stated that there is at least one station active on 1145 or 1146. Its identity has been reported as R. El Mundo and as R. Chaparrastique. In fact, there are at least two and probably three signals from El Salvador to be heard from El Salvador on 1145-1146.

It is beyond doubt that YSG, R. Chaparrastique, San Miguel, is in fact active on 1145 (not 1146). After a powerful unid SS station on 1146 signed off at 2207 on 1/1/67, a weaker but quite clear station was hrd with Mexican charro music and other musical selections. Three clear ID's were heard. At 2213, "R. Chaparristique", at 2222 "Nueve 22 minutos en R. Chaparristique" and best of all, at 2228, "Sintonizan con El Salvador. Transmite R. Chaparrastique, 1130 kilociclos." With these positive items to back it up, a report was sent. No reply has yet been received.

On a fine night for El Salvador stations, 12/24/66, a station was hrd on 1146. The items hrd will be mentioned in the reply which I received to a tentative report sent to YST. In a cogent and precise letter, showing a much better grasp of things technical than is usual from Latin America, Sr. Angel H. Suárez, Gerente Administ-

rativo, replied in a letter dated 1/4/67 (I translate):

"With regard to your report dated 12/25/66, between 10.45 and 11.30 p.m. (Salvador time), I can say the following: on the 24th and the days following, we had strong local interference, emanating from the 3rd harmonic of R. Cadena YSKL, 760 kHz., due to their difficulties in tuning their Ampli-Phase RCA transmitter, and it is beyond doubt that at the time of your reception it was this other station on the same frequency as YST Radio El Mundo, since you heard, at 10.57, "Atención... Atención", calling to the listeners in a Salvador city, and at 11.26, after the commercial, a romantic song sung by a tenor. YST Radio El Mundo transmits on the frequency of 1140 kHz from San Salvador with a power of 1000 watts. Our transmitter is a grid-modulated and was made in this country. Our format is the "soft-sell" style, with reasonable commercials, directed to an adult audience of intellectual maturity. The music is carefully selected, in order to remain within the soft music format, using only instrumental interpretations. The time is given after every second melody and the announcer just gives the exact time; for instance, at 11.00 p.m., he would say 'Eleven' or 'Eleven twenty' as the case may be"

Richard, malfunctioning transmitters can produce spurious radiations on just about any frequency (especially when parasites are involved). Note that the third harmonic of 760 is 2280, or exactly twice the nominal frequency of YST. Any non-linear impedance (perhaps in one of the transmitters, or antennas, or even in a nearby telephone line) will produce the difference freq, which in this case falls back on 1140. If YSKL is actually on 762, then the difference between the third harmonic and 1140 will be 1146. I suspect that this was the sort of effect that Suárez was speaking of. (Ed)

2300. Frequent mention of Lima on news pgm 2300. (Dangerfield, Pa.)

1000 <u>Nicaragua</u>. YNTS, R. Mil ID'ed as "R. Mil (numero uno?) en Managua" 0630 1/7. We need a few more R. Mils here don't we, hi! (Northam, Ore.)

1010 Mexico. XEDX, R. Centro de Ensenada, B.C.N. s/off at 0200 on 1/6 w/ callsign

ID. (Scrimgeour, Cal.)

1015 Colombia. Just which is this. Very strong evenings, and sounds like R. Veinte (not R. Mil Viente); R&R pgms. (Dangerfield, Pa.)

1020 Panama. HOV44 "R. Reloj" loud at 0550 1/9 w/ r&r guitar mx; faded quickly. (Reynolds, Cal.)

1020 Tonga. ZCO made a surprise visit on MM 1/16 over and under a very good KGES.

I've never hrd KGES so loud and clear and ZCO was giving them a good fight at times; signal peaked 0340-0400; mostly jazz piano mx. Man announcer w/ rather soft, low voice and Pacific accent. Unneeded but always a thrill to hear! Third weak carrier also coming from the west; maybe KSWS EC or ZKY. (Ed)

Venezuela. YV.. (call not hrd), R. Calendario, Maracabo. ID as R. Calandario 2213 on auroral night 1/3. (Wood, Ind.)

Guatamala. TGUX, R. Panamericana noted same night 1/3 2308; time checks such as "9, 24 minutos en R. Panamericana." (Wood, Ind.)

1030 XEQR, D.F. R. Centro well over WBZ 2306-2323 on 12/30. (Northam, Ore.)

1035 4VEH hrd w/ weak sigs near 0600 1/9 FF religious pgm. Not enough for rpt. (Reynolds, Calif.)

1052 Libya. Tripoli noted AN for Ramadan. (Blodorn, Germany)

1090 Colombia. HJ.. (call not hrd, listed as HJFN and HJFN), La Voz de Armenia. Armenia. Menioned "Manzales" 2050 and "Armenia" 2100 on 1/2. (Wood, Ind.)

1133 Yugoslavia. Zagreb good at 2300 on 1/3. (Dangerfield, Pa.)

1187 International waters. Caroline good 1/16 at 0100. (Ed)

1196 Germany. VOA powerful w/ EE pgm 0058 on 1/16. (Ed)

1200 Cuba. The Cuban is responsible for the miserable low pitched het here. (Ed)

1210 Hawaii. KZOO excellent at 0432 s/off (no anthem) 1/7. (Northam, Ore.)

1214 Albania. Radio Tirana w/ tremendous signal here nightly during the first week of '67. Unid languages before and after 0000 w/ 6 note IS and clear ID given at 0000. Odd I hadn't caughtthis one before. (Calkin, N.E.)

1220 Colombia. HJKR, R. Juventud, Bogotá. ID and in the clear 2100, 2106 the Cuban and Mexican swamped it. (Wood, Ind.) In the clear 1/9 from 0258 to 0326 for

solid copy report. (Reynolds, Cal.)

- 1223 Unid TA. Stn up and very good on 1/6 at 1746-1810 w/ Choir singing and opera mx. Missed the language on the brief annets. Sweden? or did I see an RNE stn there? What is the best time to take a logging on Sweden if this was RNE? (Calkin, N.B.) Very likely to have been RNE, Gregg Falun has been almost inaudible all season. Falun is no longer AN and best bet would be after s/on probably 0000 or 0100. (Ed) RNE very strong 0050 on 1/16; has been best RNE stn many AN's.(Ed)
