7 m g e 2 DX NEWS October 7, 1967 1967-68 DOMESTIC DX CONTESTS RULES! CONTEST MANAGER: Donald Kaskey, Hotel El Rancho, P.O. Box 235, West Sacramento, Calif. 95691 CONTEST NUMBER ONE (STATES AND PROVINCES): 1. Starts 12:01 a.m. local time on 10/1/67 and ends at 11:59 p.m. local time on 6/30/68. Contestant's final entries must be reported to contest manager by 7/15/68. 2. THREE stations from each of the 50 states, D.C. & the 10 Canadian provinces are eligible. First station logged (heard only) from state, province or D.C. will count one (1) point; second station counts two (2) points; and third station countres three (3) points, thus making a possible total of six (6) points in eath geographical division. 3. Any demestic Special TEST or DX for the NRC will count as an additional three (3) points. It may be 1st, 2d or 3d station from any area, or added on after area is completed. There will be no limit to the amount of Specials that can be entered. However, DX TESTS must be VERIFIED to count for bonus score. No 50,000 watt station within 1,000 miles of DXer's home address may be counted in contest. 5. All NRC members in good standing are eligible and must submit their entry fee of 25¢ to the Contest 12/1/67. New members may enter within one (1) month after becoming a member. 6. Fihal standings will be posted in DX News, or they will be announced at the 1968 Boston Convention and then posted. 7. Any station, no matter if previously logged or not, may be counted. 8. Contestants must bring their totals up to date at least once a month, or they will be dropped from the contest at the end of that month, following a postcard warning from the contest manager. 2. List of entries must include location, call, frequency, date heard, time logged, date verified (for special bons only) and Verie Signer (for special bonus only.) 10. Prizes will be issued according to the number of contestants. 11. All stations may be logged within a 10-mile radius of the DX'ers home base. If the DX'er moves during duration of contest, the manager will decide how to continue scoring. 12. Any judgement as to interpretation of the rules or disqualification of contestants rests solely with the contest manager. CONTEST NUMBER TWO (LETTERAMA): OBJECT: To build tiers of call letters by logging U.S. and Canadian Stations. FGHMAT: The fourth (or last) letter in each call is the letter used in building a tier. A tier is completed by logging 26 stations representing each letter in the alphabet. One tier must be complete before another is begun. CFCF, for example, would be an "F". Contest is scored 1 peint per lettre. RULES: Rules 1, 4, 5, 6, 7, 8, 9, 10, 11, and 12 from Contest #1 apply (except no need to verify specials). **** CONTEST NUMBER THREE (STATE CAPITALS): OBJECT: To log one station from ach of the state and provincial capitals, plus Washington, and Ottawa. FORMAT: Each station logged counts one (1) point. Greatest possible score, thus, is 62. RULFS: Rules 1, 5, 6, 7, 8, 9, 10, 11, & 12 in Contest #1 (Except no noted to verify specials). CONTEST NUMBER FOUR (GRAVEYARDERS): OBJECT To log as many stations on the "Graveyard" frequencies (1230, 1240, 1340, 1400, 1450, 1490) as possible. FORMAT: Each station logged counts (1) point. An additional five (5) points will be awarded for each NRC speiial program verified. RULES Rules 1, 3, 4, 5, 6, 7, 8, 9, 10, 11, and 12 from Contest#1 apply. CONTEST NUMBER FIVE (250-watters)

OBJECT: To log as many 250-watt stations on the NON*GRAVEYARD frequencies as possible.

FORMAT: Each station logged counts one (1) point. Verified Domestic tests from 250-watt non-gravey-rul stations count five (5) points.



We were sadden w/Gene Allen when word came that his mother had passed away & he had to leave so soon after arrival. But it was great to meet so many fine fellows that make up the NRC. Special thanks to the crew from California whom we got to know on the trip. With my special interest in foreign reception it was a real joy to meet Gordon & Ruthie as well as John from Boston. To listen to Gordon & try & absorb a bit of his wealth of information makes one appreciate the fact that we ha e in the NRC all the resources to make DXing both a science & an art. I have a little info to share. The Roseville, Cal. station w/a CP on 1110 is now nearly constructed. They expect to start tests very shortly. The GM tells me they are required to test without modulation except IDs each half hour. Better get the wording precise, as there will be little else to use for verifying. They expect to be ready to begin RS in early November. The owners are required to sell KAHI-950 forst but a deal is nearly complete for that. They will be non-directional days & protect KFAB nights. Surprisingly they are not required to protect either WC station. The non-reported KQCY-1370 that the FCC says is on was finally heard here between daytime KEEN domination of the channel & KGEN's rise in early evening. But still not enough for a report. International DX Digest

DX conditions have been highly variable the last few weeks, to put it mildly. Here in the Northeast, we've noticed conditions running the gamut from first-class TA conditions (on 9/19, Dakar-764 readable fully 2 hours and 9 minutes before our local sunset) to "typical auroral conditions" (on 9/28, TA's very weak - IA's very strong, often dominating the domestics). Tom Holmes, Massachusetts, also observed the onset of "auroral conditions" about 9/20, and inquires with quaking voice, "Don't tell me the TA season is over this year already?!" Jerry Conrad, Kentucky, notes "good auroral openings to the south and west, but no TA's so far this season - not even Dakar." International DX'er of the Year, Mike Silvera, Jamaica, notes "a general improvement in conditions." In the West, Mike Northam , Orygun, says "Conditions in general seem quite good. The last two MMs have had very little noise for this time of year." Don <u>Reynolds</u>, California, reports excellent conditions, "This morning, 10/1 was excellent for Asiatics with Communist China and North Korea all over the dial with several new ones logged. The Burmese and Taiwan receptions (see Monitor Reports) have me all 'hepped up' for the season, hi." Although the TA season has fairly just begun, several members have already commented on the fact that the stns in Eastern Europe and the Near East usually heard by now are just not there this year. We've noticed this also - not even such regulars as Egypt-773 & 818, and Beirut-836 have not yet been heard this season, even on nights when reception from more westerly TA's was exceptionally good. While this may well be related to the current elevated sunspot numbers, the exact mechanisms involved are by no means clear. Much more information is needed about longterm reception patterns for the TA stations, and we urge our members to contribute their subjective appraisals of longhaul DX conditions from time-to-time. And remember that information about stations not presently being heard (but which were in the past) can be just as informative. Given sufficient information about such reception patterns, it may well prove possible to determine at least some of the physical and geophysical factors responsible for these patterns. Only then can meaningful work on actual prediction of reception begin.

On Reciprocal Paths. Most information coming from overseas still concerns loggings made during Northern hemisphere summer, but first information in from New Zealand indicates pretty good reception from North America in September. NZDXRA reports many N.A. loggings, including: WBZ-1030 excellent @ 0230 on 8/20; WOAI-1200 very good at 0638 on 8/19; KGER-1390 good @ 0353 on 9/9; KGEN-1450 very good 0135 on 8/20; WLAC-1510 excellent 0230; and WKWF-1600 good 0145. Better summer receptions of N.A. stations in Europe according to Benelux: CBH-860 @ 2215 on 8/7; CHER-950 @ 2055 on 8/7; WLOB-1310 @ 2157 on 7/7; and CKEC-1320 at 2130 on 7/7. According to press reports, there are some very high-powered MW stations now under construction in the Near and Middle East. For Example, the Iranian Radio is building a 2000 kw transmitter at a place called Qazvin. Unconfirmed press reports also state that in Lebanon, a MW stn of 3000 kw is under construction, while, in the UAR, a MW transmitter of even 5000 kw will soon be under construction. (RNYWWDXC) That American pirate, Radio Free America, should begin operating in just a few weeks and will be based on a ship off the coast of Catalina Island. The transmitter will be of 100 or 125 kw. (Bruce Henderson, Calif., via RNYWWDXC) Unconfirmed! (Ed) Saudi Arabia. Riyadh on 647 w/an Arabic program seems to give very good reception from 1400-1600. It must be the new 1200 kw xmitter. (Benelux) Watch this one! (Ed) A correspondent living near Canton, China, reports that there are hundreds of clandestine stations in China broadcasting anti-Mao propaganda. Also Radio Canton was captured by the anti-macists, but it was taken back by the Red Guard. In the Canton area, there are 10 clandestine stations operating on about 799, 898, 1180, 1220, 1440, 1480, 1493, 1510, 1525, and 1580 kcs. (SCDX) Note that one on 1525. (Ed) September 30 was an historic day in the development of the "new BEC"; all of their radio services have been renamed: Radio 1 (the new pop service on 1214); Radio 2 (the Light Programme); Radio 3 (the new name for the former light program); and Radio 4 (the former Home Service of the BBC London). (RNYWWDXC) Real imaginative names, those... (Ed)

The Worldwide Monitors Radio Club and the Canadian International DX Club are proud to jointly announce the Worldwide DX Competitions for the 1967-1968 DX season. A unique concept, the WDXC is a series of contests geared to the interests of all types of radio and TV enthusiasts (only MW contests listed here). The schedule:

November	6-12,	1967	Medium Wave	(535-1099 kcs)
February	5-11,	1968	Medium Wave	(split channels only)
April	1- 7,	1968	Medium Wave	(1100-1605 kcs)

All contest entries must be sent to contest central and postmarked no later than one week after closing date. Each entry should be accompanied by three 5¢ postage stamps for handling and mailing. Contests are open to anyone ... regardless of club affiliation. All entrants should, however, list club affiliation on their entry, merely for interest... it will have no effect on the outcome. In addition to the logs, the entrant should list all equipment used and especially the number of tubes of his receiver. Certificates of recognition will be sent to the first, second, and third prize winners... the first prize winner will also receive a suitable prize. There will also be periodic bonuses to all entrants. The contest periods will begin at 0000 local time and end at 2400 local time (e.g., the first contest will begin at 0000 November 6, and end at 2400 November 12)

RECEIVER HANDICAP

Your receiver is given a handicap according to the number of tubes as follows:

4 or less tubes: 2	9 through 12 tubes:	1.1
5 through 8 tubes: 1.5		1.0

(We note that the otherwise very well planned WDXC neglects to consider the DX'er with a transistor receiver - we're sure that the contest managers will rectify this problem soon. We suggest that a one-to-one correspondence between tubes and transistors for MW receivers would not be unrealistic. Admiral Nelson) The RAW score will then be multiplied by the receiver handicap figure. MW SCORING.

The WDXC has developed a new and more fair way to score ... a power times distance basis. To figure out the distance multiplier, find the distance from your shack to the station and round off to the nearest 100, then divide by 100. Power multipliers are: 50 kw or greater - 1 point; 10 kw - 2 points; 5 kw - 3 points; 1 kw - 5 points; 500 watts - 8 points; 250 watts - 10 points; 100 watts or less - 15 points. To figure out your RAW score (which will then be multiplied by your receiver handicap), multiply the two together as follows:

KFAB-1110	Cmaha, Neb.	1500 miles;	50 kw	15x1	15 points
KOIL-1290	Omaha, Neb.	1500 miles;	5 kw	15x3	45 points

Add all your loggings together (in this case would equal 160 points) and you have your RAW score.

RULES FOR 1967-1968 NATIONAL RADIO CLUB FOREIGN DX CONTEST

Manager: Ben Dangerfield, 202 Governor's Dr., Chester, Pa. 19013 Open: to all members in the NRC in good standing. Entrance Fee: \$.25 (one quarter) in coin or stamps. Prizes: Overall high scorer will win a beautifully engraved plaque; other prizes will be announced later. Many join just for the fun of it. <u>Dates</u>: for loggings and reports: 10-1-67 through 6-30-68. for verifications: deadline is 7-31-68 (for receipt of verifications) Scoring: 10 points for each continent* points for each country (per latest NRC official country list) 1 point for each 1000 miles to station, or fraction thereof 10 points for QSL'ing 5 continents* 15 points for QSL'ing 6 continents* (50 points for all 7 - good luck) 20 points for a country bordering on the Indian Ocean (re Australia: only West Australia counts for this bonus) *Continents: for contest purposes only : the 7 listed below: North America (foreign); South America; Europe; Africa and Near East Asia (count as only one); Far East Asia; Oceania; Antarctica. Proof of Reception: all stns must be verified, and all veries must be bonafide. This means that not only must the verie indicate intent on the stn's part to confirm reception (as judged on the basis of other QSL's recently received from the stn in question), but the contestant must be able to supply convincing proof of reception. All members should be prepared to submit carbon copies of reports and/or actual veries (or copies) to the Contest Manager if requested. In some cases, tapes will be acceptable. Entries from Previous Contests: can be entered again. This contest starts from scratch, but it's usually better to try new stations to avoid placing unreasonable demands on certain stns. Singleton-Eliminator Contest: NRC members (only) may of course submit veries to each or both contestsif applicable - the contests are independent and exclusive. Distance Rules: All stations outside the continental U.S.A. and Canada are open, with certain exceptions: for example, a person living in Hawaii cannot count stations in Hawaii, etc. HOWEVER, PLEASE NOTE THE FOLLOWING SPECIAL RULES: (1) Contestants on continental U.S. and Canada and the Caribbean areas can count U.S. and Cnaadian stns over 3000 miles. (2) Contestants in Hawaii can count U.S. and Canadian stns over 5000 miles. (3) Alaska, Hawaii, and Yukon will count as valid countries for non-residents, Divisions: will be set up later, probably (1) for the East Coast, which will include Hawaii and the Caribbean, and (2) for all other areas, including Central and West Coast. The object is to equalize by possible total points and not just by areas.

Entries: please submit date logged, date QSL received, name-location-frequency of station, and your point count. Do it <u>once a month</u>, at the end of the month. Final decisions are the responsibility of the Contest Manager and the IDXD Editor. Address all communications to Contest Manager. (Ben Dangerfield)

In a recent IDXD, we quoted, verbatem and without comment, an item from Don Jensen's NASWA section about the BBC's relay station in Botswana (602 and 926 kcs). C. M. Stanbury, Editor of Electronics Illustrated's "The Listener" section, seemingly in search of a new "controversy" now that the major part of the DX Community accepts that Radio Americas is indeed on Swan Island, submits the following item via registered mail:

"REGARDING THE VOICE OF AMERICA AND RHODESIA

In the IX/16/67 issue of the NRC's DX NEWS (IDXD section edited by Gordon Nelson) under the heading 'BOTSWANA' and referring to the BBC station, appears the following statement: 'the station was built at a cost of 1.4 million dollars, a fact that by implication seems to refute claims that the relay station uses one of the VOA transmitters on loan" (direct quote from NASWA's FRENDX - A.N.). This statement is credited to NASWA's Don Jensen. In response to it, I submit the following;

- 1. I hearbye (sic) state unequivocally that the BBC's Botswana station was put on the air with the use of American equipment (transmitter or transmitters). This statement is based upon an unimpeachable government source which I am not at liberty to reveal. Let us just say that secret agent T.X.Thrush told us out behing (sic) the U.S.Pavilion at Expo 67.
- 2. I do not know for a fact the exact nature of this equipment but, based on the other evidence, I presume it includes the VOA's portable 50 KW BCB unit. I do not know what significance, if any, that 1.4 million dollar figure has. Possibly the portable unit has now been replaced with permanent gear although I doubt it.
- 3. If anyone challenges point 1, I hearbye (sic) invite them to write the VOA and ask for themselves. Of course while writing they will also want to ask (A) exactly when the portable unit was secretly removed from Marathon, (B) why was it removed secretly, and (C) why Washington is keeping its part in the Botswana operation secret?

Quotation without Comment: from Hank Bennett's SW section in the October, 1967 issue of the Newark News Radio Club bulletin:

"Re Stanbury's comments in the October-November Radio-TV Experimenter on WNYW's fire to be somewhat odd and that they are using a 'secret' transmitter ... a lot of hot air!

"I have a source I'd like to keep to myself for the moment that WNYW just didn't feel like telling Stanbury what they were using ... hence his assumption that everything was a CIA hush-hush job. WNYW took leases on point-to-point transmitters from RCA in Riverhead, N. Y. and from I. T. & T. in Brentwood, N. Y., with FCC authorization. WNYW did acquire 3 Gates and 1 Continental transmitters, and then cancelled the RCA and ITT&T Leases.

"Somebody ought to clue Stanbury in that he ought not to put his foot in his mouth. This (censored by Hank Bennett) thing about Swan that he hops on all the time, and then got started on the Navassa Island bit all over again is a pain. He's going to ruin the DX hobby to the point no one can trust anyone regarding information." (name of letter-writer withheld by Hank Bennett).

Continues Hank Bennett, "This letter is typical of comments that we've been receiving with increasing frequency in recent months. Many DX'ers, in NNRC and in other clubs - including his own - have been asking me to try to throttle him. This I have deliberately avoided doing for it is no concern of mine or of NNRC's to meddle in the internal affairs of any other club. However, the last line in the abovequoted letter in (sic) exactly the way that many other DX'ers feel.

"This writer has wondered for many months just how it was that ASWLC (American SW Listeners Club - A.N.) managed to let him continue in his capacity as editor for them. We've wondered if the Officials of that otherwise fine club were reluctant or afraid - to relieve him of his duties. Certainly, no responsible group would find it desirable to have a person of his calibre associated with them.

"We have personally felt over a period of several months that perhaps - just perhaps, C. M. Stanbury would come to his senses and see just what he was doing to the DX'ing hobby as a whole. We have hoped - vainly, I guess - that he would cool it and become the really fine Editor; that we know he is capable of becoming.

"As I've already said, it is not our duty to meddle in another club's affairs unless it is an affair that threatens to undermine DX'ing in general. And this is exactly what we believe Stanbury is doing.

"Stan, as one Editor to another, we'd hate to lose you. But by golly, fella, you have got to do one of two things and you'd best make up your mind what it's going to be - and soon! (1) Change your ways; cool it; wise up; check your ravings before you have them published. (2) Get out of the hobby. It's your choice! We've had our fill!"

<u>Dave Thomas vs Electronics Illustrated/ C. M. Stanbury</u> suit goes to jury. We're sure that many members remember the amusing feature article that C. M. Stanbury wrote about ex-NRC member David Thomas ("The Strange Case of Radio WUMS") in the May, 1963 issue of Electronics Illustrated, the one in which Stanbury accused Thomas of having published a book "notable for its misspelled words, (and) its obscure currents of thought."

Thomas has chosen not to take this lying down, according to our reporter in New York City, and has instituted a suit for \$250,000 damages, plus punitative damages, for alleged character damage resulting from Stanbury's article. Assigned court docket No. 11416/1964, the suit (David F. Thomas vs. Fawcett Publications), will come to trial before a jury of 6 sometime in the future in New York Supreme Court at Foley Square, not far from New York City Hall. The attorney for the Plaintiff will reportedly be Julien and Glaser, of New York City; Attorney for the Defendant will be DeWitt, Nast and Diskin, also of N.Y.C. This, as far as we know, is the first major civil suit arising out of the DX hobby, and the first time that arcane and intangible thing, the individual DX'ers reputation, has come to the attention of the courts. The outcome of this case may well indeed set a precedent of major concern for all DX'ers - especially those concerned with authoring and publishing information of interest to the DX Community. Our reporter in New York promises to keep us informed about any new developments in this case.

"An Israelian business man and former pilot, 40 year old Mr. Abie Nathan, is going to start broadcasts from an old German gunboat 'Schalom' off the Israeli coast, which will be outfitted in Pireus, Greece. Peace messages will be broadcast to the peoples in the Near East." (A German reporter in SCDX) <u>Sounds like another fake</u>. <u>One of the most rarely heard TA's in North America</u>, Radio Sahara, in Spanish Sahara, formerly operating with a poorly constructed 2 kw transmitter on about 650, should now be an easy catch according to SCDX and the Arctic Radio Club, which report that the station is now operating on <u>656 with 50 kw</u>. Reportedly the station went on July 18th. Note Mike Bugaj's comment about a new RNE stn on this channel in 8/17 IDXD. Same station, or...?

Mike Silvera contributes the following corrections to the RFS Cuban List (IDXD 8/17): 950 CMDL Cadena CMKC, Guantanamo is here, not on 940.

1030 CMDW CMQ, Guantanamo is not on the air and has never been hrd here.

1550 CMDV Santiago off the air for over 18 months.

With regards to the following, it is just a matter of speculation as to which is where:

800 In late June a relay of Cadena CMKC was hrd on this freq; as it is a Provincial network (Criente prov.) it seemed reasonable to assume that this was CMKL Santiago ex Reloj Nacional.

850 On June 7th the main station of the Cadena CMKC was noted off the air and a much stronger signal was hrd on <u>800</u>. Although both CMKL and CMKC are listed for 2 kw, the latter seemed to be at least 5 kw stronger. On July 24th a weaker "Cadena CMKC" was hrd on 850. The conclusion reached here was that CMKC was on 800 and CMKL was on 850. However, since 8-2 the outlet formerly on 800 has been hrd on 840; this is believed to be a xmtr malfunction since stns in the same town will not be expected to remain 10 kcs apart. -30-
