

#### NRC MEMBER SURRENDERS

"I give up! Start mailing my bulletins 1st Class. By the way, each week's bulletin is from Il to 14 days late when it finally comes." - C. Hutton, Ga.

While our magazine format seems to be arriving at destinations a bit faster than previously in general, there are still strange and inexplicable delays every week. Boston Globe recently ran a series of experiments to determine just how fast mail is actually delivered and came to some interesting conclusions. Thirty nine First Class letters from Boston, New York, and Washington were delivered in one day; twelve others, however, mailed at the same time took two days - including all of the items sent airmail from Boston to NYC. According to the Globe the tie-ups occur in the huge Boston South Postal Annex through which all mail from this area must pass. South Postal handles about 10 million pieces of mail a year and each item is handled seven to 10 times before it's delivered. According to the Globe, "The balance of bulk mail - second and third class - is carried by trucks under contract to the Post Office which go to all points in New England, New York, and the South." DX NEWS is now being mailed on Friday evening; the local P.O. says Monday delivery is "almost certain" for First Class. They won't make even a vague guess for Third Class, however, so it looks as if Third Class members will just have to settle for third class service.

# Selectivity

The NRC has ordered a batch of mechanical filters for 455 kg [F r ceivers. The price to members will be \$16.50 - about half of what they go for in small orders. We expect the new shipment within a few weeks and these units will then be available for immediate delivery to all interested members. N'e expect to be running an illustrated "how-to-do-it" article on installing these units in the HQ180 very soon. Order from HQ.


### INTERNATIONAL DX Digest



Propagation & Features Gordon Nellon, 19 Irma Ave. Watertown, Mass. 02172

DX conditions have been quite auroral during the past week; high latitude TA's have been very weak and low latitude TA's only fair. Caribbean reception has been outstanding and reached a peak on 1/27. From Hawaii Richard Wood reports, "1/27 an outstanding morning. 3 new countries: Sint Maarten, Guatemala, British Honduras. Many Central Americans. Lots of interesting US regionals, no time to log all. Asia good but Burma-955 not as loud as I have heard it, though Phnompenh-1434 in early. F.s. - 1/14 and 1/15 showed a distinct slump vis-a-vis tip-top ex on 1/11 and 1/12."

Geomagnetic activity increased substantially on 1/25 and 1/26 which correlates very well with observed "auroral conditions". The following graph indicates the level of geomagnetic activity as measured by the Fredericksburg A index. Low values of A occur when auroral activity is low - high latitude paths such as those from Europe to the west Coast and Asia to the East Coast are then possible. A values above about 20 indicate high levels of auroral activity and associated high latitude absorption of MM signals; reception from the South is also often improved in Morth America. Low A values are a necessary but not sufficient requirement for high latitude MM reception. Stars indicate days with reportedly good high latitude propagation; "a" indicates observed "auroral conditions"; "l" indicates unusually good low latitude reception (e.g., from Hawaii).



On reciprocal paths Arctic reports no receptions of North American stations during the past couple of weeks. Around the first of the year the following U.S. stations were logged in South Africa according to the SADXC: WINS at 2308, WEAL at 2304, WWVA at 2300, WC.C at 2310, WIBA-1310 at 2310, WPEL-1380, at 2300, WGIL-1400 at 2330, and WCMC-1470 at 2315. No reports of SABC receptions in North America because of GRM from TA's here.

\*AFGHARISTAN. Nabul is now back on 1280 after a short stay on 1295. (ARC)

\*EGYFT. Latest schedule for Cairo's broadcasts to the Arab world ("The United Arab Republic Broadcasting Corporation, Cairo"):

Voice of the Arabs Program: 2200-1655 on 620, 0300-0500 on 708V Sudan Corner Program: 2300-0055 on 708V, 0700-1125 on 872 (Ed)

\*GREECE. A new transmitter on approximately 1611, announcing as Fokis Radio (Radio-fonikos Stathmos Fokidhos, Amfissa), is now being heard in Europe. Schedule is given as 0231-0830 and 1230-1530; programs are commercial with requests for records from all parts of Greece indicating considerable power. Joannia-1061 and Florina-1277 are also reported presently in operation. (Ed)

\*HOLLAND. Lopik 3 has extended schedule after making an agreement with Hungary and Ireland which also use 1250. Now operating 0300-1200 (February to October); will run 0300-1100 Hovember-January. (ARC)

\*ENGLAND. Crowborough is now operating with 600 kw on 809 and 1295; directional antennas. (ARC)

\*WEST BERLIN. BEC's 5 kw Berlin relay, formerly on 1295, is now on 809; relays only

German language programming. (ARC)

\*LESOTHO. Radio Lesotho is currently testing on 899 with VOA relays and music. (SADXC)

\*PAKISTAN. The Soviet Union has offered to supply Pakistan with 6 high powered MW transmitters between 1969-1971; Pakistan will probably take them according to Karachi Home Service. (Ed)

\*DOMINICAN REPUBLIC. ADD HIJM-1090, R. Amistad, Licey al Medio, Santiago, 500 watts to the list of Dominican stations in 1/25 IDXD. (Objio)

\*ANGCIA. According to a letter from the station, CR6RZ does not yet have an antenna capable of taking the full 100 kw from their new transmitter; a new one is expected to be completed soon and 1088 will then go a full 100 kw. (SADXC)

\*ISRAEL. Tel Aviv is now operating with 200 kw on 575. (Ed)

\*MUSCAT AND CMAN? BBC has announced that a "high powered MW station" will be available "soon" and will cover the Persian Gulf, South and Central Asia, and India. No location given but sounds like the projected Masarah Island relay station. (RNYWW)

\*QUOTATION WITHOUT COMMENT... Or, Coming of Age in Australia:

"Yes. it has happened at last: believe it or not, Melbourne now has six 24 hour broadcasting stations, more than any other capital city. Following the introduction of AN operations by 3AK (1500), this means that all of Melbourne's commercial stations are now 24 hours, which has just about sealed the fate for serious MW DX ing from this city, or within 25 miles of the city centre. Members will recall that some months ago we commented on this situation, referring to a letter from the Broadcast Control Board, in which it was agreed that spurious radiations did, in fact, exist on a large number of sum and difference frequencies, but which would be 'economically impracticable" to eliminate. Now that 3AK has installed a directional antenna to protect 2ES on the same channel, even more energy is being channelled into Melbourne, and the spurious signal problem is even more pronounced ... Obviously there is no point in bemoaning the service provided by six 24 hour broadcasters or complaining that these spurious radiations do exist; your Editor in recent weeks has finally woken up to the fact that this problem need not necessarily mean the end of MW DX'ing from Melbourne and it now seems that a certain "re-vitalization" has occured! Over the past month a prototype loop antenna has been constructed ... and provides a very formidable counter to the elimination of undesired signals caused by the six local broadcasters..." (Australian DX Club)

\*PUERTO RICO. WKYN-630 went all Spanish on February 1st. (Variety, via Cronin)
