New stations, changes, skeds, etc. . . .

BRAZIL Radio Apolo (also known as Radio Industrial) in Sao Paulo on 1370 khz has been closed down. (Tapsell, MWC)

CYPRUS According to a brochure from Trans World Radio, they are now using Radio Monte Carlo's relay on 1232 khz during the evenings with programs in Arabic, Armenian, English and French. No exact schedule is given. Also mentioned is the fact that this station uses a directional antenna with most of the power beamed to the East and South. This would make reception in NA difficult. (Winkleman)

DOMINICA The projected frequency for ZGBC is 1060 khz (See DXN, Vol. 41, #14). Station was supposed to go on the air in July. (MWC)

DUBAI The Dubai Broadcasting Station is now on 1248 khz, ex 1250. A new 600 kw. transmitter was due to start testing on 1480 khz in May. (NZRDXL, MWC)

ENGLAND The Liverpool Commercial Station, "Sound of Merseyside" is to be called . Radio City and is due on the air 10/1 on 1546 khz. (DSWCI)

HOLIAND There are plans for Hilversum I, 746 khz and Hilversum II, 1007 khz to increase power to 300 kw. These will not be a 24 hour operation. The present program on 1250 khz will move to 674 khz (this is with permission of ORTF). Fower will be 10 kw at first, with an increase to 300 kw (perhaps in early 1975) and a later projected increase to 500 kw. This will be a 24 hour operation. It is expected that the present 1250 khz channel will be used for a 4th program, maybe classical music. The suggestion that Holland will use 710 khz is inaccurate. (Burger, MMC)

INTERNATIONAL WATERS According to the Dutch Press, Abi Nathans "Voice of Peace" was sold some time ago to a group of Belgian businessmen. The ship will be the base of a new Pirate station called Radio Benelux, with headquarters in Leiech-tenstein. This station was to have gone on the air on July 1 on a frequency between 1425 and 1580 khz with a power of 9 kw. (NZDXRA)

PAKISTAN A new 150 kw transmitter at Quetta, on 750 khz, was opened on 4/26/74. The 1000 kw transmitter at Islamabad is due on the air next year. (MWC)

TURKEY According to a recent schedule, Istanbul on 1016 khz is indeed now 1200 kw. Should be worth looking for this winter. (ED)

UGANDA Kampala on 908 khz is now 100 kw, ex 1 kw. (MWC)

And now, whats actually being heard . . .

- 540 -NICARAGUA YNOW, Radio Corporacion, Managua. July 12, s/on at 1000. Looped correctly and many mentions of Nicaragua and Managua. No definite ID was heard. (CHOTI)
- 690 -MEXICO XETRA Tijuana, BC. Beautiful instrumental mx continuous 0600-0700. ID in EE at 0700 "No News - Extra Music" by man and short SS ID by woman. Fair/good level during the hour with only a couple of deep fades. 7/7.(ZANK)
- 730 -MEXICO XEX Mexico, DF "IA X, Radio 73" (setenta y tres not sesenta y tres as elswhere noted) is much stronger last 5-6 weeks than previously noted. New format of US & IA rock, mostly oldies on weekends, plus news, sports. Suspect now closer to licensed power. Note that many XE biggies run low power (XEB - 40 kw rather than 100) to save money. (Gleason)

THANKS FOR THE KIND WORDS FROM SEVERAL OF YOU. THEY ARE MUCH APPRECIATED !

In view of some of the membership statistics we've compiled over the years, plus several of those we here in New Jersey have compiled, plus some of those recently compiled by 1966-68 Publisher John Callarman, it would seem that the NRC must take a greater interest in the areas of membership recruitment, development and retention. Toward that end, we will be making several proposals to the Toledo Convention. We present them here for the benefit of the majority of the membership who will not be in attendance.

First, in the area of recruitment, we have already elicited much assistance from the editors of many of the mass-circulation electronics hobby magazines. We have gotten a small writeup in <u>Broadcasting</u>. We would like for one of our broadcast industry members to write a piece for trade publication which would briefly outline DX'ing, its purposes and origins; the value of reception reports to DX'er and station, and a summary of the NRC and its publications and services. Finally, we again exhort all of you to solicit names of reporters to stations you may visit, and forward the most likely prospects to H2 for sampling.

In the area of membership development, we have seen some increase in participation this year, however we could still use more. Not only reporage of DX or Musings are important, but short articles on equipment or techniques are welcome. We have requested these before, but the response has been small.

In the area of membership retention, we have achieved about a 50% return on our "drop letter questionnaires". Likewise, we have had over 50 re-joins of former members during the past season. It is our feeling that in most DX'ers who drop their membership, the DX bug still lives, waiting to be re-stimulated, and we must find a way to accomplish this. Toward that end, we have transferred our drop file for the past 4 years onto address labels such as we use for mailing DX NEWS each issue. This will allow us to periodically sample our former members, at a minimum of HQ effort.

In order for all of the above plans and schemes to succeed, however, there is an overall ingredient necessary. Namely, we must organise and maintain an active membership committee. This committee would be headed by one member, subheaded by regional co-ordinators, and staffed by local staff amongst the membership. The duties would be to contact prospective members whose names were furnished, and to try to convince them to join; to sponsor local get-togethers to promote more interchange among members, and to promote more activity in the club by the members; to welcome new members in their areas; and to contact members whose memberships are lapsing to persuade them to remain or to find out why they are dropping. This will require volunteers, and they will have to be willing to do some work for the club.

We trust that these proposals will receive favorable reaction from both the Convention and the membership as a whole. We will be publishing more information in our post-Convention report.

- 760 &-EL SALVADOR YSKL Net. These two in // heard 7/22 at 1120 w/talk. 760 much
- 765 better than 765, both quite strong and readable. I'm not even going to hazard a guess at which is which. (Gleason) I don't think the one on 765 has ever definitely been identified. (ED)
- 764 -SENECAL For some months now Rill Bailey and I have been observing what appeared to be a very strange propagation effect which seemed to produce a very rapid and characteristic reduction in Dakar's signal strength at a time that veries from night to night from about 2300 to past 0045. This drop in field strength usually occurs within about an hour of Dakar's s/off time (which varies considerably from day to day) and shows up very clearly on stripchart recordings of signal strength. After puzzling about this for months, Rill finally sent a letter to Dakar and a reply from the Director General, Alicune Fall, confirms that they do cut power from 200 kw to 10 kw around 0000 GMT on 764 khz, although they give no explanation as to why they reduce power nightly about an hour or so each night. (ED) /(Cleason)
- 850 -MEXICO XEUS Hermosillo, Son. 7/20 0245-0300 w/off. US style progressive jazz, segued selections for 15 minutes, then s/off, mentioning also XEUDS-6115. Said would return to air at 10 AM local time. Never noted before.
- 880 -CUBA GMAF Pinar del Rio, R. Frogresso IDs with distinct null right on Cuba at 1000 7/15. (GHOTI)
- 900 -BAREADOS S/on 0930 w/Trumpeters Lullaby. Was excellent during Feb/Mar. Channel effectively clear save for Cuba and bits of CHML. A tip as the new season rolls around. (GHOTI)
- 910 -MEXICO XEAO Radio Mexicana, Mexicali, BC; w/SS vocal mx 0550-0610. ID in SS "Radio Mexicana" given at 0500. Fair level in solid for the 20 minute period. I was quite pleased w/this one as Mexiglen list and WRTH list as only 250 watts. 7/8. (Zank) /(Gleason)
- 997 -MEXICO XECC Cd. Camargo, Chih. noted again here 7/20 all evening, with very distorted, but loud signal. Mx of all kinds, plus local ads, ID as "Ia Doble C". This spur is heard only occasionally so may be intermittent.
- 1250 -MEXICO XEPI Tixtla, Gro., "Ia Voz de Querrero desde Tixtla" s/on 1200 7/21. S/on theme is "Little Serenade". Covered one minute later by XEDK. This is among my "Top 10" XE's. 100% readable, and in July! (Gleason)

- 570 & -MEXICO XENZ La Joven del Cuadrante and XEBL Su Rancherita Consentida,
- 710 Culiacan, Sin. v/l after 2 f/ups from Juan Perez Salcedo, Gerente Adminsitrativo at Radio Nucleo del Pacifico, 5 de Febrero No. 50 Ote, giving night power of each as 250 watts. (Gleason)
- 580, -MEXICO XEFI Radio Mexicana, XEFO "Ia F-O" and XEFA Radiorama, Chihuahua,
- 680 & Chih. v/l after f/up from Lic. Jose Conzalez Caballero, Gerente General at 950 new address of Av. Juarez No. 223. Gives full power information on each station. Confirms XEFA as 500 watts. Group also owns XEBN, R. Delicias in Ciudad Delicias. (Gleason)
- 737 -ISRAEL. Following our initial reception of Israel on 12/9/72 as reported in IDXD, both Hal Robie and I sent reception reports to Tel Aviv to which we received no reply. Hal sent a f/up report which was replied to late last year with a letter from Sara Manobla of the English Department saying that she had checked w/the Foreign Language Dept. who had informed her that our reception could not have been Israel on that date because the station was programmed in Arabic and would have already been off the air at the time of our reception on the date in question. Fine and good but Robie, Moore and I all had tapes of the reception w/fairly good and clear mentions of "Kol Israel" plus a definite Israeli National Anthem at s/off. So I culled out the highlights of the hour-plus of tape that I had kept from that night and sent them off to Sara with a request that she forward them to the Engineer-Im Dept. In the letter just received she says, "I passed on your letter, Gordon Nelson, to our engineering dept., and have their comments. They confirm that the broadcast you monitored was the Israel Broadcasting Authority's night transmission in Russian. During the past two years our broadcasts are at different times and on different wavelengths. With many thanks (Cont)

- 737 -ISRAEL (Cont.) for your interest and for your perseverence!" Sara Manobla, Head, English Department. A good example of how the "front office" in a broadcasting system may err in verification but a taped library can straighten things out in the long run ... (Nelson)
- 863 -BULGARIA Finally received a reply from my tentative report of 1/26/74 and I kinda wish they hadn't bothered. Letter states in part "I am sorry to tell you that we can't send you a QSL card, because you have listened to Radio Elagoevgrad, not to Radio Sofia". Now the question is, did they actually listen to my tape, or did they just take my tentative ID? Sure would like to count this, but can't do it. No copy of the tape, either. I've just got to get a second recorder! (ED)
- 902V-THE GAMEIA The unid West African station reported here in IDXD last Nov. on a frequency varying from 902 to 907 khz w/old US pop records and alternating man and woman announcers has been positively identified as the 5 kw Radio Syd, Banjul, station as previously suggested. In a definite v/l from Constance Enhorning of Radio Syd, they confirm our reception of 11/16/73 and comment that "as you suspect we actually had some problems w/our xmtr during that time. We had been off the air and were trimming the xmtr." The "exact frequency" is given as 908 khz and the schedule is from 0600-0200 local time in English, French, Wolloff, Mandinka and Swedish. Gambia makes country #128 and we wouldn't have had a ghost of a chance of clearing up this unusual reception if the high precision direction finding hadn't been been so good for this West African station. (Nelson) Nice! (ED)
- 1020 -ARGENTINA LS10 Radio del Plata. Finally did get a nice v/l. Signer is Deloras Ayerze, Secretaria. Sez the program I taped was "Transnoches Modart" which is on every day 0200-0500 local time. (Starr) 815! (ED)

1050&-MEXICO XED and XEHG. V/l after f/up from A. Maldonado Sotomayor, Gerente,

- 1370 at P.O. Box 84, Calexico, Calif. 92231. I quote, translated, "Although we do not generally confirm reception reports for our stations, on this occasion we will with pleasure, after having checked that your report is correct." If anyone has this group out and unverified, a polite letter in SS might do the trick. (Gleason)
- 1280 -MEXICO XEBW Radio Variedades, Chihuahua, Chih. v/l after 2 f/ups from Oscar Valles Vidal, Gerente at Edificio Eanco Provincial del Norte, Piso 16. He sent 6 very nice postcards, long letter, and said a collection of Mexican music on records was on its way as a gift. Also invites me to visit them if in Chihuahua. (Gleason)
- 1410 -MEXICO XECF Los Mochis, Sin. v/l after 2nd f/up from Apartado No. 182. V/s not readable. States night power to be 500 watts, slogan as Radio Impacto. (Gleason)
- 1470 -MEXICO XEBBC Tijuana, BC v/l from Jose Ma. Sanchez Sanchez, Sub Gerente at Apartado 1470. Says other f/up and original report not received. (Gleason)




