MM 2/10: WPUT-1510 good at full power, fair at 50w., poor but readable at 4.2w: Fait (OH), HWB, Starr, FED(CT), RKS (NYC). Hrd only at full power: Murphy and Hansch (WI); Not hrd: ERC. Hrd at full & 50w.: Gary Atkins, (KY). WNNO-990 not hrd by TRS, HWB, Starr, RjE, BF. Tentatively w/TT: Murphy, ERC. Like a local (which it is) by Hansch. WGIL-1400: No by BF, RjE, RH. Hrd TT & code IDs only: TRS & WM. Hrd also by HWB, Starr. KKSI-1130 not hrd by WM, BF, RH, ERC. KAVR-960 not hrd by RH, WM. The WEEL-1310 test was cancelled. WICH-CT showed up w/ET in that period per FED.

FM 2/lh: WSNG-610 hrd only TT by Foxy. Tentatively by ERC, and not at all by RjE & RKS.

MM 2/17: WMBG-740, again, no sign, per RjE, PT; WEJL-630, hrd TT 0045-0130+++ but no IDs at all by RjE, PT & ADD (also NJ); WCRV-1580 wasn't on per ADD, PT, RjE. WSRF was there, was was WAMM (just bl 0300 per ADD). WSRF on all AM. F/c from WORV & WKIG also hrd by RjE, ADD. WIBA-1310 hrd w/ code IDs only by RjE u/CKOY etc., WBFN-1500 hrd atop channel w/mostly TT, few IDs by RjE. KCRL-780 no info.

OTHER: Per Pogue, we ex were good 1/27 & 2/3. Per Hansch, WIBU never had of an NNRC TEST as listed per their PD. Per Foxy, CHTN-1190 got their 10 kw rig in on 1/22, went off AN until 2/7 to install it. Are now 10 kw U2 and much weaker than lkw NDA, but quite readable u/ Cordillera on 2/17 by RjE.

Its time for another HMMD thing. Quite a few reports received, and judging from one from Den Dangerfield, there have been some fair TA openings. Unfortunately, all of ye ed's DMing has been of the domestic variety last MM, so I missed it. If anyone noted anything of interest, let us know.

New stations, changes, skeds, etc.

ALDANIA - Contrary to the report in 1-20 DXN, Tirana is still using 1088 khs to sign off at 2300. (MWC)

AUSTHALIA - 800 is a new 500 watt station on 990, relaying the N.T. net (didn't catch location-GH); 2CN Canberra has moved from 1540 to 1440, opening 1540 for the new 23J in Sydney, a 24 hour rocker of the ABC; (VL)5UV, Adelaide University Radio is the first such station granted a full broadcasting license, and begins transmission in February on 1560 khs, with 600 watts, ex-1630 khs. (Arthur Cushen's DX World, NZBC via Hauser) (This updates info in the 1975 WHTM)

BAHBAIN - Under construction is a new station to operate on 570 khz with 50 kw. Seed 0400-2200. No opening date announced. (MNC)

BUIGARIA - A new 500 kw transmitter is to come into operation shortly on 1322 khs beamed to South Europe and the Near East. Sked 0530-2130. Hadio Sofia also uses 575 khs from 0530-1630 and 1223 khs from 1630-2130 and 0130-0330. (MRB) * MNC reports that 1322 is on the air and noted at 1830 with Hadio Sofia Programs Horizont.

CAMERDON - A new transmitter center is to be built at Ecos near Yaounde and will consist of 3 x 20 kw MM transmitters plus SW. Expected to be in operation within 30 months. (WHB)

INTERNATIONAL WATERS - A broadcast by Deutsche Welle says it appears that Hi Amigo has found a loophole in the Belgian BMCA. Seems a Pop Music paper is selling space at a very high cost - too much for such a paper and the Belgian Government thinks this is how Mi Amigo is getting the commercials. It could be hard for the Government to take action. (MMC)

ISLE CF MAN - The Commission set up to investigate Manx Radio has now reported and among the sweeping reforms suggested are that the station be leased to persons interested in running it and paying the I.O.M. Government an agreed percentage of the profits. One person interested in taking over the station is Bandleader/Musician Runnie Aldrich. Also suggested is that the FM coverage be improved and the HW frequency of 998 khs be used with 5 km. The report has been favorably received and something may well come out of it. (MMC)

MALAYRIA (West) - Note that 200 km transmitters are now listed in WRTH 75 for Radio Malaysia on 590, 720 and 885 kms. (Hauser)

MCMACO - 700 khs is a new frequency for Endio Monte Carlo, monitored all day by EEU, as reported in the Arctic Radio Club, and repeated on Radio Australia's DI program. (Hauser) Yes, 700, not 701, was the frequency given by R.A. amnouncer, who has been known to get his digits mixed up. (Hauser) Provious reports have this one on 701. (ED) (Sorry about that Clenn, but this is still Monneo to me, ED) * Directional antennas with 600 km are being tested on 1466 khs, and power is to be increased in the spring, per TWR's DX show. (Sundstrom)

MORDOCO - A new station at Tarfais opened on 9/25/74 on 1052 khs. (MHC)

NEW ZEALAND - NZBC ac new MW stations recently: On 1120 kh., 4YQ in Queenstown, 100 watth sk 0 (this info conflicts with WRTH 75); and on 1410, 2YM (or 2YN ? - H) n North, carrying the National Program, 24 h. Radio Neder and, via Hauser)

OMAN - This country has been noted in Scandanavis on a frequency varying between 1270 and 1290 khs. Noted in South Africa on 1272, 1279 and 1283 khs. Sked on 1272 khs with 10 kw and on 1279 khs with 100 kw. (NRB)

SOUTH MORRA - HIDA-1570's second harmonic on 3140 khs has been heard not only in Japan, but also in Pakistan (Galkin) and California (Bob Hill). (Calkin's Asian DX Report on Radio Mederland; Hill's logging report section in FRENDX; and Radio Japan's DX Program, via Hauser)

TURKEY - Radio Ankara's DX Show on 2-8 indicates the domestic channels now used by R. Ankara (from 1w1) are three: TRT-1 on 1500 meters, TRT-2 on 1648 meters and TRT-3 on 202.2 meters. This corresponds to 200 khz (1200 kw announced), 182 khz (1200 kw listed) and 1483 khz (announced, no power given). Would speculate that this is actually 1484 khz with 2 kw, as Radio Trabzon with 2 kw is already here (and a 1 khz het would be sudible in central areas of the country), on a maww from 701 khz as this was not mentioned. 701 khz probably had QBM from Istanbul also on 701 with 150 kw just 170 miles away, and there is 360 miles seperating Ankara and Trabson. TRT-1 and TRT-3 would be new. (Sundstrom) * Izmir on 926 khz is now using 200 kw. (MMC)

UPPER VOLTA - According to Redio RSA's DX show of 2-5, the outlet on 737 khs (100 kw) has extended its sked to 2400 (from 2300). Outlets announced as being in parallel are 1340, 4815 and 7230 khs. Note that 1340 is only listed in the by-frequency section of the 75 WHTH; it looks like that was omitted in the country listing. (Sundstrom)

USSR - Archangel is now on 908 khs, ex-231. (MMC)

777 - An advisory committee to the USIA recommends construction of 2500 kw transmitters for the VGA to "obtain superiority" over the 500 kw outfits of other major nations. (QST League Lines, Jsn. 75, via Houser) (Probably pertains to SW, but such power is equally inconcievable on MW! -GH)

- 540 -DOMINICAN REPUBLIC HICM Santo Domingo, Radio ABC 2/1, heard u/CBT s/off at 0400, ID as "R. ABC". (Peterson) -UNID 12/21-27 at 0930-1030, nx in SS. No ID heard, but I did hear jingle "Ia --- Nacional after every 3-4 nx items. Anyone know who? (Peterson)

555 -ST KITTS ZIZ Basseterre, 1/28 at 0230 and 0300 w/ID as "R. 555 St Kitts". Plays US tunes. Much QRM from local WGAN-560. (Peterson)

575 -UNID Unknown here. Three sets of very beautiful chimes sounded at 1259 on 2/9. No Kremlin Bells here. Went into RR at 1300:30. (Wilkinson)

584/5-USSR FES (Svobodnyi?) in at 1145 on 1/29. Kremlin Bells for 45 seconds at 1200. (Wilkinson)

600 -DOMINICA Radio Dominica, 1/28 at 0340 heard "R. Dominica" on 600 u/CFCF o/SS Much QRM from CFCF. Many of "R. Dominica" and also as "Radio Dominica Marco del Tiempo" and "Radio Dominica Horizonte". Could they have changed freq as WRTH lists them on 595? (Peterson) They are definitely on 595, noted this past week. Also, Dominica is all KE; never reported in SS that I can remember. (ED)

625.5-COSTA RICA TIXE San Jose, Radio Omega 2/10, American pop (old rock) mx, sig noisy at best, 0340+, finally one good positive ID in clear 0440. These the old TIRICA facilities? (Sundstrop)

- 630 -CUBA 1/27, may now be running low power MMs. Foxy told me he was either off or on low power 1/20, on 1/27 running very low in jumble w/CJET atop freq. Cuban on 640 holding forth with usual signal. (Sundstrom)
 - -CUBA CMQ Havana, 0540 2/3 faintly u/KFI's religious program w/male and female ancrs giving nx. Heard often u/KFI whose towers are approx. 100 miles away. A strong regular when KFI is off the air. (Lobel) * 1/22 at 0505 ID as "IA Habana, Cuba" w/unid under. Many mentions of La Habana. (Peterson)

-VENEZUKIA (Unid) 1/23 s/off at 0400 w/NA. Didn't hear ID clear, but did hear "Venezuela". (Peterson)

-UNID 1/22 heard ID at 0500 as "R. Capital" o/CMQ. (Peterson)

645 -PARAGUAY ZP19 Coronel Oviedo, Radio Caaguazu presumed. Man and woman w/ads 2/10 0915; splatter from 640; Asuncion sunrise this date about 0930, per SPEEDX table. (Hauser)

647 -ENGLAND BBC Daventry. Have been hearing the BBC Foreign Service here early

in the evening, such as 0215, 2/11. (Dangerfield)

647/8-USSR FES (Location?) W/Kremlin Bells at 1100 on 1/30. (Wilkinson)

650 -HAWAII KORL Honolulu weak u/HJ QRM 1/27 0758 w/phone-in show, BBB PSA, "Reasoner Report". No ID but PSA confirmed as coming from KORL. (Forth)

660 -HAITI 4VUE Port-at-Prince, "Radio Lumiere" atop of everything else at 1040 on 2/10. Rasy catch for WCers. (Wilkinson) -NICARAGUA YNAM Managua "Mi Preferida les desea .. mejor suerte en el futuro"; 2/10 0918; American romantic mx in EE; a het above 660, this stn is. (Hauser) -VENEZUELA YVNA Coro, w/good "Ondas de los Medanos" ID after each selection on AM of 2/3. (Wilkinson)

665 -PORTUCAL/WEST GERMANY Very strong (Lisbon mainly) around 0200 2/9-10-11, w/the second carrier causing severe and rapid fading. Sometimes SWF on top. (Danger--USSR FES (Location?) w/Kremlin Bells ID at 1230 1/29. (Wilkinson)

690 - CUBA CMBC la Habana, R. Liberacion, 1/28 at 0935 w/ID "Radio Nacional de la Habana Cuba". (Peterson)

699.4-COSTA RICA TIHE San Jose, R. Reloj hetting WIW, 2/10 0845 710 -MEXICO XEMP Mexico, DF, Radiorama is now "Radio Dos", as heard 200 and 100 and 10 record offer, 7 digit phone beginning w/5 (invariably Mexico City); some ripple, whoop-WHOOP-WHOOP as on the other digitally identified Organizacion Radio Formula stations. (Hauser)

720 -UNID 1/15 something that sounded like a BB game. Heard an ID at 2200 as *Cadena Oriente" / WGN and SS/o (?? ED). (Peterson)

728 -EAST GERMANY Berlin/Koepeneck the best of the E. Detween 0200-0230 on 2/11. (Dangerfield)

740 -SOUTH KORFA HIKG Taegu in the clear at 1041 on 2/3. (Wilkinson)

780.3-CURA The drifter measured here 2/10 0730; E-naturally. Surprised WREM hasn't donated them a crystal. (Hauser) Freq 780.33

834 -BELIZE Radio Belize on 2/1, announcer giving power as 50 km, not 20. R&B mx, IDs, TCs, prayer at midnight, s/off 0500. (Fait) Please submit all material to IDXD in the same format that it in - its dificult and time consuming to read through a letter a try to pull the tips out. Thanks. ST LUCIA R. Caribbean, Castries in good 12/27 at 0000-0030 w/religious type EE lessons of the day, then man in FF. Lost to WHAS from time to time, but listened until s/off for ID in FF at 0203. ID as "Ici Radio Caribe International, Ste. Lucie, emettant sur 840 khz" w/NA. (Peterson)

-ITALY/UNID 2 Hz het noted 0512 2/3, any ideas? (Schatz) Yes, but not about (Wilkinson) this. (ED)

-PERU MILLA Lima, Radio Nacional del Peru very strong at s/on at 1102 on 2/10. -SOUTH KOREA HLKN Mokpo in the clear starting at 1032 on 2/3. (Wilkinson)

-ARMENIAN SSR Yerevan, a real surprise just after 0200 on 2/11 w/morning calisthenics. Strong and clear, and best sig from there in 10 years. (Dangerfield)

-MONTSERRAT ZJB Plymouth noted 2/10 1015 w/hymns in EE. Must start looking for a Malaysian SAH. (Hauser) Dreamer (ED)

-HONDURAS/UNID On at least two occasions a signal has been heard behind R. Panamericana. I think it loops to Angola, so it is of enough interest to report. I note R. Ecclesia, Luanda is listed as 24 hours. So far I can't seperate enough of the sig for a report. Hrd last 1/31 at 0300. (Dangerfield)

945 -HONDURAS HRYW Tegucigalpa, Radio Panamericana had just about the best sig I've ever heard from them 2/3 between 0525-50 w/the usual program of pop and light classical mx. (Krejny) Where can I get a selection of those bolts? They're just what I need for some of my projects. (ED) I'll be at YAD!

9700 -SOUTH KOREA HLCA Seoul atop of freq at 1327 on 2/9. First time this season.

-UNID CC speaking stn in the clear at 1304 on 1/29. (Wilkinson, last 2) -MEXICO XECL Mexicali, BC 0600 2/3 w/"Musica Moderna" ID. (Lobel)

| COLOMBIA HJDP Neiva, "Radio Colosal" heard w/frequent IDs around 1018 on 2/3. (Wilkinson)

1010 -JAPAN JONR Osaka in at good volume at 1016 on 2/3. (Wilkinson)

CHTN went on the air Christmas Day, 1974, as Atlantic Canada's premier sports station, programing easy listening music from 9:00 A.M. to midnight and M O R from midnight to 9:00 A.M.

Our studio location is 1190 North River Road, West Royalty, P.E.I., with transmitting facilities at Rocky foint, Prince Edward Island.

CHTM operates a 10,000 watt RCA transmitter into a 3-tower antenna array, with an overall height above sea level of 243 feet. An omnindirectional radiating pattern is used during daytime hours, and the full array is employed to affect our night pattern.

CHTN is presently operating with a temporary power output of 1,000 watts, Conversion to 10,000 watts will take place in February 1975.

MEMORANDUM TO CLIENTS

Re: Emergency Presunrise Sign-On Time Reinstated

The Commission has reinstated last year's emergency presunrise sign-on times for qualifying AM daytime broadcast stations for the period February 23 to April 27, 1975.

Under last year's emergency presunrise sign-on procedure stations assigned to U.S. I-A and I-B clear channels \(\frac{1}{2} \) and presently ineligible for presunrise service authorization (PSA) were allowed to begin operation one hour before local sunrise with 50 watts power. Stations operating on these channels which held or were eligible for PSAs of less than their 50 watts were also permitted to begin operation one hour before local sunrise with 50 watts power.

The Commission has now also authorized U.S. daytimers assigned to Bahamian and Canadian clear channels to operate one additional hour immediately preceding local sunrise at specified power levels under agreements recently concluded with these countries. A copy of the Commission's Order, which will contain a listing of the stations affected under this new authorization along with the specified power level that the stations may operate at, will be released by the Commission within the next few days and a copy sent to all affected AM stations. Additionally we will advise each of our affected clients as to the applicability of this new authorization as soon as the listing is released.

It should be noted that the emergency presunrise operation cannot commence earlier than 6:00 a.m. local time, must be appropriately logged and a description of the method used to reduce power to the level specified must be entered into the maintenance log. All affected stations are to revert to licensed and/or authorized presunrise authorization modes of operation at 2:00 a.m. April 27, 1975.

The only unhappy group of broadeasters to respond to the commission's proposals were class IV stations. Community Broadcasters Association, representing various class IV licensees, sought the inclusion of class IV stations in any relaxation of power requirements that might evolve and urged the FCC to grant a 1 kw nighttime power authorization to all class IV stations.

The FCC, in initiating the debate over power increases, noted that less stringent acceptability standards might necessitate a modification of the commission's "suburban policy" which requires suburban stations, whose SmV/m daytime contour (the signal strength the FCC feels is necessary to provide a good primary signal over a city) penetrates much larger towns, to prove they are not intending to serve the larger city.

FCC Revokes 5 Radio Licenses Of Star Stations

Agency Cites 'Misconduct' By Omaha Businessman In Unprecedented Action

My & Walls STREET JOHNSON, SING REPORTS WASHINGTON-The Federal Communiautions Commission, in an unprecedented action, revoked the Ecouses of the radio stations owned by Star Stations Inc., a conpany \$1.2%-owned by Don W. Burden, as Ownaha Inanimentation

The FCC rarely denies renewal applications. It has turned down fewer than 50 for radio stations, since 1934, although broad casters must renew their licenses every three years. But the agency said that the "pervasive and continuing misconduct demonstrated in Burden's operations of the sta tions" made the license denials necessary Among other things, the FCC found that Mr. Burden's stations gave over-the-air favors to two U.S. Senators during their election campaigns.

Affected by the order are WIFE-AM and FM in Indianapolis; KOIL-AM and FM in Omaha and KISN-AM in Vancouver, Wash. The agency also assigned the license of WIFE-AM to a competing group, Indianapolis Broadcasting Inc.

Beyond Recommended Ruling

The commission's decision went considerably beyond the recommended ruling by an administrative law judge in 1973. That decision recommended the denial of the WIFE-AM license but the renewal of the other four ticenses.

CKLG returns, strike goes on

and FM operations were being run with an appearance of routine Sunday after a strike Saturday caused the station to broadcast 24 hours of a "commercial-free weekend" from its transmitter sites.

The strike by members of the recently-certified Canadian Union of Public Employees (CUPE) Local 686 included incidents of minor violence Saturday when pickets refused station management personnel access to the CKLG building at Nelson and Richards.

Organizers said the strike is the first at a private radio station in a major Canadian city and is part of a bitter unionization struggle at CKLG.

Pickets were restricted later Saturday to eight CUPE members in an ex parte injunction granted Moffat Communications Ltd., the radie station chain which owns CKLG, by Mr. Justice Harry McKay of the B.C. Supreme

Management personnel reentered the station without incident about noon Sunday and/ reinstituted normal operations with the help of some nonunion staff. CUPE members. who are striking for a first contract, continued picketing outsidé

Union members left the station Saturday at about 11:30 a.m., leaving a continuous tape broadcasting a strike announcement and an old union song, "You Can't Get Me, I'm Part of the Union" on both AM and FM.

About 30 union pickets outside the station soon were joined by other union members and leaders, including president . George Johnston and secretary-treasurer Len Guy of the B.C. Federation of Labor, and Oy Stairs, president of the B.C. and Yukon Building Trades Council.

New Westminster NDP MP Stu Leggstt also arrived to express support for the strike.

Shortly before noon, CKLG general manager Don Hamil ton tried to enter the front door of the building but was stopped by pickets who stood in front of the locked door.

Shortly afterward, news director Larry Sell also tried to enter the building. A BCTV

Radio station CKLG's AM News film televised Saturday night showed Sell being roughly pushed away from the door but it was not clear who had shoved him.

He said "it wouldn't surprise me" if the company brought in strikebreakers to work at the station. The local would provide no physical resistance to strikebreakers, "however, local 686 doesn't speak for the whole labor movement.

The CKLG local has signed up about 33 of a possible 46 members for the bargaining unit. The local was certified by the Canada Labor Relations Board in August.

Mitchell said the CKLG strike is the beginning of the end for mon-union private radio stations.

'As 'LG goes, so goes the nation," he said, "There's no question of losing it '(the strike). It can't happen. Organized labor won't permit it to

"This is one of the last bastions of paternalism in our society," he said. "This isn't a radio station keeping out a local. This is the Canadian Association of Broadcasters keeping unions out of private broadcasting as long as they

"The transmitting towers for radio station CKJS!"

That's the kind of joke which will be making the rounds come the end of ruary.

That's when CKJS expects to go on the air, broadcasting in 15 languages and becoming Manitoba's first 'full-time ethnic radio station.

And when station owner. Casimir Stanczykowski says full-time, he's not kidding. The station will be on 24 hours a day.

In English. In French. In German. In Urdu. In staffers, with Manitobans Ukrainian, Polish, Czech, getting first preference. Ukrainian, Polish, Czech, Slovak, Greek, Portuguese, Filipino, Yiddish, Hungarian, Dutch and Russian.

It will all be in AM and available to 85 per-cent of Manitoba's population, to according Stanczykowski.

It will broadcast on 810 on your dial with a power of 10,000 watts from four transmission towers in St. Norbert.

The programming, mostly ethnic music and news, will be in the time proportion of 60 per-cent French and English and 40 per-cent ethnic languages.

Why did he choose Winnipeg for his second ethnic station?

Mr. Stanczykowski says the 1971 census revealed that 60 per-cent of the residents of Greater Winnipeg are of an ethnic neither French nor English background, and 25 per-cent of them use their ethnic language at home.

It must have been at least a year since last report, so it's time for a few lines. Work sked & generally rotten CX have limited DX, not to speak of general lack of stations to be DXed this neck of the woods. Winter CX are mostly Auroral w/few stations making it in, & Summer DXing is more interesting. Best time for dial twisting here is between 3 & 6am LT when you can hear WCs s/on. SM 1/26 produced only six stations besides the locals. That is, a total of nine listenable stations on the whole dial. Hello folks. I have to agree 1,000% with Paul Mount & Eric Fader's observations for the following reasons. I too occasionally travel a short distance to a quieter locale, not to purposefully evade rules that someone else arbitrarily tries to legislate to suit their superior location & circumstances & cut down the other DXers score in the ratings. I can hear better DX just three miles away not because of any more nulls, but because it's not so electrically noisy. This is well within the 25 mile radius. Why take the fun out of DXing? I essentially agree with Glenn Hauser's position - better to light a candle than curse the darkness! I call your attention to Supre macy Ratings. How many reporters list their actual location, say within ten miles? Refer to DX NEWS of 12/16/74 in the article, "Count 'em, Bunky", for what I mean. Ron Musco lists location as New York City, yet he really lives in Windsor, Conn., more than 80 miles from NYC. George Kass lives in New Haven, but N.Y.C. is listed & there are others too. Why? Flexibility & Mobility! Why be so narrow when it's resourcefulness that counts in the DX game, whether it's a better RX like the HQ-180 or for that matter, the ADVANTAGE of two RXes for simultaneous DXing (DX twice as much as the other fellow in a certain allotted time. Where does that leave us "poor folk"? But that's another matter - or is it?), or whatever antenna, or various antennas in a location of 25 miles radius? Then in Foreign Supremacy Ratings each member is listed by STATE, yet a state is generally accepted to be larger than 25 miles, & some of those reporters are outside the state they list! So I say there is a better way: If someone wanted to legislate equality for every DXer in the USA, why didn't he decree that everyone must use a particular seven-tube or transistor RX with the same length antenna? Obviously all the arguments presented are self-defeating or self-serving. The 25 mile rule can be termed "the equalizer." The oldtimer DXers who wisely instituted it no doubt envisioned the current malaise. Therefore, the longstanding 25 mile Club rule is MY standard & no one is going to tell he otherwise. Where I do disagree is that I think the Pages this subject already has consumed here in DX NEWS is unwarranted. It could have been used for IX news instead of controversy. Who brought it up, anyway? This info, provided by my contact at the station, appeared recently in DX NEWS. This reporter has now learned the new XR arrived 1/22 & since then they were off the air each night from 12-6am their time for installation. This explains their not being heard here MM 1/27 and 2/3. As of this writing 2/10, they're running 10kw & they were heard here quite a few times in the evening, too, mostly just after WLIB s/off. My contact believes they 're using their DA now but apparently it needs work, owing to their signal strength. They do plan on operating AN-7. Their engineers have "several" reports that should be answered soon. Perhaps not so coincidentally, CFCY-630 was heard for the first time ever here SM 1/26 & with an equally good signal MM 1/27, as they are also NSP. Turns out they were heard almost every night since, when checked, for almost two weeks but during the early part of Feb. he has once again been missing. I got some very clear, loud signals from them, taped. I guess it must be a record, adding two new PEI's in less than a week, hi. Any ne getting an SPR-4 for IW should find out about alternate antenna hookups or pre-selectors first. Actually many modern RXes that tune LW have this problem. Jim Hagan's approach (use of an up-converter) is a good alternative, or one can look for a TRF-type RX on the surplus market. 73.

TO PAUL MOUNT: Your 1490 unID was said by me to be likely not WLDB because the route numbers you mentioned are not NJ-type numbers and do not exist anywhere near Atlantic City. Maybe MD? -R1E
