TRAVELERS' RADIO DIRECTORY --

A Review by John A. Callarman

A new 180-page publication listing AM and FM stations in the United States by state and by format has been received here at WMIX in the midst of my compilations for the new NRC Domestic Log. It is called the TRAVELERS' RADIO DIRECTORY, subtitled "Your Kind of Listening While You Travel," and is for sale at a price from Paananen & Paulsen Corp., P.O. Box 365, Waite Park, MN 56837.

The directory represents a massive effort to compile for the traveler a useful guide to stations that provide programming to the listeners' taste. The listings are prepared first by state, then broken down alphabetically by city of license under nine format headings.

The formats are defined by editors Wayne Paananen and Reinhart Paulsen as 1) Middle of the Road, stations that vary their style of music; 2) Country & Western, blue grass to modern country sounds; 3) Rock, Top 100 to heavy acid; 4) Beautiful Music, big band, easy listening and classical; 5) Solid Gold, features only million sellers; 6) Soul, jazz and many new all black formats; 7) Ethnic and Spanish, foreign language programmine; 8) Religious, gospel to traditional hymns; and 9) All News and Talk.

Under each segment, information shown consists of city, frequency, call letters with a designation to show stereo and 24 hour operation), mileage for day and night coverage, news network, and live sports coverage. News network includes each of the national commercial networks plus one regional network (IMN) but does not show state networks nor UPI Audio nor AP Radio. Mileage figures are based upon estimates supplied by the station and are designed to show the coverage under which a signal can be received on a windshield antenna.

It's very difficult to come up with a simple format code that's truly descriptive, because many terms mean different things to different people. MOR is a particular offender in this regard. Those who have received my listing of potential format codes know how difficult it is, and there will be several revisions, I'm sure, before a final workable code is established.

In the Paananen - Paulsen list, many stations of many different stripes are lumped together under MOR -- all of the local-type stations that program different kinds of music in different segments, along with such Top 40 rockers as KXOK, WLS, WKBW, and KHJ. I wanted to check on where WABC was listed, discovered that it's not shown in the MOR section, but somehow the entire "Rock" section for the state of New York is missing. (The edition I received was a prepublication edition sent to radio stations for their correction, so I assume this and other problems will be ironed out.)

The work that's been put into the Travelers' Radio Directory has been endless. Paananen, a salesman for WJON-WWJO in St. Cloud, MN, and his wife, El Marie, spent 10 hours a day for seven weeks calling every radio station in the US to gather Information for the listing. In making the calls, Paananen discovered a retired businessman in Omaha, Reinhart Paulsen, engaged in essentially the same enterprise. They joined forces and became business partners.

They expect to make the Travelers' Radio Directory an annual publication.

Lest the above criticism sound a bit picayune, let me qualify the comments. In a listing such as this, it's easy to make typos, errors of omission, and to have classification problems with formats, particularly on a first effort. The great 1340 omission a couple of NRC Log editions ago is an example, and I'd be the last to promise an error-free fourth edition of the NRC log. Our log has improved steadily, and I expect the TRG to do so also.

I think, too, that NRC members can aide Paananen and Paulsen in their information gathering efforts, and we encourage them to do so. The first edition of the TRG will become a collectors item, and it will be interesting over the years to watch the growth of the endeavor. The compilers deserve all the support they can get and we encourage NRC'ers to use the directory. Particularly helpful is the section on live sports coverage.

New stations, changes, skeds, etc.

ALASKA The FCC has granted a conditional license to the city of Unalaska for a station on 1450 khz with 50 watts. Station will rebroadcast programs of AFRN. Call used will be KIAL. (Broadcasting)

AUSTRALIA 2BE hopes to move from 1480 to 1040 khz and increase power to 5 kw before the end of 1976. (NZRDXL)

BANGLADESH The station at Khutna on 1340 khz is now 50 kw. (DSWCI)

BENIN L'Office de Radiodiffusion et de Television du Benin has just gotten a new 20 kw MW transmitter from Germany. (SCDX) No indication of where this one will operate. The stn on 1475 khz is supposed to already be 50 kw, so this might be for one of the low powered stns currently on 1578 and 1598 khz. (ED)

BOLIVIA CP125 on 900 khz has changed name to R. Metropolitana; CP28 R. Cochabamba is now on 1000 khz, (ex-900). Correct adr is Casilla 2772, Cochabamba; CP54 on 1250 khz has increased power to 1 kw; CP133 on 1370 khz has changed name to R. Tupiza and correct power is 500 watts. (WRTH)

COLOMBIA HJCR-590 now 100 kw; HJJR-1005 now 15 kw; HJDQ-1020 now 10 kw; HJAI-1040 now 15 kw; HJNC-1110 correct power 1s 2.5 kw; HJFF-1210 now 15 kw; HJIM-1310 now 5 kw and correct adr is Apartado Aereo 3854; HJEI-1410 now 10 kw; HJIB-1470 now 2 kw and correct adr is Apartado Aereo 589; HJCL-1490 now 3 kw; HJIT-1550 now 5 kw; HJZI-1550 now 15 kw and is operating 24 hours; HJCP-1560 now 2 kw. GALAPACOS ISLANDS There is now a MW station here - Radio Santa Cruz on 1410 khz located on the island of Santa Cruz. (NZRDXL)

GUAM KTWG-770 is sked 2000-1200. All programs are in EE except KK on Sun at 0730-0800 and Vietnamese Wed and Sat at 0730-0800. (WRTH)

GUATEMALA TGSL-1050 now 5 kw and using the name La Voz de los Cuchamatanes; TGD-1070 now 5 kw; new stations are TCME-1340 R. Quezada Educativa, Qudzada with 1 kw and TGEB-1360 R. Momostenango Educativa with 1 kw both sked 1100-1500 and 2200-0000. Owned by Ministerio de Educación Publica. (WRTH)

HONDURAS Radio Paz has changed name to Radio Valle and moved from 990 to 810 khz.

IRAN Two new unidentified Iranians are being heard with good signals in Europe at 0230 on approx 1125 and 1245 khz. (SCDX)

ISRAEL The new pop music station is on the air on 529 khz, not 539. Name of the new station is "Reshet Gimel", (SCDX)

JORDAN The new 1200 kw station is not yet on regular schedule, still testing 1300-1400 daily on 590 khz. (WRTH)
