■ In a recent issue, the question was raised about the call letters of the 880 outlet in Conroe, TX. Isaac Eaves of Crosby, TX clears up the question in Spacini, below. Ladies and Gentlemen, change your logs.

Besides checking in with his DX, Wendell Ford notes there are 5,517 total stations listed in the new <u>NRC Log</u> (excluding the LPers and AFRNs). Robert Tiere checks in with some DX as well as his updated totals as of 12/15/88: TDH-531; TDV-129; T. Reports-172 (75%); T. Countries-32. Now if I could only figure what TDH & TDV mean ...

STATION PROFILE: WNTS - 1590 - Beach Grove, IN

#### "The New Testament Station"

EDITOR'S NOTE: In this season of good will, as the Christian world observes the birth of its savior, it is appropriate that DX News profiles a station which is operated by committed Christians. Additionally, the spirit of Christmas is personified by the station's morning announcer, Tom Elliot, who, with his wife, has dedicated his life to minister to people who have no homes, no resources, and few others who care. We thank WNTS General Manager Jim Wilson for his assistance in profiling this unique Christian broadcaster.



In December, 1956, Rollins Broadcasters' decision to enter the Indianapolis radio market was realized, as WGEE signed on the air. Heralded by large advertisements in the Indianapolis newspapers, the 5000 watt daytime station hoped to carve out a dedicated audience

by programming everything from spirituals to a polka party. The programmed variety of music on "Wegee Radio" (which was the intended call meaning), augmented by a five minute news summary every thirty minutes flies in the face of contemporary programming. The early musical variety failed to attract legions of listeners so every format from country music to rhythm and blues was tried. The R & B format reportedly lasted for three days.

To increase broadcasting capacity, Rollins Broadcasting applied for and was granted the frequency of FM 103.3. As the management felt that FM did not, and would never pose a threat to well- established AM radio, WGEE-FM was sold to WIRE-1430 in 1972. Today, WIRE's sister FM station, WXTZ, broadcasts easy listening music and is very much a profit center.


WGEE - AM was sold to Ennis Broadcasting shortly thereafter. The call was changed to WNIR, and the station played country and western music. Even with CWM, Ennis could not compete with the stronger, more established Indianapolis stations (including country music WIRE). Inspiration came from the all news stations of New York and Chicago. News radio had yet to come to Indianapolis' 700,000 people.

#### WNTS - News, Talk, Sports.

Jeff Smulyan, present owner of WNTS, bought the station from Ennis in 1974, and went to a news/talk/sports format, and applied for the WNTS call to describe his programming concept. Smulyan had double anchors during AM and PM drive, plus sports, weather, and feature reporters. WNTS mobile units cruised the Indianapolis streets, broadcasting live from crime, accident, and fire scenes. This sense of immediacy pleased Indianapolis radio listeners, but two factors plagued Smulyan's all news station. When the sun set (during PM drive in the winter), so did daytime only WNTS. And the personnel - intensive format cost money. WNTS, to economize, went to the short lived NBC News Information service. The best known WNTS news anchor was well known David Letterman, and many Indianapolis market radio and TV news people once worked at WNTS. The news/talk format lasted for three years.

On January 17, 1977, WNTS became what is today one of four religious stations in Indianapolis. WBRI-1500 and WXLW-950 broadcast mainline preaching and teaching, and WGRT-810 is a 250 watt daytime Black gospel outlet. WNTS emphasizes pentecostal and charismatic preaching and music.

#### WNTS People


Three uniquely qualified people are the main contributors to the success of WNTS' ministry. The first is General Manager Jim Wilson. A friendly. dedicated broadcaster, Jim began his first radio job as a sales person for WNTS in 1979, and became general manager in 1984. Jim still sells for his station, and is an authority on Christian broadcasting.

The second person, who keeps WNTS on the air through his electronic expertise, is Chief Engineer Warren Fooks. Warren has been chief engineer since 1959, and has installed state of the art equipment in the modern control room, and well-equipped production studio. he oversaw the installation of the tower for the night pattern, and maintains three transmitters. Warren daily cares for WNTS' electronic equipment as would any chief engineer. However, Warren is legally blind - and fulfills his job flawlessly, according to his boss, Jim Wilson. His wife drives him to and from WNTS. Warren's performance is testimony that any person, regardless of any impairment, can conquer this infirmity through faith and determination.

The third WNTS person truly lives the spirit of Christmas, and, thus, this profile is appropriate for this season. Pastor Tom Elliot has hosted early morning "Good Morning Indy" for the past three years. A totally dedicated Christian, Tom has been blessed with a voice, and projection which would make him an asset to any 50,000 watt radio station. However, tom's love for jesus, and his fellow humans has led to an amazing, giving ministry. Years ago, Tom and his wife began to get up in the wee hours of the night to labor over a huge stew pot in the kitchen of their home - cooking for Indianapolis' homeless population. The pot was loaded into a second hand van, which the Elliots drove into downtown Indianapolis. There, they fed people on the street. The van has been replaced by a larger van, and Tom Elliot's ministry has been expanded to the Compassion Center, at 622 South Keystone Street. The mobile kitchen, called the "Compassion Center - Mission on Wheels" is supported by faith in God, and donations from Tom's listeners. Tom has expanded the ministry to a branch kitchen in Anderson, In. WNTS supports Tom's thanksgiving dinner for the homeless at the Compassion Center, as well as his Christmas feast and Toys for Tots in December. In November, Tom estimates that he and his wife had served 58,000 meals so far in 1988. What a story about a man who could possibly be successful in business, but who chose to serve God and minister to those who need love and care! Tom also has a Saturday morning program called "Indianapolis Central".

#### WNTS Programming

Along with the pentecostal and charismatic preaching, WNTS carries two popular Christian call in shows. "Talk Back" with Bob Larson airs via satellite every afternoon at 3:00. And "Derin's Coffee Shop" comes from Windsor, CO. each afternoon at 1:00. Both shows deal with problems ranging from cults to drugs, to abuse to witchcraft. The USA Network provides news, and Diane Benson hosts a gospel music show nightly from 9:00PM until midnight. The Rosary is aired daily, and has been sponsored by the same Chrysler - Plymouth dealership for a decade.

#### New Testament Station

Three public service programs are aired, including an Urban League Program and "Beech Grove Report", covering issues and events in WNTS' city of license. WNTS has been located since its beginning at 4800 raymond Street, in the southeast corner of Indianapolis. One enters the single story studio building into a spacious lobby. Adorning the lobby is a window allowing visitors to look into a roomy, well-lit control room. Adjacent to the control room is a production studio, and an announce booth vestiges of the all news days, when six or seven people would be on the air during drive times. The transmitter room houses the station's day and night Harris transmitters, and a vacant space once occupied by the WGEE-FM transmitter. WNTS employs six full time persons, six part timers, and six more spares who fill in on the board as needed.

WNTS operates on 5000 watts days and 500 watts at night. The station is on the air from 0530 to 2400. The station's 5000 watt signal is pushed northwest by an array of three in line 170 foot high towers. A fourth offset 170 foot tower is used to tighten the night pattern, as WNTS must protect WAKR, Akron, OH., and WAIK, Galesburg, IL. In its early days, WNTS received a DX report from Australia, and, more recently, a correct reception report was received from a DX'er in West Germany.

WNTS is the only former daytime station in Indianapolis to have received permission to go full time. This was done by changing the city of license to Beech Grove. Beech Grove is a blue collar community best known for Amtrak's equipment repair facility. Raymond Street is the northern boundary of Beech Grove. The FCC has relaxed the city of license rule, but WNTS remains THE Beech Grove radio station.

WNTS is one of two stations owned by Jeff Smulyan. KCRO-660, WNTS's sister station, a daytime station, also airs a religion format.

In this yule season, the National Radio Club is pleased to profile WNTS-1590. The giving nature of its dedicated people is an inspiration in this time of good will.

The editor is very grateful to WNTS General Manager Jim Wilson for all of his help in contributing to this station profile. And the editor wishes one and all a blessed and joyous holiday season.

# Vernon Nolte dies

The Regeter Star Vernon A. Nolte, who made WROK-AM one of the top radio stations in the country, died of heart failure at 4 p.m. Tuesday at Rockford Memorial Hospital.

Nolte was 72

Note came to Rockford in 1963 when Bloomington Broadcasting Corp. bought WROK Inc., from Rockford Newspapera. The business later was renamed Noite Communications Inc. He was chairman of its board at the time of his death.

This past month, WROK marked its 65th analyersary and sister station WZOK-FM its 40th year.

Locally, he was regarded as a philan-thropist, his son said. Nationally, Vernon Nolte was known throughout the radio industry as an innovator and as the driving force behind "one of the last great AM stations," said John Lund, a San Franciscobased radio consultant.

"A faw weeks ago in the Sunday New York Times, there were several stories about the death of AM radio," said Lund, who has worked with Nolte Communications for the past seven years.

"There was the decline of this and the decline of that, but my mind turned im-mediately to Vernon Noite and WROK bing the No. 1 station in Rockford."

In 1988, Arbitron, a New York-based

> Nolte and his associates formed Automatic Tape Control Inc., and later sold \$100,000 worth of the machines at a radio executives convention in late 1959,

"Even with the advent of compact discs, radio stations still eat, sleep and drink cart machines," Lund said.

"If there are 10,000 radio stations in the United States and another 10,000 around the world, there are at least 60,000 cart machines in operation. I can't imagine a radio station without at least three of them.

Nolte's technical and management skills led Billboard magazine to name WROK-AM its Station of the Year in 1977, citing its programming, news and value to the comnunity.

John Nolte said: "He worked last Satur day. He still had his hand in the daily operation. He loved his work."

Lund said, "It's a great feeling to say I knew him.

II. WHAT THE FCC IS REALLY LIKE, AND HOW IT MAKES ITS RULES

The FCC consists of several thousand employees located mainly in Washington, DC in two large office buildings, 1919 M Street and 2025 M Street, in the Northwest sector of the city. Except for one section of the seventh floor at 2025 M Street, there is no radio monitoring or test equipment in use there. All equipment testing and radio monitoring is handled at the FCC laboratory in Columbia, MD, and at 36 field offices spread around the country. There is another major FCC office in Gettysburg, PA where most of the mobile radio and all of the amateur radio licenses are processed.

The top FCC official, presently Chairman Dennis Patrick, is one of three FCC Commissioners. The other two at this writing are Patricia Dennis and James Quello. (There are two vacancies that could be filled at any moment.) Commissioners are selected by the President of the United States who also names the Chairman.

Commissioners are responsible directly to the U.S. Congress for the overall operation of the Commission. Reporting to the Commissioners are Bureau Chlefs and administrative personnel. Of greatest interest perhaps to NRCers are the Office of Engineering and Technology, the Field Operations Bureau, and the Mass Media Bureau that handles all broadcast-related matters. In addition, there is the Private Radio Bureau and the Common Carrier Bureau. These latter groups handle all the mobile radios, telephone systems, amateur radio, aircraft and ship communications, etc. This series in DX News will focus on the rules, regulations and procedus of the Mass Media Bureau.

The Mass Media Bureau is divided into the Audio Services Division (ASD) and the Video Services Division (VSD). The ASD is broken down into the AM Branch, the FM Branch and the Auxiliary Services Branch. The VSD is responsible for regular television station operations, plus low-power TV and Cable TV. There are also Enforcement, Policy and Rule's Divisions, and other groups concerned with broadcast engineering, international negotiations, complaints and investigations, broadcast fairness and political programming.

From time to time, the FCC holds open meetings - anyone can attend in room 856 at 1919 M Street in Washington - to let the public know about changes in FCC operations and how to get information from the FCC. A good telephone number to know is FCC Public Information, 1-202-632-7260. They can often answer general questions about the Commission, and can tell you where to turn for more information. They will also screen out crank calls.

Every day, the FCC releases news items and public notices, conversational texts on proposed new rules, and listings of all applications received and of all actions taken. It usually amounts to 20-50 sheets of paper daily. It is by means of these releases that the public is notified of pending FCC actions. Also on a daily basis, but usually delayed by a week or more, the Federal Register (available in many libraries) prints all the key information about proposals for new or changed rules. Subscriptions to the daily announcements are available (the cost runs about \$120 per month); looking at the Federal Register is free!

Of course, you don't have to wait for an announcement from the FCC to propose a new Rule. If you have a good idea for a Rule, you might want to have an attorney help you phrase and file your suggestion properly. You can also write to the author of this column for guidance (no charge!).

The FCC is not able to institute just any rule it wants. In fact, a large share of the Commission's rules are taken directly from the regulations of the "International Telecommunications Union" (part of the United Nations) because the United States is a Treaty Member of that organization. Also, the FCC is only responsible for about half of all the frequencies used for radio communications in the United States! We will learn more about this another time.

But in spite of all these restrictions, once the FCC has announced its plan to introduce or change a rule, the Public is given several weeks to send in comments on the proposal. Then, after sifting through all the comments, the FCC either goes ahead with the rule or abandons the proposal.

REPORT ON MOTIVATIONAL PROGRAMMING FORMAT ON WNNW-1110, SALEM, NH

I recently contacted station WNNW-Salem, New Hampshire, 1110 khz. and spoke to program director, Teika, who gave me some further information about the station and the format. She described the format as "All Self-Help and Motivation". WNNW west on the air on June 27, 1988 replacing station WVHN. The station presently runs with 5000 watts daytime only.

The programming is made up of 3 to 5 minute excerpts of recorded programming dealing with self-help and motivational subjects, such as self improvement, money making, personal development, investments, etc. Everything is in a positive, up-tempo fashion. Teika tells me that the programming has been very successful and appeals greatly to the working community. The station is popular with salesmen & sales departments, assembly line workers and office workers. Many offices have the station playing for employees during coffee breaks and in lunch rooms.

The station is an affiliate of WWNN in Pompano Beach, Florida. Programming is produced here and sent to WNNW thus accounting for the WNN station ID's on WNNW. There is no programming presently produced in Salem. All material comes from Pompano Beach. WNNW-Salem has applied for a 24-hour operating licence, but Teika doubts if the motivational programming will run 24-hours if the permit is granted. Chances are this format could wear thin with the listening audience. Advertising sales at the station are up and the community seems happy with the station and format. WWNN Pompano Beach plans to set up 7 or 8 more affiliate stations throughout North America including proposed outlets in Boston and New York.

WNNW usually uses the WNN ID from Pompano Beach. Local Salem, New Hampshire for WNNW air at 20 minutes after the hour and 10 minutes before the hour. The station will verify reception reports mailed to WNNW c/o Teika, P.O. Box 1110, Salem, New Hampshire 03079

# MORE INFORMATION ON WNTK-NEWPORT, NEW HAMPSHIRE

I spoke with Mr. Doug Carrick of the technical department of WNTK-1020 Khz in Newport, NH. This is a new station which went on the air on Labor Day, September 3, 1988. Mr. Carrick tells me that the studios are located in New London, New Hampshire. The station is running 6500 watts. The schedule of the station is from 6:00 AM to 4:30 PM at present. At 8:00 AM, they power up from 2400 watts and then power down to 2400 watts again at 2:30 PM. The transmitter and city of licence is Newport, New Hampshire. The early highlight of the 1988-1989 season was the arrival on 10/28 of a verie from Radio France for the Lille XR on 1377 kHz. **IDXD** has all the details. This station had been a holdout since my original report in 12/61, so it was most gratifying when they finally replied. My only other verie is CFGM-640. There were 4 new logs in this DX den. The first two were mundane frequency changes: WFAN-660 on 10/.26 and CFGM-640 on 11/1. I finally logged WNTK 1020 at SS on 10/29. They overwhelmed the channel from 5:24 to 5:44pm These 3 logs were made on the TRF. The remaining DX was on the HO-180A. I was home with the flu on 11/17 and made a bandscan at SS. At 4:10pm the season't first TA showed up in the form of **Duba**-1521. I was surprised by the steadiness of their signal as well as the relative ease of separating them from 1520. The signal hung in there until 4:22pm. I hadn't heard audio from this station since 1/87. My fourth new log occurred on 11/19 when I stumbled across WSJR-1230 as they briefly overwhelmed the channel from 10:25 to 10:27pm. I was in Lancaster, PA on August 29 and did a little DX. Make that very little. I used a GE portable stereo (not a Superadio). I received a lot of Quebec stations, but that was about it. On the way there I had to use the Delco car radio in a relative's 1987 Pontiac 6000LE. It was one of the best radios I have ever used. FM reception was excellent and AM was very good, too. On the way there I got to listen to many AM and FM stations on the Deleo radio. Many AM stations are giving very good sound quality for themselves. (ex. [9/12/88 letter] This fall marks my 30th anniversary with the NRC, and I was once a fairly frequent contributor to both Musings and IDXD. Now that I am retired maybe I can become a little more active. My verified country total still stands at 119, and all but 14 of these were gamered during my first ten years in the NRC, mostly on the HQ-180 which I still use, with a Radio West loop. However, when I travel - and my country count of visited countries is now at 57 - 1 have only enough room for my pocket size Sony ICF-4910 plus my WRTVH. It does separate the stations, and can pick up stations from 3,000 to 4,000 miles, or more. And if I couldn't get WSB in Guatemala, the six or seven CA's and Mexicans using 750Khz has to be a factor. And now for my Australian trip in July of this year. What a wonderful country! The band is a lot like the U.S. band during the middle Thirties, when I began to DX. Except for the 50 kw ABC stations, most of the frequencies have two or three low powered locals, and more than half of these are commercials.

Thank you, friends, very kind of you. This reminds me of the last Convention I attended: the Atlanta Convention where I went with my dear friend Ronald Schatz. I regret not being able to be in one again as US dollars have become too expensive as well as air fare; they are out of my reach right now. My cousin Franklin has already finished a compilation of the most complete list of FM stations in the Dominican Republic. [10/4/88 letter] I've done a little BCB DXing, with the GE Superadio, the only receiver now available to me. and have reports out to WEZO-990, ex-WNYR, and to WXEZ-820, ex-WCZE/WAIT. I noticed the likes of WMAQ, WGN and WBBM booming in here on the morning of October 4, so I decided to try 820 to see if I could nab WXEZ, and by golly, there he was, but with much interference from CHAM. DXing's not too easy with the Superadio - it is difficult to tell which frequency you're on, especially on the high end. The HQ-180 is still not back; it's being fixed with all the speed of a centipede with 50 broken legs, trying to slither up a wet window. I read with interest the two accounts of the Collins 51J4 in Issue #1. Two important things were not mentioned - the price, and where one could purchase one. Sounds interesting. I had an R-390A for a while, but I tired of it - 'twas like driving an 18-wheeler, so to speak. It took a lot of time to tune from one end of the band to the other, and its weight was prohibitive. The only way it seemed to outperform the HQ-180 was in being able to tune to 530 KHz (and lower), while the 180 stops at about 538KHz. I've used the SM-2 antenna with the HQ-180 for some 15 years with excellent results, but it stops peaking at 1570 kHz, so I can't get good volume on the channels above that; particularly on 1610 to try for some of those oh-so-weak Tizzies. .... Whilst on vacation at Green Lake, I was tuning around and came across a classical music station on 1000 KHz in the afternoon, with local strength. They IDed around 5:00PM as WNYS, West Taghkanic, NY, and said they were a community access noncommercial station, and operated Sundays only, from 8:45am to 5:05pm. Does anybody know anything about this station? Laura McCusker maybe? I don't find it in any logs. I suspect 'tis a bootleg, albeit an unusual one. They have a deepvoiced male announcer and use a strong reverb on speech, much like WLNG-FM 92.1 does. (Sag Harbor, NY) They gave a rural route number and box number, but I didn't catch it, as they then left the air. The following Sunday, I was no longer in their coverage area. ('Tis indeed a pirate which has been on the air for about five years or so -pls) WXKA-900 has changed calls to WCLZ, same as their FM. Both can be heard here on RS. Middleboro town selectmen have voted to send a letter in support of the license application and property for the transmitter sight has yet to be purchased. Studios will be located in the main area in town. Steven Callahan has signed a couple of my veries and has been associated with WBSM-1420 New Bedford and several area stations including WPEP-1570 Taunton, and WWAZ-790 Providence. Red Sox are out, Bruins are in 73.

[10/14/88] What happens when four deer, a horseback rider and an elk walk through your recently crected 800 foot beverage? No, Castro didn't turn off his transmitters (did he?); the A index didn't hit imaginary numbers; it was an act of nature. It all happened when Los Angeles won the National league west. As a Cincinnati Reds junkie, I could listen to WLW even before sunset despite the pollution on this once-clear channel. [10/17788] Looking back to the 1987-88 season, 1 ended up with only 15 new loggings, of which 7 were call changes. The best catch was the WVW 630 test. The high point of the season was the arrival of my first Asian BCB verie when Duba 1521 (SLed my fourth letter!!! In the new 1988-89 season, I so far have 3 new logs—all call changes. Around 10:15 pm on 7/23, WKOS 930 finally penetrated the slop-over from the XR of CBM 940, only 2 miles away. Then on 8/1, WNNW 1110 overrode WUHN around 7:30 pm. Both of these NH stations were logged on the HQ-180A and loop. On 9/8, the TRF slightly outperformed the Superadio II when I logged WEZO 990 after 2 am. In addition to Duba 1521, new veries are WKOS 930, WNNW 1110, WSKW 1160, and WKIT 1200. After 28 years of on and off BCB DX, my totals are 1707 logs and 1633 veries, for a 95.7% return. For years, I have been tantalizing close to the 96% barrier but never quite made it. In theory, I could get there by verifying by 6 holdouts from 1985-87. [10/18/88] 1 was surprised to see that WGST-920 is buying WPBD-640. 1 hope to see WGST's 920 spot be sold to either a minority operator and keep "Heart and Soul" in Atlanta or to someone who wants to program the "Z-Rock" format, which is about to catch on in the markets it already serves and Atlanta needs very badly, as the only AOR station there is WKLS-96.1. 640 in Atlanta doesn't make it past Marietta at night, so a synchro may be needed somewhere to the NW of Atlanta. This is also true of WQXI-790, which is covered hy Radio Reloj-Cuba and WNWS-FL at night. The Atlanta Constitution erred when referring to WCNN's daytime power; it's 25,000 watts, not 50,000 as is the case with WPBD. WGST has only marginal coverage at night on 920. About the NAB-Sequerra project; the NAB should have selected Robert Carver of Carver stereo fame to do this project. His TX-11a already has all the features the NAB wanted except for continuous AM-FM tuning and multi-mode AM Stereo (it receives C-QUAM only). About the Tom Kneitel scandal; I truly believe he has gone off the deep end. He has continually cut down clubs such as NRC, and it's about time that he stop this before he is pushed out of the DX hobby. Marc DeLorenzo's domestic on 590 over Radio Reloj is most likely WKIIX, as their directional lobe is aimed NW-SE, to give a strong signal over Marietta, WKIIX-FM's city of license. Stations that Most Need to Change, Chapter Two: KXOK-630 made a king-sized mistake by dropping an excellent Top 40 format for satellite-fed talk in February of 1988, raising the ire of listeners (including myself). Owner John E. Connelly should consider donating the AM station to the St. Louis Community College at Florissant Valley, where the station would simulcast its 100-watt FM on 89.5 MHz, and change to KCFV to match the FM station. The only nonsimulcast times would be 2000-2400 Saturday and 0600-0800 Saturday and Sunday. The station already has C-QUAM equipment in place, so it would be able to broadcast in stereo on AM and FM. WLS-890 still has a fairly good music format, but it should drop the talk shows at night, and return to a Top 40 Format. WXEZ-820 is an excellent candidate for those shows, despite poor coverage. WLAC-1510 made a gamble on REL at night and is losing in the ratings. A Top 40 format and Cardinals baseball during the season will get the 50,000 watt station into a better position to compete with the other Nashville stations. KXEN-1010 is the joke of the decade. It has held on to its Southern Gospel format since 1968, and the audience for it is dwindling. A call change to CHR (with oldies library dating back to only 1980), and going full time with 10000/10000 U2 (not 5000/500 U4) is proposed. According to a ham operator friend, the 10000 watt night power would require at least seven towers. The added pluses of C-QUAM Stereo and a 2.3 GHz STL would be beneficial to the station's ability to compete. 73 for now.

[10/25/88 letter] First off, many many thanks to William Swiger for his very interesting tape-full-of-answers, and to Herman T. Adams for his postcard tip on the Radio West Great Little Loop. Herman, I bought the Shotgun loop instead because I was afraid of the amplification among these locals of mine. I couldn't be happier with the antenna. It pulls in much stronger signal levels than I imagined a passive ferrite loop could (and it doesn't need batteries!!!). Thanks very much for the help, gentlemen. Here's a DX Time Machine quickie for you. I just read Vol. 56, number 3. Looking back thru my collection I find Volume 46, #3. 46#3 was 40 pages, with a 22 item table of contents. It contained, among other things, 4 CPC test listings, 5-page DDXD with 14 reporters, 3-page IDXD with 8 reporters, both GYDXA and IDXA columns, and Musing section with \*41\* Musings. Two entire pages (out of 40) were taken by HQ business of all sorts, and there were only two previously published articles. Many of the Musings were active DXers describing their active DX. By contrast, 56 #3 contains 3 pages of DDXD with a total of 8 reporters, and a total of 5 Musings. The biggest theme in the Musings seemed to be road trips rather than hard-core DXing from home. 56 #3 contains no less than 10 previously published articles. And my favorite column, IDXD, has had a total of exactly one reporter over the last FIVE issues. Sure, I'm interested in formats and DJs, but I get a heck of a lot more excited about hearing Bermuda than about a local format change. I realize that the focus of the NRC is shifting away from DX, but you folks must be hearing SOMETHING? #### \* WNBC IS GONE - ANOTHER BLOW TO AM \*

#### Bob Smolarek - 156 Oldwick Road - Whitehouse Station, NJ 08889

[10/27/88 letter] October 7th at 5:30 was a sad moment in New York radio history as one of the best AM stations in the country expired. WNBC is no more, as WFAN moved to 660 from 1050. But the worst part about it is the station that took over 1050, another Spanish station. We now have Spanish stations on 620, 1050, 1280, 1380, 1480. I first started listening to NBC in the early 70's as they played AC music and had personalities such as Ted Brown. They also had NY Knick games with Marv Albert when that team was at its best. Around 1973 NBC became a Top 40 competitor against WABC with Wolfman Jack and Don Imus. They lured Cousin Brucie away from WNBC in 1974, and a great memory was their total request format around Christmas 1974. The years from '75 to' 77 were great as fine personalities like Dick Summer, Norm N. Nite, Walt Baby Love, Joe McCoy, Bil Rock, Vernon With a V, Oogie Pringle, and Big Al Brady entertained us. Then in the summer of 1977, Bob Pittman fired all of them and brought in a whole new air staff. The new station sounded like FM on AM with no loud commercials, no jingles, a real clean modern sound. Some of the new jocks lasted along time, such as Captain Frank Reed, Alan Beebe, and Johnny Dark. Others didn't last long, such as Lee Masters, Jay Stone, Ellie Dylan, and Batt Johnson. Don Imus came back, and WNBC was still playing music when WABC stopped on May 10, 1982. Howard Stern came aboard and pumped up the ratings, but you could sense a decline in the station. The music programming slowly was being phased out, and more oldies were being played. But Soupy Sales and Joey Reynolds still made NBC in the sixties again. Dan Taylor acted like he was Don Ingram; it was a lot of fun. But when the ratings hit the low 1's it was time for WNBC to say goodbye. They stayed professional until the end and closed the last day with a historical special. Thank God they just didn't disappear like WFRM or WVNJ. Can it be that we may never hear popular music again on AM in New York City? I certainly hope not.

[11/1/88 Letter] Greetings, again. This will probably be my annual contribution to this column, although I hope to be a little more frequent than that. DX has been essentially nil here, as it has been for longer than I care to say. Ican'teven blame itom my ham activity, because that, too, has declined. Ido still run a ham net on 2 meter sideband, which, while not NRC-oriented, is certainly open to NRC'ers who operate that band. The net is the Delaware Valley Sidewinders on Two being a national 2 meter sideband organization), and it meets Mondays at 9:00pm ELT on 144.250 Mhz. I typically beam around the compass in a clockwise direction, sarting in the Northeast at 9:05pm, and finishing up there again at about 9:15. I can usually work most of PA, all of DE, MD, & NJ, much of VA, CT, RI, & NY as well as Eastern Ohio, Northeastern WV, Western MA, Southern VT, NH, & ME under normal band conditions. \*\*\* On another subject, the TIS list was of interest. I can personally vouch for the existence of the following at the times noted: 1200 Busch Gardens, VA (6/88); 1610 Tampa IAP (11/86,2/87,4/87); 1610 Chincoteague (8/86); 1610 Shenandoah NP (6/88); 1610 Jamestown (6/88); Sea-Tac IAP (3/83). Most of my medium wave time has been spent cleaning up the "Antenna Farm" at the side of the house. Dipoles, Verticals, and Long wires were the only thing to grow in this part of Ohio! Weather permitting, all will be relocated to new areas. Now that antennae are more secure, and noise is just about non-existent from our local power company, DXing is getting fun again. I've also been playing around with

an AM transmitter, testing some of the new AM transmission standards the NAB has been talking about. All indications are that with sufficient band limitations, and quality technical standards on processing, AM can sound quite good compared to FM, but in 30% less spectrum space. I suppose that if this is brought up to the FCC they'll dump it to the marketplace. For those of you that heard the "War Of The Worlds - 1988" on NPR, it was a real treat. The stereo could have been better, but the production was great. I taped the original 1938 version [Fred was only 26 yrs old then, hi - HQ], the 1988 version, and the "Making of the War Of The Worlds" in DBX/15ips for my archives. [11/2/88 letter] I was interested in the DXChange item on Page 1 of the October 21 issue of DX NEWS, that William Swiger has a couple of R-390s for sale. I have written him to inquire if they are in A-1 condition or if they need realignment. I had one of these monsters some years ago, and found it about the equal of the HQ-180, but cumbersome to tune and extremely heavy. Mine was manufactured by Motorola, while most of the one in DX circles are from Collins. But an R-390 is certainly better to tune than the GE Superadio, which makes it difficult to tell what frequency you're on, particularly on the high end of the dial. Then too, with the Superadio, I can't get into frequencies next to powerful locals by day, or next to loud 50 kw out-of-towners at night, in many cases. So, we'll see... Somebody said WUKQ-1050 would exist only for about two weeks. As of 11/1, they're still going strong. I note Larry King is now being carried on WYNZ-970-ME and WPTR-1540-NY, and CFGM is gone from 1320, leaving CKEC-NS and WJAS-PA top dogs there, with neither very strong. On 1380, WQMI-NH is now running AN, and so is our local across the bay, WPLM-1390, but the latter is silent Sunday mornings. WQMI keeps mentioning "95-FM" so they're simulcasting. The AU CX have left us, and the opposite seems the case now, with the French Canadians booming in, particularly CKRB-1460, which is way on top in the early morning hours, so it'll be a while before I can get a log on WGNA, Albany. On a tip from Stan Morss, Hogged WOBM-1160 Toms River, NJ, ID'ing often as Star Country, and often topping the frequency in the early evening as well as during the early morning hours, like around 2am. The new NRC Domestic Log is here, and it is a great job, but there's one glitch, at least in my copy. The first page of the 1350 stations lists instead, the 1380 stations, and at the 1380 heading, the 1350 stations are shown. The copy on the reverse side of these two pages, however, is in the correct place, so the pages cannot be interchanged. [ERC, you mean the AM Radio Log. Those two pages have been corrected and replacement pages sent out; if you haven't gotten the replacemnt pages let the NRC Publication Center know] On 11/1, I heard Larry King welcome WZTZ, Clarksville, TN to his network - 1 guess that's an FMer. On 1350, a station mentioned being on the Mid-Canada network -1 wonder who this would be? I've enjoyed the adventures of John Malicky as he visited all those interesting Ohio stations - nice going, John! Forward - March!

#### If You Can't Get the West Coast, Maybe You Can Log Australia

[11/3/88 letter] It has taken me months to recognize and fully awaken to the fact that something extraordinary and wonderful has happened in this often discouraging hobby of DXing the broadcast band. So I have a message for all those Eastern DXers who have tried in vain to get California, Oregon, Washington, Idaho or Arizona. The message is simple: Quit fretting about California; you can get Australia instead! There are five 500-watt Aussies on 1620 and 1629 KHz and they transmit signals of unbelievable strength into Denver these October - November mornings in the area from 9:00 to 1400 hours GMT. (They were still in one hour after sunrise on Nov. 2) The pair of them on 1629, Sydney and Melbourne, deliver the best signal for me inasmuch as I have a 1600 local that complicates reception of the 1620 Aussie. But I can hear the 1620 stations and their signal seems to be on a par with what I hear on 1629 although it is not in the clear. As to the 1629 stations, they give me by far the best down under reception I have heard in a lot of years. Nothing else comes even close to them. If I were to hear they were using 50 kW rather than 500 watts, I would not be surprised, for they arrive with enough strength to drive you right out of the house as the old DX saying goes. You can never forget there are two of them for the beating between them is constant but you can be certain you are getting Australia for 1629 is a clear channel, along with 1620. I do not believe for a passing second that any body in the Eastern U.S. would need a thousand foot beverage antenna to hear these midgets so many thousands of miles away. I can locate them on by GE Superadio with its ferrite rod, not as well, of course, as on my HQ-180 with its big loop antenna, but using both of them at the same time shows the weaker signal on the GE is duplicating what I'm getting on the Hammarlund. Another thing about the 1629 Aussies: their reception is a daily proposition this time of year, never a case of here on Monday, gone on Tuesday, back on Wednesday. There is a remarkable steadiness in their signal, fading almost non-existent. The 1629 stations offer no signals of any sort on the hour or half-hour and there's not a lot of talk on them. The voices you hear are usually male, although I have noticed a female voice around 12 hours up to 1209. Maybe she is brought in for the 10 o'clock news. The audio would be quite readable except for the fact that hearing it is always difficult on account of the constant beating between the two stations. Perhaps if one of the two could be caught fading sometime, then the other station might be heard with a readable ID. Let me suggest that the liberation of three frequencies above 1600 is the best thing which has happened to the DXing hobby in a lot of years, we can go exploring now on 1610, 1620, and 1629, and there are a lot of riches to be found in that spectrum space, blessed by the absence of domestic stations. This small space is something like the whole broadcast band was about 1930 when our domestics were mostly silent after local midnight. Finally, there is no requirement that you be an international DXer to participate in this Australian feast. If your radio is good enough to reach down to the noise level, and you can read your dial accurately, then reception of Australia is a distinct possibility for you. Go get'em. Gene
