A North Ridgeville radio station was off the air yesterday after a fire destroyed its broadcast equipment and a library of albums and cassette tapes, according to fire officials.

Damage to WJTB-AM/1040, an adult contemporary radio station on Center Ridge Rd., was esti-mated at \$150,000, said Capt. Ray

"The fire itself was knocked down rather quickly, 20 to 30 minutes," he said. "But the heavy

Court yesterday.
North said she got a raise from \$3.35 to \$5 an hour last month at WGFT radio station to handle the station's gospel music program. She said that on Oct. 27, she was called into the office of Timothy DeCapua, the station's owner and general manager, and was told she was being dropped from the show.

"He finally admitted that's what it was: I wasn't black enough, North said. "People thought I was white, and they were getting complaints.

"I was shocked." she said. "I felt bad about it, especially that they would release me from that kind of show because 1 wasn't black enough.

Named as defendants in the suit were DeCapua, WGFT Inc. and unnamed defendants. DeCapua

could not be reached for comment.

The suit seeks an order saving that the defendants' conduct violated the Civil Rights Act, a permanent injunction prohibiting racial discrimination, \$150,000 in compensatory damages and \$250,000 in initive damages.

North's lawyer, Avery S. Fried-man, sent DeCapua a letter dated Oct. 31 in which he sought to have North restored to the program.
"While the racially motivated

actions of your franchise are both shocking and unlawful, it is impor-tant to emphasize that Ms. North is not desirous of pursuing legal remedies at the present time," he said in a copy of the letter attached to the suit.

Friedman said North was fired after the station received the let-

The station, which broadcasts from dusk to dawn, was off the air when the fire was reported by employees of a nearby pizza shop shortly before midnight Tuesday. Firefighters remained on the scene until 1:30 a.m. yesterday.

### A DXer/Broadcaster's View On AM Radio

WGST, in preparation to move to 640, has sold it's 920 spot to Dr. James Dobson of Focus on the Family fame. With this sale, Atlanta will have seventeen religious stations audible on AM and FM. WAVO-1420 has not yet switched to BRN Business News as of 1/13. WWXX-1400 is back after a two week silence, off for transmitter trouble. In response to the 920 sale, a point is made: REL stations are the biggest waste of frequency, bigger than the bird (satellite) or simulcasting. Atlanta, the nation's tenth-largest market, is a prime example of such wastefulness. Several good frequencies (most notably 970 and 1080) have been wasted by REL stations. The reason being is that not many people listen to REL stations, and many of these stations are consistent no-shows in the ratinos (KXEN-1010 is one notable example). These REL programmers hardly (if ever) study the market to see what voids need to be filled. Many of the programs these stations carry are available on other radio stations in the same market, and such things shouldn't be allowed. A lot of others don't usually make money doing something a dozen other stations are doing. In Atlanta, for instance, there are no Format 41, Z-Rock, Standust, Oldles Channel or even a full-time ABC Talkradio outlets, and Heart and Soul will pull out when WPBD becomes WGST. If I had bought a radio station in the Atlanta market, my programming decision will be based on market research, and not the need to "reach out" and get very few listeners, as many REL stations do. The FCC should put limits on the number of AM REL stations each market should have. In Atlanta, there should be no more than four. This should be based on market size, and is intended to encourage AM stations to try something different. The extremely high number of REL stations is yet another reason for AM's decline. Programming REL will make a simulcaster or a satellite-fed station look like Caspar Milquetoast (remember "The Timid Soul?"). Another reason for AM's decline is that suburban AMs tend to program for an entire metropolitan area instead of the area around their city of license. If an AM station programs for the area around their city of license (example: Hazelwood, MO), it will gain listeners from that area, and maybe the entire metro area. As you read in Formats in 56-13. White Birch Communications, headed by yours truly and three other people (two KCFV disc jockeys and an amateur radio operator), is planning to buy KXEN-1010 from their current owners, who also owns KXEG-1010 in Tolleson, AZ. The purpose of the proposed buyout is to give Hazelwood it's first radio station, and give St. Louis another music choice. If and when the deal is successfully made, the format will be CHR geared toward North St. Louis County and the St. Charles County, MO, with Hazelwood West Wildcats football and basketball (high school). Florissant Valley Norsemen baseball and Norsewomen softball (junior college), and the American Legion baseball on Friday nights. The station will be Stereo using the C-Ouam system, and is also planning hard rock on Saturday night. Christian rock on Sunday morning and novelty music on Sunday night, as well as acquiring the local rights to Scott Shannon's and Shadoe Steven's countdown shows. My decision to get into ownership is mainly due to my difficulty in getting a job in or out of radio. It could be the only career move I'll ever make. I didn't expect to get into the ownership ring until I was a least 40, but with the job market as it is, I had no choice. More as it happens. 73.

At 1900 I heard the unnKCTA-1030-Texas signoff above WBZ. I was listening to the REL music for about 10 minutes expecting KCTA, but their signoff surprised me nonetheless; I hope everyone else experienced similar conditions this strange night. [You did send your loggings to DDXD-East, right? - HOl On the local front, WAGE-1200 is now all night with Larry King, since late November, boo hiss. I hope the new year is rewarding to everyone, healthwise, financialwise and more importantly DXwlse!

Recently, Nell Kazaross made a trip to New England from San Diego, CA. He and I got together on 7 Jan 89 and took a ride out to the shore at Swampscott, MA for an Impromptu DXpediton. Nell, as you may remember, logged a staggering amount of Trans-Atlantic, Caribbean, and South American DX from Narragansett, RI and Ogunquit, ME a few years back. Neil's a great guy and a super DXer: we could use him back in New England. He's considering a full-fledged DXpediton to Maritime Canada (NF or NS) in autumn '89. On 7 Jan (8 Jan, GMT), we logged a good assortment of southerly Trans-Atlantic's and Caribbean stations between 0130 and 0230 GMT. The DXpediton location favored east/southeast and conditions were semi-aurora). Log information was taken casually: detail isn't sufficient for a report to IDXD. Azores on 1566 had a potent signal; as we listened to it, a het from something on 1565 became apparent. The first thought was a low-powered St. Lucia outlet, eventually, Spanish-language audio could be pulled by 1566 by manipulation of the MWT-2 regenerative tuner and by a favorable fade. The 1565 thing was probably a Dominican Republic split. Antigua on 620 was generally dominant, with soca/calypso music and accented english talk. Blg signals were noted from a good number of Carlbbean spilts, including Grenada - 535 and the new Nevis - 895 (from which a fine ID was heard). Venezuelans were all over the place: 600 -790 and 1000-1200 are the prime frequency ranges for these. Neil's excellent DX memory helped log YVOD (Ecos del Torbes) which was ruling 780; Neil recalled the parallel 4980 kHz outlet which, upon investigation, had the Jamaica on 750 was atop the YV and WSB; same program. Saturday-night-party DJ shows from Jamaica are always welcome listening for me. Turks & Caicos was awesome; its preaching was blowing away all competition on 1570, even usually-pesty CKLM. Spain was tentatively noted on 999 (the talk sounded Spanish, not the expected Arabic from the Moroccan). Usual "mouth-of-the-Med" Trans-Atlantic's were good, with Algeria - 891 leading the pack strength-wise with its typical cruncher signal. The "travelling DX set-up" with the (Gerry Thomas ~ modified) Sony ICF-2010, regenerative tuner, and 100 foot (30 meter) wire on the ground proved quite capable. The last time I'd logged this much in an hour was on a sunset Trans-Atlantic blitz from Brant Rock (Marshfield, MA) a couple of years back. The same gear was used. Average equipment and a

location will outperform good equipment and an average location for foreign DX. 73

### A Special Enhancement For The Down Unders

There was a period of intense solar activity January 11 through 16 -- an X category flare on the 11th, an X-2 flare on the 14th, whatever that means. [A large burp of hydrogen from Mr. Sun - HO ... pretty good, huh....get away from that keyboard, mike - Suel So realizing the A-Index would be hitting a high level. I went exploring the new DX environment before sunrise on the 11th. First thing I located at 1400 GMT were quite strong signals from the two Australian midgets on 1629, which is my favorite DXing spot these days. I sheck them out every morning and they were coming in much stronger than during the previous several days. Bearing in mind that mid winter is the poorest time of year for Down Under reception, perhaps that rule can be amended to say, except when a solar eruption comes along. On the 11th I taped 5 minutes from 1629 at 1400, on the 14th 2 minutes at 1414. On the 15th, 4 minutes at 1334. All of these taped excerpts display a guite strong signal, although the constant beating from Sydney and Melbourne presents the usual difficulties in hearing any ID. This isn't the first time I have noticed that auroral activity enhances Nown Under reception. I have been cognizant of it for years, but never before have I encountered such a convincing demonstration of it. Down Under DXers also benefit from these episodes of intense solar activity. It is during them that they get their best reception of North American BCB stations. Right now, it's summer down under, and perhaps summer static would cover up any improved conditions for them. The Northern aurora and the southern aurora occur simultaneously, just as they should on any well-ordered planet. There is no such thing as having an aurora borealis without also having a companion aurora australis. Perhaps we are not accustomed to thinking about the aurora in these terms, but that's the way the cookie crumbles on our cozy little planet that is occasionally blasted by disturbances on the sun.
