Format Futures ... by Chris Cuomo

Although it may seem early, I am going to make my predictions as to what will happen with each of the formats listed in the AM LOG in the 1990s. The percentage indicates the predicted gain or loss over the current number of stations with that format.

AC - Adult Contemporary - As the Baby Boomers age over the next decade, I think this format will grow. People are getting tired of heavy metal and Top 40 and should be tuning in here. Prediction: +5%

AOR - Album Rock - This format's listening audience of mostly high school and college students are not listening to AM. Prediction: -24% A recent offspring of AOR is Classic Rock, which is '60's and '70's AOR, unlike true AOR which is mostly modern. Classic Rock stations will not play modern AOR as it is often described as "headbanging heavy metal". By 1999, much of this Classic Rock will be thirty years old and its audience will probably be listening to something else.

B:/UC - Urban Contemporary - Because of this format's wide diversity, look for it to expand greatly in the '90's. Conceivably, three "B:" stations could exist in the same market if one plays R&B, another plays current should hits, and a third plays rap. Prediction: +10%

BB/MYL/NOS - Big Bands - This format is probably on its last legs. No new music of the format is being made and it has shown almost no ability to attract new listeners. By the end of the decade this music will be perhaps too old. Prediction: -50%

CLA - Classical - It has been a surprise success on AM so far. Watch for this to continue. The idea of none of those infernal pledge breaks will attract people. Prediction: +75%

C&W - Country - In the '70's, the '50's were the good old days. Now it's the 60s. If the trend continues, the '70's will be the '90's' good old days, which is good news for C&W as it became very popular in the mid '70's. There is already a glut of C&W stations so I don't think this format will grow that much. Prediction: +3%

CHR - Top 40 - Many people are getting tired of today's Top 40, with all its heavy metal and shabby remakes. Don't look for much to change in ten years. Prediction: -8%

EZL - Easy Listening - This format should increase as the Baby Boomers age. On the other hand, many listeners are turned off by the large numbers of watered-down versions of Top 40 records being played as EZL. I don't think this will hurt the format much though. Prediction: +5%

ETH/S: - Ethnic - With increasing Hispanic immigration and this format's wide diversity, it will go through the roof in the '90's. Prediction: +85%

GOS/REL - Religious - There are already too many REL stations. Some cities have seven or more. Some are going to have to go. Prediction: -10%

JAZ - Jazz - Jazz is showing increased popularity with young people and in my opinion sounds very good on AM. Prediction: +40%

NWS/TLK - News and Talk - As one of the few formats that AM has and FM doesn't, this format will have to grow in the '90's. Prediction: +90%

OLD- Oldies - This format is constantly changing. Ten years ago, a lot of '50's music was being played. Now there is hardly any. The same thing will probably happen to '60's music in the '90's. Satellite feeds are cheap and will probably make up for the loss of audience that I expect will happen. Prediction: -3%

VAR - Variety - It's perfect for small towns. It will grow and further clutter the band in the process. Prediction: +18%

Newcomers - Because these new formats' small numbers of stations, percentages can not be of much value here.

Sports - Definitely the best of the new formats. Being so diverse, more than one can survive in a city. Perhaps one can cover professional sports, a second can cover college sports, and a third cover high school sports.

NewAge - An interesting blend of jazz, easy listening, and a touch of classical. Its heavy use of synthesizers can attract younger listeners. I've heard it and I like it. This music is not to be confused with progressize rock which is also known as New Wave, and New Age, and punk rock, which has not appeared on AM, yet. (Fortunately - CC)

BRN - Business News - Another great idea. It does have a small audience, but has the advantage of no competition from FM.

Children's Programming - This has shown no success so far in numerous attempts. I don't expect any miracles for the format now either. The audience of children, ages seven to twelve is just too small to cater to. KPAL - North Little Rock's luck will probably run out soon.

Travelers Information - At first I thought this stood no chance but in reconsidering it, it just might. Don't expect this to replace the TIS, though.

Elvis Radio - Elvis made a lot of songs during his career, about 900, but this is still not enough to start a format on when you consider many are B-sides, studio outtakes and rejects, and holiday music. A lot of hype was made about Beatles-Radio "KBTL" a few years back, but it's gone now. WCVG and its Elvis Radio impersonators will go the same way.

Inspirational/Self-Motivation - I'm not too sure that radio can really play doctor. I feel this is another flash in the pan.

This is my look at the future of the formats. Keep this list handy when the '90's start.

KCKO(AM) AT SPOKANE, WA. ORDERED TO SHOW CAUSE WHY ITS LICENSE SHOULD NOT BE REVOKED

The Commission has ordered Great American Radio Corp., licensee of KCKO(AM) at Spokane, WA, to show cause why the station's license should not be revoked.

On May 13, 1985, KCKO received Commission permission to remain silent until August 15, 1985. After that date, attempts by FCC's Field Operations Bureau and the Mass Media Bureau to contact the licensee were unsuccessful. These attempts, together with attempted monitoring of the station that revealed it was not operating, indicated that the station had been abandoned. In addition, a visit to the transmitter site revealed no evidence of a radio transmitter building or antenna towers. Great American has neither requested further FCC permission to remain off the air nor turned in its license, in violation of Commission rules.

Consequently, the Commission ordered Great American to appear at a revocation hearing to determine: 1) whether Great American has violated Commission rules; and 2) if it posesses the requisite qualifications to be or remain the licensee of KCKO.

If the hearing record does not warrant an Order revoking the station's license, an Order for forfeiture of up to \$20,000 for willful and repeated violation of the Commission's rules may be issued.

Radio his link to world

REDDING — Don Blair has talked his way into millions of homes, but few people in them have ever seen him.

That's because Blair doesn't have to be seen to be heard. For 34 years, he has been a broadcaster for several networks and has covered such stories as the 1986 Super Bowl and the Challenger explosion.

When Apollo 11 returned from the moon in July 1969 after carrying the astronauts who made the first manned landing on the moon, he was the only radio broadcaster on the recovery ship.

Blair's coverage of their return went to half the networks in the free world, and he believes the people who listened then may have comprised the largest radio audience of all time.

With all he has experienced, Blair said there is nothing like handling breaking news, especially two stories at the same time. That's what happened earlier this week when he was broadcasting the return of the shuttle Discovery and bulletins flashed about the release of a hostage.

Blair said many people were hoping the man would be one of three American professors, but he said there was still great joy when it turned out to be a colleague, Indian educator Mithileshwar Singh.

"When you are handling two breaking stories at the same time, anyone in this business knows how exciting and exhiliarating it is," be said. "Those were two happy stories back to back. So often the criticism is that all we do is tell people the doorn and death."

A Redding resident, Blair has a deep authoritative voice with a warm quality to it. He joined NBC in 1974, agreeing to work-only

part-time so he could pursue other projects.

Every Saturday and Sunday he gets up at 3 a.m. so he can make it to NBC's Manhattan studio by 5 a.m. There he reads a computerized screen containing every major story on news, business and sports events.

Using an ultra-high-speed printer, he prints out copies of all the stories he plans to work with. Then he edits them so that what he broadcasts is in his own words and

style. As stories are updated, he makes necessary changes.

Blair said hardly a day goes by when someone doesn't incorrectly assume that he and other newscasters merely read whatever script they are handed. But he said every newscaster he knows writes his own script.

"It's your own way of telling the story," he said. "Newscasters are very proud of the fact that they write their own material."



With regular correspondents covering special events, such as the Olympics, Blair winds up working an average of three days per week at NBC. That earns him a yearly salary of about \$50,000.

Blair, 55, said NBC executives have asked him to go full-time on many occasions, but he has always held out. That's so he can be his own boss in scheduling free-lance assignments, such as doing voice-overs and on-camera work for national and international businesses.

With a working studio right in his home, Blair can receive scripts on his fax machine and oh his own recordings. His salary from the freelance work varies, and when he is called on to speak before a camera, his fee is between \$600 and \$1,000 for a half-40;

Blair completed an on-camera as-

signment this past week at Union Carbide in Danbury, whose Linde Bulk Gases Operations Department asked him to help introduce a new maintenance management system.

After his face was sufficiently powdered to cover any spots that might shine under the camera lights, and after he had used a generous spritz of hair spray, Blair was on a set designed as an office.

"If I don't use hair spray, my hair flops all over the place," said Blair, who carries his own hair spray and powder.

He practiced reading the script on a teleprompter as technicians perfected the lighting, props and audio. A few hours later, the program had been recorded and Blair had set up another assignment for next month.

Blair said free-lancing has several benefits. One is that it provides him with a variety of work, such as recushol? On

ording a corporate news telephone report for General Electric. Between 3,000 and 4,000 sales and marketing people call a special General Electric number to hear Blair give a new report each week.

Another plus is free-lancing allows Blair to indulge his favorite hobby: travel.

Since his wife, Patricia, is a comptroller at a Darien travel agency, Blair is well-informed about all the best travel packages. He and his wife have three grown children, and they also enjoy skiing and relaxing at their Vermont home, which is near a large ski area.


Blair never went to college for radio broadcasting. He just took a six-month course at New York's Cambridge School of Radio and

On Friday, February 10, 1989, Montreal's Oldies station, CKGM 980 Khz. was running the following previously unannounced announcement. "Ladies & Gentlemen, at 5 o'clock this afternoon radio station CKGM will become a thing of the past and the future will belong to you. Keep it right here at 980 on your AM dial, then be ready as we present to the people of Montreal, Canada's newest Top 40 Radio Station and the most music allowed by law." General manager Lee Hambleton stated that this is a new radio station, just as though someone had applied for a new licence from the CRTC. We want to emphasize that this is not the re-creation of an old station, but the creation of a new one. The change marked the end of a three year effort to turn CKGM into a soft-rock station targeted at adult listeners. Hambleton and program director, Susan Davis determined that no one in town was playing hits anymore. "Our research says there is a strategic opening for a special kind of Top 40 radio. The station is therefore, now called CHTX-980 Hits. The goal of hit radio minus metal music is to make CHTX more palatable to females. The sound will be carefully tailored toward listeners between the ages of 18 and 34, 60 percent of whom will be female. The station IDs as 980-Hits and features the slogan "The most music allowed by law". The station will feature at least one cluster of 10 records in a row commercial free, every hour after 9 AM. As part of the overhaul, CHTX has hired a new morning man, Garry James, most recently morning host at Winnipeg's CITI-FM.

In a follow-up to this story, it was announced in the Montreal Gazette of February 17, that further changes were in the works for CHTX. CHTX should have a new 50,000 kilowatt transmitter on the air by September of this year on the new frequency of 990 Kilohertz. The former CKGM has occupied 980 kilohertz since signing on in 1959. In July 1983, Geoff. Stirling, owner of the station at the time, recognized his AM station's signal problems and decided to correct them. He got permission from the CRTC to boost the power to 50K and change the frequency to 990. His plans lay dormant until CHUM purchased CKGM and CHOM-FM in September 1985. The current transmitter site, in southwest Kahnawake, cannot be used because it is too close to Montreal and would create signal problems. Hambleton had no fewer than 18 potential transmitter sites rejected before Quebec approved CHUM's plans to put up a new transmitter between St. Isidore and Mercier, Quebec. CHTX has also decided to switch to AM stereo with the installation of their new transmitter. No firm date for the transfer has been given, just the tentative target of September 1989. More on this as it happens.

ACTION IN DOCKET CASE

January 30, 1989

FCC ISSUES DECLARATORY RULING CONCERNING ELIGIBILITY FOR AM DAYTIMER PREFERENCE (MM DOCKET 87-131)

The Commission has issued a declaratory ruling clarifying that, regardless of channel type, preference will be given to former daytimers with secondary status authorizations to operate at night.

This action grants a request by Newsic, Inc., licensee of daytime-only station WRWH(AM), Cleveland, GA, for clarification of issues relating to actions taken in a 1987 Report and Order. In that Order, the Commission authorized nighttime operations on regional channels for former daytime-only stations, reduced when necessary to avoid interference, and imposed secondary-service status on the nighttime operations of former daytimers operating with less than 250 watts nighttime power on those channels. The Commission, however, declined to address issues relating to the daytimer preference, concluding that those issues were beyond the scope of the proceeding.

Newsic requested explicit clarification that former regional channel daytime-only stations who received nighttime authorizations at a power level below 250 watts will remain eligible, if they meet other eatablished criteria, for the special comparative credit granted in Docket 84-231 to former AM daytimers competing in comparative hearings for new FM allotments.

Newsic pointed out that although the Order made passing reference to the daytimers' preference, it did not specifically state that such preferences were available to operators of former daytime-only stations who are presently operating on regional channels on a full-time basis at less than 250 watts nighttime power.

The Commission said that in adopting this preference, it did not condition its availability on the types of channels on which licensees may operate. It stated that in Docket 84-281, daytimers who received nighttime authorizations to operate with less than 250 watta power on any of the foreign clear channels would still be considered daytime-only licensees for purposes of determining eligibility for the daytimer preference. However, when this decision was made, no daytimers had been authorized by the FCC to operate at night on any type of channel except foreign clear channels. Therefore, the Commission had no opportunity to explicitly state its position with respect to other types of channels.

Accordingly, in response to Newsic's petition, the Commission has taken the opportunity to indicate that channel type was not a factor in determining eligibility for the daytimer preference when a daytimer subsequently receives a nighttime authorization. It was only incidental that the Commission's decision in Docket 84-281 was limited to stations operating on foreign clear channels. The line of demarcstion established in that Docket for determining eligibility of former daytimers for the daytimer preference was whether secondary status was conferred on their nighttime authorizations. The Commission has consistently conferred secondary status upon Class II and Class III nighttime authorizations of less than 250 watts.

Accordingly, the Commission concluded that former daytimers operating at night with an authorization of less than 250 watts power and not producing an effective field strength of 141 mV/m, or greater, at a distance of one kilometer from their transmitter sites, will be considered daytime-only licensees for purposes of determining eligibility for the daytimer preference, regardless of the channel on which they operate.

Action by the Commission January 18, 1989, by Memorandum Opinion and Order (FCC 89-17). Commissioners Patrick (Chairman) and Quello, with Commissioner Dennis concurring in the result and issuing a statement.

WI.RM-780 AM has adopted a "winning" format in a split from its simulcast with FM sister station WEQZ-102 (Q-102).

The dawn-to-dusk WLRM previously simulcast the signal of its sister station, Q-102, which features a light classic-rock format.

General manager Bill Clark said the

switch to WNN was the result of an effort to do something different with the AM signal of WLRM.

"A number of people in the metro area are into entrepreneurship, sa'es and marketing, and they need a shot of mental adrenaline," Clark said. "This seemed like a very yiable concept in this narket."

WNN, based in Pompano Eeach, Fla., and the brainchild of Joe Nuckols, presents a fast-paced format tar geting the trend-setting and profit-making "babyboomers." A WNN newscast is featured at the top of the hour and local news from the Mississippi Radio Network on the half-hour.

Clark knows WNN won't make WLRM, tagged "WNN AM 780," No. 1 in the local radio ratings.

However, "Jackson being the seat of government and business for the state, there is a large enough audience. We don't expect to be No. 1 in town, but No. 1 in terms of quality listeners."

Clark defines "quality listeners" as those who are highly educated, with discretionary income.

Easthampton AM station in doubt

The chances that Easthampton will get its own radio station are up in the air right now, as an 18month construction permit that was granted for an AM station in that town is about to expire.

The permit, granted to Edward F. Perry, Jr. of Kingston in September, 1987, would have allowed a 2,500 watt, daytime-only station to go on the air at 1140 AM. But because Perry has been granted a construction permit for another station in Amherst at 100.9 FM, it is likely that he will now have to sell the Easthampton frequency.

Perry began applying for the Amherst frequency back in 1972. He was granted a construction permit for the station several times, but the station never signed on the air because the proceedings have been continually challenged in court by Ted Peane, owner of WTTT-AM in Amherst. Peane has been interested in acquiring his own FM station in Amherst. Although the FCC has no definite rule against multiple ownership of radio stations in a particular locale, it prefers diversified ownership. One of the things the FCC took into consideration when it awarded Perry the Amherst license was the fact that he did not at that time own any other stations in this area.

Perry says he is going to file for a six-month extension of the Easthampton license next week. If he gets it, he said he will attempt to sell the station to someone who he feels can make it work. If his request for an extension is denied, the station will not go on the air because the FCC has put a hold on granting licenses for daytime AM stations.

Perry says that he would love to sell the Easthampton frequency to someone from the Five College community who would turn it into a noncommercial station. He envisions it as being a sort of "bulletin board" of the air for the college community, carrying listings of upcoming events and programs of interest to the colleges

"Here's an opportunity to take radio back to what I think the FCC intended it to be back in 1934, which is an educational medium," Perry said. "It would be a lot tougher nowadays for a new AM station, that broadcasts only during the day, to make money and establish a niche in the community. Therefore, I'd like to see the Five College community pool their assets and get the equivalent of a huge information system without having to wire anything up."

Perry heads up a consulting firm called FM Associates, based in Duxbury. The firm helps find frequencies for new radio stations, and also assists new stations to get on the air once they are granted frequencies. Perry has previously owned radio stations in Vernon, Conn. and Webster, Mass. He currently owns two stations, WATD-AM&FM in Marshfield, Mass., although he is planning to sell the AM soon.

Perry attended Amherst College for three years. He was in the class of 1963, but left prematurely at the end of 1962. He then took radio and television courses at Boston University and Emerson College in Boston. His ties to this area are strong, as his father, grandfather, and cousin all attended Amherst College, and his sister currently attends Northfield Mount Hermon School.

Perry says anyone from the Five College community who would like to talk about the Easthampton station can write to him at WATD in Marshfield.

At the beginning of 1989, Radio station WLND in Cortland joined the already increasing number of stations dedicated to broadcast-

ing Christian music and ministry.

Albert Zippay, manager and part owner of the station, believes there is a need for more Christian

radio programming.

FCC ORDERS WRPZ(AM), PARIS, KY, TO SHOW WHY ITS LICENSE SHOULD NOT BE REVOKED

The Commission has ordered Mega Broadcasting Corp., licensee of WRPZ(AM), Paris, KY, to show why its license should not be revoked, at a hearing to be held at a time and location specified in a subsequent Order.

The Mass Media Bureau received a complaint alleging that WRPZ(AM) had been off the air since October 11, 1987. The Field Operations Bureau (FOB) investigated and was told by John Bush, a co-owner of the licensee, that the station had ceased operation by the end of November 1987. After the FOB personnel monitored the station and confirmed that it was non-operational, a letter of inquiry was sent to the licensee seeking to ascertain whether it intended to resume operation. The letter, dated June 17, 1988, was returned stamped: "Return To Sender. No Forwarding Order on File." Thus, it appears, that WPRZ(AM) has not resumed operation since at least November

Furthermore, the licensee has neither requested FCC permission to remain off the air nor turned in its license, which are violations of Commission's rules.

In addition, the FCC ordered that if it is determined that the hearing record does not warrant revoking WRPZ(AM)'s license, the Commission will determine whether an order for \$20,000 forfeiture will be issued against Mega Broadcasting Corp.
