



DID YOU KNOW that you can always spot a directional AM radio station because it will always have more than one tower. In fact, a station with only one tower is most certainly a non-directional station.

DID YOU KNOW that 1540 kHz is a Clear Channel for the Bahamas? This means that U.S. stations cannot transmit substantial signals in their direction (FCC Rule 73.25[b]). You may be able to hear the Bahamian station, ZNS-1540 where you live.

DID YOU KNOW that some major highways pass between the towers of some directional stations? WSUN at Tampa Bay is one, KWAL is Wallace, Idaho is another. If you know of more, send them in. You'd think that a large truck passing by might upset the phasing!

Broadcast Station Pioneers: State-by-State Thomas H. White – January 1, 1992

The fall of 1921 saw the formal st inauguration of the broadcast service in the United States. In the year that followed the

United States. In the year that followed the Commerce Department issued over 550 broadcast station authorizations, including at least one for each of the 48 states plus Alaska, Hawaii, Puerto Rico and the District of Columbia.

This is a review of the spread of broadcasting across the United States-starting in Pennsylvania and ending in Wyoming--listing chronologically the first broadcast station granted in each state. In most cases these stations were also the first to go on air in the state, although in a few cases rivals may have beaten them to the airwaves. [NOTE: Although the Commerce Department didn't begin to grant formal broadcast licences until late 1921, Westinghouse's KDKA and WJZ, which pioneered broadcast development, are listed according to their initial land station grant dates].

The list reviews 52 jurisdictions: the 48 states, the territories of Hawaii and Alaska. plus Puerto Rico and the District of Columbia. There are a total of 54 stations, because in two cases (New Mexico and Idaho) there was a tie between two stations for the honor of first licencee. Only 19 of the 54 stations have survived to today. However, they are among the most prominent in the nation. Surprisingly, two of the stations are no longer in the states in which they originated -- KYW has moved from Illinois to Pennsylvania, and WJZ of New Jersey is now WABC in New York. Thirty-five stations didn't make it--some expired after just a few weeks or months-reflecting the tumultuous period of rapid change.

The list is organized chronologically, state by state. Each entry has the rank for the given state (where "state" includes Hawaii, Alaska, Puerto Rico, and the District of Columbia). In case of a tie between states the ranking is only listed once. This is followed by the state abbreviation plus the call, city and original owner of the pioneering station. (Both stations are listed in the two cases where there was a tie within a state.)

Each station entry includes, in parentheses or brackets, the station's overall position among all licences issued in the United States. Numbers in parentheses come from my research on station grant dates. An '*' means the station is tied with one or more other licences issued the same day. For grants made after May, 1922 I used the Radio Service Bulletin monthly lists, so the numbers in brackets are estimates. The next line lists the station outcome-either deletion date or its current call and location.

This can get confusing, so here is an interpretation of a sample entry: both WLB Minneapolis, MN and WHA Madison, WI received initial broadcast licences on 1/13/22. Each was the first within the state, so Minnesota and Wisconsin are tied for the honor of being the 13th state to receive a broadcast station authorization. In addition, according to my research these two stations are tied for 34th place among all station licences issued. Both stations survive to this day, although WLB has changed its call to KUOM.

ichael Glinter believes the recession is one reason Summers gospel music is becoming more popular, and not just for Christians

"This music offers people hope," he said. "As people suffer more, they begin to look back to traditional values."

Unlike other forms of music, Southern gospel hasn't changed dramatically during the past few decades.

The music, especially popular with people over 40, can remind listeners of simpler times.

Glinter, a 43-year-old Kansas City, Mo., resident, is the owner of WREN-AM, Topeka's only Southern gospel radio station.

"It is one of the fastest growing formats today," he said.

Glinter said Southern gospel also has ridden the bandwagon of the revival in traditional country music

Glinter revived WREN, at 1256 on the AM dial, one year ago. The station went off the air in 1987 because of the previous owners' financial problems.

The station had a long and rich history. It first went on the air in 1926, and was owned by former Gov. Atf Landon from 1952 until 1982.

WREN is in a small building along a lonely gravel road just east of Grant-

ville. Four nearby radio towers, each 199 feet tall, serve as a landmark.

Glinter said the four towers recently were connected, which means WREN's night-time signal soon will be heard in Colorado, as it was in Landon's days. The former governor ordered that arrangement because he had a vacation home in Colorado

Glinter hopes to get permission to boost the power of the 5,000-wait station to at least 10,000 watts.

Glinter got a little radio experience while he attended Detroit Bible College from 1965 to 1968 He moved to Kansas City in the 1970s

to manage a Christian radio station owned by er.

a longtime friend. In 1981, Glinter was hired by Sateilite

Radio Network, which owns three radio stations. He now is president of that company, and he owns WREN. WREN has just two full-time employ-

ees and one part-time employee. Most of the programming is supplied from Nashville

Phil Swartz, a board operator at the station, said he has regular callers. "They get to know us as a personal friend " Swartz said. Swartz, a 33-year-old Topekan who

has an large personal collection of Southern gospel music dating back to the 1940s, plays local requests on Sunday afternoons

Pirate radio beams settler perspective

BEIT EL. West Bank -- Leaders of the Israeli settlers are borrowing ideas from their opponents on the left, including the creation of a pirate radio station, similar to one created by peace activist Abie Nathan almost 20 years ago.

Mr. Nathan's unlicensed station, called the Voice of Peace, broadcasts from a ship in the Mediterranean anchored just outside Israeli territorial waters. The settlers' unlicensed station, called Channel Seven, was the creation of Rabbi Zalman Melamed, the leader of an influential religious school in Beit EL an active settlement north of Jerusalem. Its ship is anchored right alongside that of the Voice of Peace.

But, while the Voice of Peace plays a mix of pop and easy listening music, mostly in English, mingled with

other, Channel Seven is strictly Hebrew, and strictly politics.

Its estimated 500,000 listeners hear an assortment of traditional Israeli folk songs, contemporary Sephatdi fare and ultra-orthodox klezmer music, along with religious and political commentary from a right-wing perspective.

Newscasts on the hour, borrowed from Israel's government radio, arc followed by personal commentaries that stress the importance of the land of Israel and the Bible.

No foreign-language songs are to be played, no risqué language is to be used, and even commercials are subjected to strict scrutiny. Rabbi Melamed forbids any advertisements for non-kosher restaurants or German products.

In September, the station unveiled its own news service, broad-you have to start somewhere."

I recently purchased the book "Latin America by Radio" thru NRC publications and highly recommend it for anyone interested in Latin AMerican DX. It's full of usefull tips, including info on advertisers and product names, sample Spanish reception reports, an informative section about different styles of music and Spanish/English broadcast terminology. It was published in 1989 but it doesn't seem to be outdated. I studied Spanish at U MA-Lowell for 5 semesters and still have trouble understanding LA broadcasts.
