# DDXD-East

So many changes; so little time! Sunday I traded in my 1997 Plymouth Neon and bought a 2001 Hyundai Elantra. Great warranty on the thing (and if past Hyundai are any indication, I'll *need* that warranty). I rescued my CCrane coil-loaded whip from the Neon, but it won't fit the Hyundai without an adapter from CCrane. Still, I have had a chance to do a mini-evaluation on the MW reception of the radio (it's the AM/FM/CD upgrade).

The verdict: Don't they listen to MW in South Korea? Maybe the CCrane antenna was a *lot* better than the stock Mopar antenna. Whatever the reason, the Hyundai AM tuner is inferior. Coming home tonight from my job in St. Petersburg, I heard 970 WFLA FL Tampa do power/pattern change at 1745. I was in Dunedin (a great little town a few miles north of Clearwater) at the time, and WFLA got significantly weaker with distorted audio. This is something that never happened with the old Mopar. A casual band scan revealed that most of my favorites were still there, but a few were missing and copy wasn't as good on those that remained. I also miss my tuning knob! The Hyundai, like many other newer tuners, has the rocking switch that tunes up and down.

The worst tuning scheme in my opinion is the tuner in my wife's 2000 Ford Focus. To step through the band, you must enter the manual tuning mode, then tap up or down. If you pause to copy for any length of time, you have to re-enter the manual mode to tune it again. Jeez!

At 0020, I hear English words "Guidelines International Ministries," slogan "Radio Luz, 1040, una estacion con nadima(?)," talked of what sounded like "produccion con Manos Battias" and played Mexican version of gospel rock. At 0027, gave time check "Cinco con treinta minutos" and started what appeared to be a program centered around a ministry for women ... Comentamos, comentamos, comentamos," the introducer said, and the female minister came on. No call letters heard. I called up "Radio Luz Chihuahua" on internet search engine and found IDXD column from a year ago where John Wilkins heard this station's new slogan. Like John, I did not hear call letters. [Callarman-TX]

- 1050.3 unID DEC 3 0315 slow Spanish talk and het against WEVD. [Connelly\*H-MA]
- 1060 MEXICO R. Educación, XÈEP, Mexico City, DEC 2 0318 classical violin music rolling over KYW on 70-250 degree loop during good auroral opening to Mexico. [Connelly\*B-MA]
- 1060.3 COLOMBIA unID city, NOV 18 1043 Spanish vocal with a rural style of music having South American Indian influences; poor. DEC 2 2344 - emotional Spanish vocal; QRM from Cuba-1060. [Connelly\*H-MA]
- 1070 MEXICO XEANT, La Voz de las Huastecas, Tancanhuitz de los Santos SLP, DEC 7 0201 stumbled across this one just beginning its sign/off announcement, with soft-voiced, non-announcer sounding man, in the small window that nulls both KRLD's lower sideband slop and KFDI. Announcement, barring misunderstood words, was: "Muy buenos tardes a todos ustedes. Estamos dando las gracias por haber escuchando durante este dia en su radioemisora de XEANT, La Voz de las Huastecas, en el mil setenta en su radio por mensajes, en presentando musica, noticias y programas interes ... Y los invitamos a nos accompania el dia de mañana a partido de seis en punto." The announcement did not include a city or state. A female vocal, title apparently "Tomas" sounded like a teeny-bopper crush song, "Johnny Angel" style, followed by "Sixteen Tons," sung in English but with a Spanish accent by a deep-voiced Tennesee Ernie Ford copycat. (I kept the tape on for the entire song.) Ricky-tick piano and brass theme song followed at 1157, with closing credits including names of Victor Gonzales and Arturo Hernández, among others. At 1158, Mexican National Anthem began, but by 1200 end, all I could identify was KSTP. [Callarman-TX]
- 1510 MEXICO, XEQI, Radio Uno, Sultana, Monterrey, NL DEC 10 0345-0507 growing in strength in WLAC null, playing mild ranchera/norteno music, deep voiced announcer with "Radio Uno, Sultana" announcement in every break. (At first I copied last word as Puntana, then Cultana and finally, as signal became stronger and clearer, Sultana.) No commercials heard, but mention of Monterrey and "gobierno del estado de Nuevo Leon" mentioned several times. At 0458, had announcement touting something that would happen "diez de la manana al Teatro Calderon." Then an announcement involving "los jovenes" and "problemas escpeciales." The Fred Cantu website (www.mexicoradiotv.com) shows XEQI's slogan as Radio Uno, Radio Nuevo Leon, and provides a link to the XEQI website. Unfortunately, the AM portion remains under construction, while the FM portion tells of XHQI's classical music programming. WRTH-2000 lists this one as a 50,000-watt daytimer. No call letters heard. [Callarman-TX]
- 1529.53 unID DEC 2 0302 probably Uruguay as heard in Newfoundland. Het against WSAI/Sao Tome-1530, fragments of talk. [Connelly\*B-MA]
- MEXICO. XEUR, Mexico, DF, DEC10 0436-0450 Surprised to find this one here with talk, 1530 good at times, low key approach in comparison to most Mexicans. Heard deep voice announcer with promo "En Terce,' con Teador Renteria. Escuchamos de ... savientes ... doce de la ... a dos de la tarde, a traves de ... de música, la instrumental de Mexico," (as I transcribe what I thought I heard.) Then announcer begins long introduction to program "En el Telefon Dos Mil," presented by Organizacion Radiorama. A part of the intro: "A traves de XEUR, Radio (Temalco... not clear), a traves diez mil (probably 530), amplitud modulada ..." and mentioned "Mexico, Guatemala, Brazil, Argentina, Estados Unidos y todos unidos a llevar esta telefon latinoamericana." Thus began a remote broadcast, with carbon mike sound, featuring man and woman, crowd noise in background, and music. During 0448-0450 taping, several times said "Organización Radiorama esta presente 'En el Telefon Dos Mil." Gave time check ... "en la capital de la pais." Slogan reportedly is 15-30 Tu Musica and it's possible that "de música" in Teador Renteria quote and "Temalco" could fit. Otherwise, I did not hear that slogan. Checked other Mexico City frequencies, 1470, 1500, 1560, 1590, and found fragments of Spanish but not enough to try to identify. [Callarman-TX]
- 1670 unID DEC 4 2228 evangelistic preaching in Spanish, atop US C&W station. Not sure if a domestic, Argentina, or something else. [Connelly\*B-MA]

John speaks: "One of my unidentifieds on 1000 had a commercial last night for "Mariachi Bar Nightclub," something that brings almost immediately to mind Ciudad Juarez across from El Paso ... and I tried to ID others on 1010, 1070 after XEANT left, 1170 with a "Cafe Coahuila" commercial, and 1100. I hope I can spur others, maybe with better equipment that I, to meet the challenge of logging some of these most interesting stations. I'm also checking 550, 560, 600, 700, 710, 760, 770, 1010, 1100, 1100 1180, 1210 for other stations from whom I've heard bits and pieces in the past two weeks. And I'm rechecking other channels to tape full IDs with better reception and/or to pull out the second or third stations heard."

#### TRANS-PACIFIC DX

1575 THAILAND Bangkok (presumed), DEC 4 1132-1141, Recent unusual conditions have produced reception of what I believe to be the VOA in Bangkok on 1575 kHz, with brief bursts of audio in noise, male voice. Again DEC 7 1138-1147 in and out with short periods of audio, male voice. This station has been heard every winter (NOV-FEB) for the past eight or ten years that I have been monitoring TP frequencies on a daily basis. Usually just a carrier, but occasional audio. Best ever reception was FEB 1, 1998, when I got a nice tape of a program in a SE Asian language. Tentative identification based on (1) Past receptions (notably 1998 tape.)(2) Signal fading typical of trranspolar propagation. (3)Propagation conditions, i.e., not a trace of common Aussies on 1548, 1512 and 1503 kHz (4) All of South America in daylight eliminating possibility of a deep SA.(5) VOA Burmese program on 9890 and 11850 kHz sounded exacly like what I taped on 1575 kHz, man talking with several brief pieces of music, from 1130-1200 when monitored on DEC 9 with SW loop. Came on with Yankee Doodle at 1130 which I will be listening for next time the 1575 kHz station comes in. Incidentally, WRTVH lists VOA Thailand on 9890 and 11850 kHz while PWBR does not mention them. [Moore-FL]

## WORCESTER MW RECEIVER

We begin with some comments on this receiver which was discussed the last couple of weeks from the member who was rumored to have one...

Dave, Although not a regular member of the list I thought I'd add a few comments in reply to the last DXN. Yes, I had and STILL HAVE a Joe Worcester receiver, one of only 3 or 4 ever sold. I believe Joe produced 5 of these rigs but didn't sell them all, as I recall the price was around \$700 and in 1975 that was a lot of money. My radio served me well for quite a long time although I must admit my trusty one-owner HQ180A remained my favorite BCB DX weapon. The main drawback of the Worcester was that the AGC/AVC circuit had a fixed time constant and it was pretty heavy on compression. I would have been happier if the AVC gain and attack had been variable. But once one got used to the unique audio quality it was a very good selective and sensitive rig and was quite immune to mixing products which wasn't usually the case for all solid state receivers in the 70's. The tuning knob had a somewhat "rubbery" feel since the shaft extension was a bit flexible but one also got used to the tactile properties of the rig. The fit and finish were that of an obviously hand built unit. Unfortunately about 15 years ago something in the audio circuit died, the radio functioned normally except that it had no audio output. I'm sure the audio in this rig is fairly straight forward but lacking a schematic I never got around to troubleshooting the problem. This happened about the same time my interest in MW DXing took a back seat to family matters (moving to a new home, the growing size of my family, etc) so I put it away in a box and there is sits to this very day. One time I phoned Joe and asked if he'd consider doing the repair work but he begged off due to his health, arthritis in his hands had forced him to give up electronic building and experimentation. This was the reason Worcester products disappeared from the DXing scene. It's been so long I don't remember if it would tune past 1600 kHz, it may very well not be capable of receiving in the X band. I would entertain serious offers from somebody who would understand the collectability of a receiver this rare and probably could "clean up" if I offered it on ebay but if I did sell it I'd like to know it went to somebody who has an appreciation for what it is and its place in DX history. The audio repair shouldn't be too difficult if one had the time and patience. I remember another peculiarity of the Worcester receiver, the tuning knob turned COUNTER clockwise to increase the frequency, which seemed backward to me. Maybe Joe was left-handed. I had to put a note on the front of the rig to remind me to turn the knob opposite of intuition. This was one of the first consumer-priced rigs (as opposed to the multi thousand buck commercial units) that had a large LEDtype digital frequency readout.

**Doug Smith**, W9WI <w9wi@w9wi.com>: A quick workaround for any solid-state radio with audio circuit problems, is to hook a shielded line between the two outer terminals on the volume control (hook the shield to the terminal that's grounded) and hook the other end to an external audio amplifier - either your home stereo, or a set of amplified computer speakers, or one of the powered speakers Radio Shack sells. If you know what you're doing with electronics, you can probably apply the same fix to a tube-type radio, but since there are high voltages floating around tube sets are best left alone if you're not familiar with electronics...The reprint says nothing about X-band coverage. But it apparently uses a standard LC oscillator so could presumably be tweaked into covering the X-band? (at least it has a digital display, so you don't have to worry about wrecking the dial calibration)

#### IONOSPHERE

Continuing the recent discussion on the state of the ionosphere...

**Russ Edmunds** <wb2bjh@nrcdxas.org>: "I've been following the discussion about the ionosphere being somehow maxed out in recent years, and I have to admit I'm a bit baffled." David, we can discuss this off-list in more detail if you'd ike, as this is one of my favorite topics, and one I've done a lot of reading on over the years. With a bit of luck, given our respective locations, we might even be able to do so in person further on...For this venue, I'll say simply that as noted in my earlier post, I concur that the ionosphere itself isn't likely saturated, and that the noise pollution probably doesn't impact there. But all of the increased RF in terms of total numbers of stations, total numbers of megawatts, less quality maintenance, more RF noise, etc. are all factors in reducing apparent signal strength (which is, after all, relative to the overall noise level). And it is also pretty well documented that auroral conditions do indeed attenuate (often to the point of apparently removing) signals which are normally dominant via skywave (usually from the northerly directions), rather than enhancing the signals from other directions, although I wouldn't go so far as to say that some enhancement isn't either occurring or possible.

**Paul Smith**, W4KNX <sunray2@gte.net>: It is my opinion as a degreed electrical engineer, that 1 bolt of lightning has as much RF energy as all the Radio transmitters in the world combined. Just my \$0.02 worth.

**Russ Edmunds** <wb2bjh@nrcdxas.org>: Thanks for confirming my thoughts! The noise aggregation (including 'unwanted' signals) certainly is greater, which ought to create a greater ambient noise level at the receiver, which in turn should, on a relative basis, reduce the apparent strength of the DX signals. But that has little to do with the ionosphere. As to the various research bombarding the ionosphere, particularly about the North Pole, with RF, I suppose it might be conceivable, since this is aimed right at the ionosphere (as opposed to lightning) that some temporary or even longer term effects might result...

**Robert Foxworth** <rfoxwor1@tampabay.rr.com>: I, for one, enjoy reading these joules of knowledge from Paul. Seriously, what should be remembered is that the RF from a lightning strike is spread over octaves of spectrum and has relatively low power density at any given bandwidth of say < 100 Hz. A pure carrier has 100% of its power in the same bandwidth. Just \$ 0.01 for this, thanks.

**Bruce Conti** <BACONTI@aol.com>: There is evidence that the ionosphere can in effect "boost" signals. I placed boost in quotations only because I'm not sure whether it's a boost, or just that an optimum propagation path is produced. This is most noticeable on the east coast at local sunset, when transatlantic signals are often received at maximum. The same occurs at transmitter site dawn. Furthermore, when the transmitter at a transatlantic location is at sunrise, and the receiver is at sunset, "grayline" reception can occur where the signal travels along the daylight/nighttime borderline. Hypothesis: If a boost or optimal path occurs during critical sunrise/sunset hours, then a similar effect should be conceivable along the borders of the auroral dome. As the auroral dome expands and contracts, it may produce results similar to those of the critical sunrise/sunset hours. I have often observed a peak in transatlantic reception days after a major storm as the ionosphere is settling down. Once the ionosphere is quiet, transatlantic reception returns to normal. Thus there can be moments when reception conditions are ripe for transatlantic and transpacific reception despite being at the peak of the solar cycle. You just have to be in the right place at the right time.

**Russ Edmunds**: Most of what I remember about enhancements such as you mention are reported to be a function of the changes resulting from the active ionization which is occurring at those times, and not at any other. While I don't have it handy, I believe one or more the Reprints articles on SR/SS addresses that.

Mark Durenberger <mark@durenberger.com>: What I think is way cool about Bruce's comment is his last line. It defines our hobby, doesn't it?

John Tudenham <w0jrp@earthlink.net>: Does anyone know if ground conductivity can also boast sky wave signals on the receiving end? when 1 lived in the Texas panhandle, which has one the best ground conductivity in the states it seemed to me the sky wave signals were also stronger than our location here in the Missouri zarks where it is poor. I still notice the same think when I go back there for a visit so it has not changed. Both John Callarman and Larry Godwin made some great DX catches while they lived there. Of course groundwave coverage has always been good there.rThere is an area of good ground conductivity running NNE from the TX panhandle through western Kansas,eCentral NE, and SD.

**Russ Edmunds:** Yes, it does - good ground conductivity at the transmitter or receiver end increases antenna system effectiveness. That's another factor in favor of oceanside locations.

**Russ Edmunds**: But most of them are to very quiet parts of the world in terms of local signals and also noise. And many are oceanside. I don't think a DXpedition would be anywhere near as successful if they tried to set up shop, say, in Independence Park in Philadelphia, or Central Park in Manhattan:):)

**Randy Stewart** <jrs555t@smsu.edu>: Or, as John Tudenham mentioned, here in southwest Missouri with our p%ss-poor ground conductivity!! I've never had the opportunity to set up a really LONG wire, but I've often wondered if its performance would be compromised seriously by this location and its lack of ground conductivity...

Kevin Redding <lwdxer@juno.com>: Randy, Beverage antennas LOVE poor soil conductivity. Just bring lots of water for the ground rod and life will be good. At least that's what it seems to me. I have run wires here in the desert and sank the rod in the Rio Salado and the reception was very good. Believe me that the soils here are about bad as they get. Try it, you'll like it.

Andrew Ooms <oomspine@cybertrails.com>: A while back I read, maybe something from Barry Mishkind (thank you Barry) that in the late 1920's, Chicago radio stations signed off early Mondays, and as early as prime time, were silent. This was done in order that Chicago citizens could DX. Eventually the stations decided to stop forgoing the advertising income for Monday evenings and announced that they would have Monday evening schedules. Protests resulted from DXers and a listener's boy-

cott was threatened. However the protests were ignored, the stations were no longer silent on Mondays, and no boycott effect was ever noticed. So DXing has been around a long time; longings for the good old better days of fewer signals started early; and no surprise, radio fans can't keep their sets turned off even for a "good" cause.

**Russ Edmunds** <wb2bjh@nrcdxas.org>: I still haven't even found a het from this location, even with low A-index. I'm beginning to think that this location has some problems that simply won't be overcome without getting the shack out of the basement, and that's a few years off.

Mark Connelly <MarkWA1ION@excite.com>: It's too bad that there are all kinds of houses not too far from here right along the coast north and south of Boston but very few DXers are in them. TA's can probably be heard well there 9 nights out of 10. Unfortunately where those with the talent and desire for DX are, the DX often isn't. I guess that's why DXpeditions to Newfoundland and elsewhere are so necessary.

**Russ Edmunds**: What really amazes me is what I was able to hear with my HQ-150 and FET loop in a garden apartment complex in Parsippany NJ from 1969 - 75 l didn't hear all of what Ben was hearing, nor all of what the New Englanders were, but I heard a great deal TA-wise that I wish I could get here. I suspect I've got some sort of horizon blockage not too far out that I'm not aware of, which, when added to the basement shack, creates some major problems. But I'll keep trying, because I simply refuse to believe that even in a sunspot maximum year, I can't even find any TA signals if Ben is hearing good stuff!

**Ben Dangerfield**: I agree with Mark that we can't always be where the best DX is. And I have always enjoyed just getting the most out of my location [Wallingford, Pa.] even though the TAs and other good stuff don't always roll in on demand. When one of those TA [or auroral] cycles does occur I can overlook all the bad days. In fact, if every night was perfect, it would get awfully boring!

Russ Edmunds: Absolutely! But now if you could just figure out a way to let me know about those good TA openings in advance <grin>

Michael Shaw N1XTV <mshaw002@tampabay.rr.com>: Having lived on the North Shore of Massachusetts (Beverly), I can tell you that—in principle—it's a fantastic location for DX. But in practice, I found that in my situation there was noise, noise and more noise. I lived in an apartment complex. I had to put up with dimmer switches (our halogen torchieres that my wife insisted on keeping until we moved plus those of our neighbors); sputtering street lamps that the management installed for outdoor lighting; noise from my cable modem and computer monitor; and noise from a CBer using a kilowatt linear about a 1/4 mile away. But when it was quiet...oh, my was it a great QTH!

**Ben Dangerfield**: I am well aware of the extreme solar activity around these days and wonder if the erratic, cross-the-band buzz I have been getting is a result. It is not consistent and comes and goes. I do not think it can be traced to a neighbor's lights as I tracked it for at least 2 miles on my car radio. I have been hearing it for the past couple of weeks, often in short bursts. Has anyone else had it?

**Russ Edmunds**: I haven't noticed it, however, there could be a correlation with geomagnetic activity. Usually, though that's less of a buzz than white noise, but under such intense conditions, the overall absorption level for signals could be acting to create the perception of elevating a noise which is usually buried by signals...

**Patrick Martin** <mwdxer@webtv.net>: I totally agree that we can't all have good DX all the time. Even in my rural area on the Northern Oregon coast I get sunspots and bad conditions at times too. In fact in the past few years DX has not been what it used to be. We should be happy with what we have had with DX. Conditions will improve again as soon as all the sun stuff drop off within the next few years.

#### RECEIVER QUESTION

**Kevin Redding** <lwdxer@juno.com>: OK guys, Many of you have been doing this a lot longer than I have. I have come to the oracles seeking answers. I have two old radios that have a switch on them, and they both are only AM/FM radios, the switch is marked AM Beat, A - B. I have no idea what this does? I played with it and couldn't figure it out. This is one for you older guys.

**Robert Foxworth** <rfoxwor1@tampabay.rr.com>:Okay...Older Guys step in here, now:-)...Oracles Tomorrow...The only time I've ever seen any kind of switch like this on a radio is on my SR-2100 series mini-boombox with digital AM/FM and cassette rec/player, house brand sold by Sears, I bought mine in 1986 or 1987. A radio ahead of it's time, it tuned to 1710 kHz years before there were any stations. There is a small slide switch marked "oscillator A-B" on the back near the battery compartment. It would shift the bias oscillator for the cassette recorder freq slightly in case you were trying to record an AM signal (I TOLD you this was an Old Set, hi) and there was an oscillator harmonic on the signal. I've used it a few times. So to me the word 'beat' implies an oscillator somewhere. But without a cassette recorder in your set, I wouldn't know. Maybe the AM Local Oscillator ran when the set was in FM mode? (dohh...) Put one of your sets on, tuned to say 1000 kc. (set A) Take a separate radio and put it right next to the set on 1000 and tune to 1455 (set B) and try to hear the local oscillator signal from set A on your set B. Then operate the A-B switch on set A and see if the signal heard on set B changes. If that doesn't do anything then I have no idea.

Kevin Redding: l didn't think about this but l can't remember but one of these definitely is a AM/ FM cassette player. Do you ever use that Sears boombox any more? The one that l know has a cassette player, essentially a GE SRII with a cassette, has this AM Beat function. I also have a Readers Digest AM/FM cassette with an oscillator also. There is another radio l have with this and can't remember which one it is...Bob, I'll try it. I always wondered what that was. This is as good an explanation as any. This radio has a sleep timer but only for the cassette also. The radio in it is good, but this GE SR II with cassette seems to be built more around the cassette than anything else.

Doug Smith, W9WI <w9wi@w9wi.com>: Might I guess they have tape recorders built-in? A tape recorder contains an oscillator operating at an ultrasonic frequency, known as a "bias oscillator". Reportedly, in some sets harmonics of this oscillator would mix ("beat") with the carriers of AM stations and generate interference when you tried to tape the AM stations. The exact frequency. That gets rid of the interference with the station you're taping. (and moves it somewhere else on the dial...)

**Doug Smith,** W9WI: "Then operate the A-B switch on set A and see if the signal heard on set B changes." But it's not the local oscillator signal that switch is moving. The bias oscillator is something else. Moving the local oscillator either tunes the set to a different station, or requires you to move the entire intermediate-frequency amplifier chain. (I'm quite sure you're right that this switch is for a bias oscillator. If Kevin comes back & says there's no tape deck, I'm going to be VERY surprised()

Robert Foxworth: Yes you're right. See what happens when I post anything at 0730??? I told you good people...Oracles Tomorrow...old guys today...and it worked...

Tom Dimeo <radio@blazenet.net>: I have a Sangean ATS-818 with a switch to change the bias oscillator frequency on the recorder and it works quite well when the oscillator causes a heterodyne on a signal. Wonder if better shielding would shield out the oscillator and, maybe, be less expensive than a switch and associated circuitry?

#### PUBLISHING

We start out this topic with Paul's responses to some of the issues raised on this subject. As an aside as to the method of communications, in preparing this column I noticed that all of the messages you have seen in the last three columns on this subject were posted to the listserv on the same day!!

**Paul Swearingen** <PIsBCBDXER@aol.com>: "However, if you have a desire of seeing the NRC flourish in the coming decades, you will have to figure out how to deal with those fears and allow technology work for you rather than pretending it doesn't exist." Okay, two thoughts here...does anyone take a laptop into the bathroom for casual reading (you DON'T need to answer that, but do consider the many situations where paper is still more convenient than plastic)? Second, this forum (and others) has proved quite useful for the dissemination of time-value DX news topics (new X-band stations, short-notice tests, etc.); do we really need to put up with the inconvenience of an electronic device (batteries, weight, connectivity, etc.), when a.95 ounce saddle-stapled object can deliver the same information to anyone, any time, anywhere? I don't know about youse guys, but I still like to get away from a CRT as often as I can. When computerized news delivery can be accomplished via permanent implants in my body, I'll change my mind. But not until then. I, too, subscribe to SDXM, rather than DXM, but for far different reasons than those you list.

**Paul Swearingen:** " a major gating factor is "who's going to do the additional work, and does it work logistically?" " Another is the cost of the equipment. Creating file for a web page for DXN wouldn't require much additional time or effort on my part, as long as my current equipment would be up to it (and my Mac clone isn't even a G3, at least not yet). I've spent more time and effort in the past 3 months battling printer problems than 1 can imagine spending learning and implementing the rudiments of Internet publishing. Nevertheless, whatever we decide to do has to be what the membership wants. Perhaps an adjunct publication using elements from both DXN and DXAS would fly in the near future, but if the web site got only a couple hundred hits a month, I wouldn't want to bother to continue with it.

Doug Smith: If your hardware is up to browsing the Web, it's up to creating Web pages. The way I see an "EDXN", it would not be posted as a web site. Rather, it would be a \*file\* in HTML format. (actually a collection of files, as any images cannot be part of the same file as the text. It would be possible to split the text into separate files as well - for example, it might make sense to create each column as a separate file.) This collection of files could be compressed with PKZIP both to reduce transmission time and to ensure the collection remains intact. The collection - or more likely the single archive containing the collection - could be emailed to a mailing list; you could only get on the mailing list by approval of the "moderator" (who would make sure you'd paid the appropriate dues) and only the moderator could post to the list. The PDF format would probably be even easier to create - I'm not familiar with PDF creation software but I'd be surprised if there isn't a plug-in for Pagemaker that would handle that. Of course, PDF does have the problem of being inaccessible to the visually impaired. (may not be a problem as we'd still have the DXAS) I don't know how you're producing DXN right now - I presume the whole thing is a single Pagemaker document? I don't know as a fact that Pagemaker is capable of doing a "Save As" in HTML format, but I wouldn't be surprised if it can. Certainly other text processing programs can do that. Alternatively, the text and image files could be emailed to someone else who would assemble it into a web document.

**Bruce Conti** <BACONTI@aol.com>: "I suspect that the AM LOG and AM Switch are examples where having them in electronic form would make life a lot easier for many." Electronic form would make life more difficult for me. I'd hate to have to turn on the computer to look up stations while I'm DXing. I wouldn't like having to print out 320 pages of the AM Log either. \$16.95 to have someone else print an annual update is a steal. It's easy enough to pencil in changes. Don't get me wrong. I'm not a Luddite when it comes to technology, but there are some things that the print media still does best.

**Bob Klinger** <Rklinger9?@aol.com>: For what its worth, I have been DXing for about 17 years off and on. It has only been the past year and a half that I have really got bitten by the bug! Due in part I would say is because of the "Computer" and all that is accessible to the DXer! I just recently rejoined the NRC after a 15 year hiatus, and boy am I glad! The computer is very helpful in some aspects of the hobby, but reading it in "BLACK & WHITE" is still neat! It may be old fashion, but hay so is DXing in away! I get a kick when I read how this person heard California from say Pennsylvania on a regular basic, or how this person could hear a station signing off in every time zone, and etc. Now those were the days! Today it's nothing but fighting through @#\$%^&\*()....a.k.a. static. If I ever hear California from hear in Pennsylvania, that will be a special day. I just recently heard KOA and was thrilled to death about it! Well, that's my two cents! Not much I know but I just had to get it off my chest!:)

**Russ Edmunds** <wb2bjh@nrcdxas.org>: At the risk of being redundant on this, the bottom line still has to be do enough members want this to even pursue it? Like anything else, there's nothing like a consumer demand. But so far, given 40% of total IRCA membership is doing the electronic version; given the overlap with the NRC membership as evidenced here, and given the small proportion of NRC/DXAS members active electronically here, I don't know that we have that. What we have is a segment of the membership that is active on the list, which is a small piece of a still fairly small piece of the whole pie. Once again, I would personally like it, but based on cost-benefit, I'm not yet convinced now is the time based on this week's discussions here. And, finally, having been there, I'd be the last one to stand up and say to someone who is putting in x number of hours a week for the club right now that I want them to put in X+ hours without a lot stronger support.

Harry Helms <ak6c@earthlink.net>: As I've mentioned to a couple of you in private e-mails, I would've volunteered to take the lead with any electronic publishing initiatives NRC would have liked to explored, such as an electronic version of the Log or an on-line version of DXN. But judging from the response to date, I don't think I'll have to make good on that offer any time soon, hi!

**Russ Edmunds**: That may depend on what happens when this discussion ripens in the 'old-fashioned' pages of DXN:)

John Callarman < John Callarman@email.msn.com>: Russ Edmonds added an important factor into the ongoing discussion when he said, "a key factor here is in a volunteer specialty organization, you have only so many people willing and able to do the work, and adding more media in parallel increases the work on those few ... " The following is an extremely simplified history to lead up to my point: When an avalanche of quibbling became a crisis in the late '50s, a volunteer publisher rescued the club bulletin after a convention vote in 1959 to do away with the board of directors form of government. Some members questioned some decisions made by the subsequent "government" - the two editors and the publisher - and, when the trio did not satisfy those members with their actions, volunteers from the dissident ranks of the NRC formed a new club in 1964, and it grew into the IRCA. Meanwhile, a new NRC publisher presided over a quiet period of growth, then in early 1967, after I'd moved to Boston where I could build a solid base of volunteers to do bulletin publishing work, I became publisher. In summer 1968, I married and my new bride gave me a choice. The choice resulted in a major crisis for the NRC...no publisher and no transition time, as there had been in the past. At one time, in 1968, it appeared we would merge with IRCA, under IRCA's terms, and I would go down in history as the man who killed the NRC. But the surviving Boston Publishing Committee established offset publishing and the sharing of technical knowledge that spread throughout the DX'ing hobby. As BPC began to lose interest and become less responsive to member needs, Russ Edmunds in New Jersey was the volunteer to continue the growth of the club. Some good people in Louisville continued the process, there was a setback referred to in discussions about attempts to make the NRC Log a private profit-making venture, and then the current group of officers and board members was established, Along the way, the club incorporated, delegated the various elements of the work to different volunteers in all parts of the country so there would be 1) no load too heavy for a single individual, and 2) less chance of a debilitating crisis if one of the key volunteers should have to quit. Checks and balances were established to avoid "cheating" by any one of the responsible volunteers. The NRC Log, my primary contribution in 1968 and for a couple of editions in the mid-'70s, is now done beautifully and efficiently by a long-standing, loyal volunteer and a whole group of volunteer contributors. Two new elements were added by anotherpcompetent, creative, hard-working volunteer, the DX Audio Service and this list service. I suspect most of us would be shocked if we knew how many hours a month are put in by Fred Vobbe on the two club ventures he offers as a labor of love. Wayne Heinen's 20 hours a month is a tip of the iceberg as far as the number of hours spent by volunteers to produce the services NRC offers. Now, after this oversimplified but still lengthy history, my point: Given the NRC's legacy on the cutting edge of DX hobby publications...offset, the log, technical leadership, this and other electronic lists, and the DX Audio Service...I see the possibility of a trustworthy volunteer or group of volunteers stepping forward with a plan to develop an electronic version of DX News that would answer the legitimate concerns raised by the current leadership. The NRC did not get to where it is today by one sudden decision and one sudden decree. It grew, slowly and sometimes fitfully, discarding some elements, adding others. The club, as a collective entity, has never stopped and said: "This is the way it will always be, forever and evermore."

**Frederick R. Vobbe** <fredv@nrcdxas.org>: OK, I guess someone needs to answer the question about how the "club" sustains itself electronically. How much would you be willing to pay to receive DXN electronically? How do you keep someone from redistributing it to a larger group through their subscription? How do you keep the folks that would peel info out of the electronic version and put it on their mags and sites without credit? Above all, and like Wayne stated, how do we serve the remaining 700 members of the club? I guess the big, and honest question that needs to be asked is...do you want it electronically for some kind of ease of reading, or is it so you don't have to pay \$24.00 per year for a magazine?

Doug Smith: I think you'll find a significant number don't want to pay the \$24. They're thinking that since there is no expense for paper or postage it should be possible to offer an EDXN at considerably lower dues. Only those who've read the balance sheet can answer whether that's a reasonable thought<g>. I don't think uncredited use in other publications/sites would be significantly more common than it already is. It's not all that hard to retype individual items. Redistribution is a bigger question. I'm not aware of significant redistribution of Monitoring Times' PDF files. Then again, a PDF of an issue of MT is much larger than one of a DXN would be, and much more difficult to redistribute. It is important to keep in mind that any EDXN would, for the foreseeable future, be an \*option, not a \*replacement. I think we're already seeing that many of our most computer-literate members would still prefer a paper DXN. But there are some who would prefer the electronic version. Is it enough to justify the effort and risk? Good question.
